

## ORDINANCE NO. 66-39

AN ORDINANCE TO AMEND THE MUNICIPAL CODE OF THE CITY OF BLOOMINGTON, INDIANA, 1957, BY AMENDING CHAPTER 17, ENTITLED "MOTOR VEHICLES AND TRAFFIC" BY AMENDING CHAPTER 195 THEREOF ENTITLED "NO PARKING ZONES", SECTION 206 THEREOF ENTITLED "STOP INTERSECTIONS" AND SECTION 193 ENTITLED "ONE-WAY STREETS AND ALLEYS".

Be it ordained by the Common Council of the City of Bloomington, Indiana:

Section 1. That Section 195 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, entitled "No Parking Zones" be amended by adding thereto the following:

- A. South Fairview Street - on both sides of the street between Allen Street and Dixie Street.
- B. East Atwater Avenue - both sides of the street between Mitchell Street and Eastside Drive.
- C. South Dunn Street - the first three (3) parking spaces on the East side of the street North of Fourth Street.
- D. South Ballantine Road - the East side of Ballantine Road between Third Street and First Street.
- E. South Lincoln Street - the West side of South Lincoln Street between Third Street and Fourth Street.


Section 2. That Section 206 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, entitled "Stop Street Generally" be amended to include the following:

- A. Hunter Avenue shall be designated "Stop" at Eastside Drive.
- B. Hunter Avenue shall be designated "Stop" at High Street.
- C. Grimes Lane and Washington Street shall be designated a 3-way stop intersection.
- D. Seventh Street and Elm Street shall be designated a 4-way stop intersection.
- E. West Howe and Maple Street shall be designated a 4-way stop intersection.


Section 3. That Section 193 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, entitled "One-Way Streets and Alleys" be amended by deleting therefrom the following:

- A. "Kirkwood Avenue, West between Walnut Street and College Avenue".
- B. "Sixth Street, east between College Avenue and Indiana Avenue."
