

ORDINANCE NO. 66-45

AN ORDINANCE TO AMEND THE MUNICIPAL CODE OF THE CITY OF BLOOMINGTON, INDIANA, 1957, BY AMENDING CHAPTER 17, ENTITLED "MOTOR VEHICLES AND TRAFFIC" BY AMENDING SECTION 193 THEREOF ENTITLED "ONE-WAY STREETS AND ALLEYS" AND SECTION 195 THEREOF ENTITLED "NO PARKING ZONES" AND SECTION 206 THEREOF ENTITLED "STOP INTERSECTIONS" AND SECTION 207 THEREOF ENTITLED "YIELD INTERSECTIONS".

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

Section 1. That Section 193 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, entitled "One-Way Streets and Alleys" be amended by adding thereto the following:

1. Henderson Street shall be designated one-way north from Second Street to Atwater Avenue.
2. Indiana Avenue shall be designated one-way north from Atwater to Third Street.
3. Atwater Avenue shall be designated one-way east from Third Street to Henderson Street.
4. Third Street shall be designated one-way west from Indiana Avenue to Dunn Street.

Section 2. That Section 193 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, shall be amended by deleting therefrom the following:

1. Henderson Street from First Street to Second Street.

Section 3. That Section 195 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, entitled "No Parking Zones" shall be amended by adding thereto the following:

1. The south side of East Third Street from Mitchell Street eastward to the corporate limits.
2. Both sides of Atwater Avenue from the intersection of Third Street to the intersection with South Henderson Street.
3. Both sides of Indiana Avenue from the intersection of South Henderson Street to Third Street.
4. Both sides of Dunn Street from the alley in the 200 block south to Third Street.
5. Both sides of Dunn Street from Smith Avenue north to the first alley south of Third Street.
6. Both sides of Third Street from Indiana Avenue to Dunn Street.
7. The north side of East Second Street between Henderson and Fess Streets.
8. Both sides of North Walnut Grove between Thirteenth Street and Seventeenth Street.

Section 4. That Section 206 of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, entitled "Stop Intersections" shall be amended to include the following:

1. Henderson Street shall be designated "Stop" at Atwater Avenue.
2. West First Street and South Rogers Street shall be a 4-way stop intersection.

3. Woodstock Place shall be designated "Stop" at High Street.

Section 5. That Section ²⁰⁷⁷ of Chapter 17 of the Municipal Code of the City of Bloomington, Indiana, 1957, entitled "Yield Intersections" shall be amended to include the following:


1. That northbound traffic turning off of Atwater Avenue shall yield to northbound traffic on Indiana Avenue.

Section 6. This Ordinance shall be in full force and effect from and after its passage, promulgation, and publication in accordance with the law.
