

ORDINANCE NO. 65-18

AN ORDINANCE TO AMEND THE MUNICIPAL CODE OF THE CITY OF BLOOMINGTON, INDIANA, 1957, BY AMENDING CHAPTER 19 ENTITLED "PARKING LOTS" BY AMENDING SECTION 31 ENTITLED "CERTAIN PARKING LOTS RENAMED; DESIGNATION OF NEW LOTS"; SECTION 32 ENTITLED "HOURLY CHARGE" AND SECTION 21 ENTITLED "ILLEGAL PARKING DEFINED."

Be it ordained by the Common Council of the City of Bloomington, Indiana:

Section 1: That Section 31 of Chapter 19 of the Municipal Code of the City of Bloomington, 1957, be amended by adding thereto the following:

- "e. The Off-street parking lot located upon part of Fractional Outlot 20, the same being the 200 block of East Third Street, shall be named and referred to as Municipal Parking Lot Number 6."

Section 2: That Section 32 of Chapter 19 of the Municipal Code of the City of Bloomington, 1957, be amended to read as follows:


- "a. The charge for the use of Municipal Parking Lots No. 2, No. 3, No. 5, and No. 6, shall be five cents (5¢) an hour or part thereof for the use of each space, excepting those otherwise designated by signs, for the twenty-four hour period of each day. The charge of five cents per hour shall be collected by parking meters installed thereon, and any person parking a motor vehicle thereon shall deposit coins of the United States at the rate of five cents for each sixty minute period or fraction thereof.
- "b. The charge for the use of Municipal Parking Lot No. 4 shall be twenty-five cents for each ten hour period or part thereof for the use of each space for the twenty-four hour period of each day. The charge of twenty-five cents for each ten hour period shall be collected by parking meters installed thereon, and any person parking a motor vehicle thereon shall deposit coins of the United States at the rate of twenty-five cents for each ten hour period or fraction thereof.
- "c. The provisions of this section shall not apply from 7:00 A.M. to 1:00 P.M. on Sundays.
- "d. Thirteen (13) spaces on Municipal Parking Lot. No. 6, when signs are erected giving notice thereof, no person shall park a vehicle for a period of time longer than 30 minutes between the hours of 7:00 A.M. and 6:00 P.M., prevailing time, of any day except Sunday and public holidays."

Section 3: That Section 21 of Chapter 19 of the Municipal Code of the City of Bloomington, 1957, be amended to read as follows:

"Any vehicle which remains in a separate parking space upon a parking lot after the time limit shown upon the meter for such parking space has elapsed or any vehicle backed into a parking space upon any of the municipal parking lots is hereby determined to be illegally parked."

Section 4: This Ordinance shall be in full force and effect from and after its passage, promulgation, and publication in accordance with the law.


