

ORDINANCE NO. 65-20

AN ORDINANCE TO AMEND THE MUNICIPAL CODE OF THE CITY OF BLOOMINGTON, INDIANA, 1957, BY AMENDING CHAPTER 17 ENTITLED "MOTOR VEHICLES AND TRAFFIC" BY AMENDING SECTION 195 ENTITLED "NO PARKING ZONES; SECTION 206 ENTITLED "STOP INTERSECTIONS": AND SECTION 207 ENTITLED "YIELD INTERSECTIONS".

Be it ordained by the Common Council of the City of Bloomington, Indiana:

Section 1: That Section 195 of Chapter 17 of the Municipal Code of the City of Bloomington, 1957, be amended to include the following:

- a. West side of 300 block of South Mitchell (Third Street to Atwater Avenue).
- b. North side of the 200 block of West Tenth Street (between College Avenue and Morton Street).
- c. A space of 8 (eight) feet at 831 West Sixth Street (from east property line west for a distance of 8 feet for driveway).
- d. East Third - the first space east of Grant on the north side of East Third Street.
- e. South Grant Street - the first space north of East Third Street on the East side of Grant Street.
- f. Henderson Street - Third Street to Maxwell Lane on both sides of the street.
- g. West Fourth Street - the first two spaces west of College Avenue on the south side of west Fourth Street.
- h. North Kinser Pike - from the 3000 block to the 3800 block of North Kinser Pike on both sides of the street.
- i. West Allen Street - from Rogers Street to west city limits on the south side.

Section 2: That Section 206 of Chapter 17 of the Municipal Code of the City of Bloomington, 1957, be amended to include the following:


- a. Dunn Street shall be designated stop at Dodds, Dixie and Wylie Streets.
- b. Grant Street shall be designed stop at Dodds, Dixie and Wylie Streets.
- c. Palmer Street shall be designated stop at Dixie and Dodds Streets.
- d. East Fourth Street shall be designated stop at Clark Street.
- e. Henderson Street at the intersection of Second Street shall be designated a three way stop.

Section 3: That Section 207 of Chapter 17 of the Municipal Code of the City of Bloomington, 1957, be amended to include the following:

- a. The traffic on Covenanter Drive shall yield to traffic on Ruby Lane.

Section 4: This Ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
