

ORDINANCE NO. 65-28

AN ORDINANCE APPROVING AND CONFIRMING A FRANCHISE OR CONTRACT BETWEEN THE BOARD OF PUBLIC WORKS AND SAFETY OF THE CITY OF BLOOMINGTON, INDIANA, AND MONROE ALL CHANNEL CABLEVISION, INC.

THAT WHEREAS, the Board of Public Works and Safety of the City of Bloomington, Indiana, has entered into a Franchise or Contract, titled "Franchise, Contract and Grant Relating to Television Transmission and Distribution System in the City of Bloomington, Indiana", which Franchise or Contract is described hereafter in this Ordinance, and such Board of Public Works and Safety has determined the exact form in which such Franchise or Contract is to be finally adopted, and a public hearing on the adoption of such Franchise having been duly advertised as required by law and held at 7:30 P.M. on the 23rd day of September, 1965; and

WHEREAS, such Board of Public Works and Safety is desirous of submitting such Franchise or Contract to the Common Council of the City for the approval of such Common Council, in the best interests of the citizens and residents of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the Franchise or Contract agreed to by the Board of Public Works and Safety of the City of Bloomington, Indiana, and Monroe All Channel Cablevision, Inc., giving and granting to Monroe All Channel Cablevision, Inc., the non-exclusive right to erect, maintain and operate television transmission and distribution facilities, and additions thereto, in, under, over, along, across and upon the public highways, streets, alleys, sidewalk ways and other public places within the corporate limits of the City of Bloomington, Indiana, and subsequent additions thereto, for the purpose of the transmission and distribution of television and FM radio impulses and signals and television energy for a period of twenty (20) years, and all of the provisions, terms and conditions contained in such Franchise or Contract, a copy of which Franchise or Contract is attached hereto and made a part hereof the same as if copies herein in full, are hereby approved and confirmed.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
