

ORDINANCE 64-8

AN ORDINANCE TO AMEND THE MUNICIPAL CODE OF THE CITY OF BLOOMINGTON, INDIANA, 1957 BY AMENDING CHAPTER 17 ENTITLED "MOTOR VEHICLES AND TRAFFIC"; BY AMENDING SECTION 195 ENTITLED "NO PARKING ZONES"; SECTION 197 ENTITLED "RESTRICTED PARKING ZONES"; SECTION 199 ENTITLED "LOADING ZONES"; AND SECTION 206 ENTITLED "STOP INTERSECTIONS".

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That Section 195 of Chapter 17 of the Municipal Code of the City of Bloomington, 1957, entitled "No Parking Zones" be amended to include the following:

- a. East Hillside Drive between Walnut Street and Grant Street, both sides.
- b. East 13th Street from North Walnut Grove to North Fee Lane, both sides.
- c. West Grimes Lane from Walnut Street to Rogers Street, on the north side of the street.
- d. West Grimes Lane from Walnut Street to Madison Street on the south side of the street.
- e. West Grimes Lane from Rogers Street to the first alley east of Rogers Street on the south side of the street.

SECTION 2. That Section 1957 of Chapter 17 of the Municipal Code of the City of Bloomington, 1957, entitled "Restricted Parking Zones" be amended to include the following:

30 Minute Zone:

- a. The south side of West Grimes Lane between Madison Street and the first alley west of Madison Street.
- b. The first three parking spaces upon the north side of West Fifth Street, west of Maple Street.

SECTION 3. That Section 199 of Chapter 17 of the Municipal Code of the City of Bloomington, 1957, entitled "Loading Zones: be amended to include the following:

- a. The first two parking spaces on the north side of West Eighth Street, west of Rogers Street.


SECTION 4. That Section 206 of Chapter 17 of the Municipal Code of the City of Bloomington, 1957, entitled "Stop Intersections: be amended to include the following:

- a. 11th Street at North Woodlawn.
- b. Cottage Grove at North Woodlawn.
- c. North Park at East Cottage Grove.
- d. North Fess at East Cottage Grove.
- e. North Fess at East 11th Street.
- f. South Washington and East First Street shall be designated as a four-way stop.

SECTION 5. This Ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.


