An Ordinance Concerning the Annexation of Adjacent and Contiguous Territory

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of the West Half of Section 36, Township 9 North, Range l West, Monroe County, Indiana, described as follows, to-wit:

Beginning at a point on the now existing corporation line said point being on the East line of the West Half of said Section 36, a distance of 2863.77 feet South 00 degrees 10 minutes 45 seconds East from the Northeast corner of said West Half Section; running thence North 89 degrees 03 minutes 07 seconds West on and along the said existing corporation line a distance of 1720.75 feet to a point on the South-easterly property line of the Illinois Central Railroad (formerly the Indianapolis Southern Railway Company) (the said Railroad proper-ty being on a curve having a radius of 2342.01 feet); running thence in a Northeasterly direction upon and along the said Railroad proper-ty line and along the said curve to the left a distance of 18.05 feet to the point of tangency of the said curve; running thence North 30 degrees 44 minutes 00 seconds East upon and along the said Railroad property line and along 'the extension of the tangent of the last described curve a distance of 2103.64 feet to a point; running thence South 59 degrees 16 minutes 00 seconds East upon and along the said Railroad property line a distance of 25.00 feet to a point (the said Railroad property being 150.00 feet wide at this point); running thence North 30 degrees 44 minutes 00 seconds East upon and along the said Railroad property line a distance of 371.09 feet to a point; running thence South 89 degrees 08 minutes 50 seconds East a distance of 418.36 feet to a point on the East line of the West Half of said Section 36, which point is a distance of 711.64 feet South 00 degrees 10 minutes 45 seconds East of the Northeast corner of said Half Section; running thence South 00 degrees 10 minutes 45 seconds East upon and along the East line of the said West Half Section of distance of 2152.13 feet to the place of beginning, containing 53.32 acres, more or less.

SECTION 2. BE IT FURTHER ORDAINED, That the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
