

APPROPRIATION ORDINANCE  
NUMBER 5, 1963

An Ordinance specially appropriating from the General Funds not otherwise appropriated of the City of Bloomington, Monroe County, Indiana, and reduction of funds heretofore appropriated for the use of Departments of said City, to meet the extraordinary emergencies found to exist in the various departments.

BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF BLOOMINGTON, MONROE  
COUNTY, INDIANA:

SECTION 1. That therebe and hereby is appropriated from the General Funds of said City, not otherwise appropriated, to meet the extraordinary emergencies found to exist for the expenditures of more money for the current year of 1963, than was set out in detail in the budget as finally adopted, and appropriations as finally made, the following sum to the City Administration Department of the City of Bloomington, Indiana:

SECTION 2. That therebe, and hereby is, reduced from the Special Funds of said City for reason that the amount previously appropriated is in excess of actual needs at this time, and this amount may be returned to the unappropriated funds of the General Fund as follows:

SECTION 3. This Ordinance shall be in full force and effect from and after its passage by the Common Council and its approval by the Mayor, subject to the approval of the State Board of Tax Commissioners.
