ORDINANCE NO. 18, 1962

AN ORDINANCE TO AMEND THE BLOOMINGTON
ZONING MAP, DATED JULY 18, 1950

WHEREAS, the Common Council of the City of Bloomington, Indiana, passed a zoning ordinance and adopted a zoning map on July 18, 1950, which said ordinance and map became effective on November 17, 1950 and

WHEREAS, the Plan Commission has recommended that the Bloomington Zoning Map be amended by the rezoning of certain property, now

THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174, ACTS OF 1947, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the Map entitled "Bloomington Zoning Map", dated July 18, 1950, be amended to rezone the following described land in the City of Bloomington, Monroe County, Indiana, from its present residential zone classification to a B2 DOWNTOWN BUSINESS ZONE, to-wit:

A part of Seminary Lot No. 46 and No. 37, in the City of Bloomington, Monroe County, Indiana, to-wit: Beginning at the Southwest corner of Seminary Lot No. Forty-six (46), running thence East along the South line of Seminary Lot No. Forty-six (46) and Seminary Lot No. Thirty-seven (37) a distance of Eight Hundred Sixty (860) feet; thence North along the West boundary line of Rogers Street a distance of Three Hundred Eighty-four (384) feet; thence West a distance of One Hundred Thirty-two (132) feet; thence South a distance of Fifty-four (54) feet; thence West a distance of Seven Hundred Twenty-eight (728) feet; thence South along the West line of Seminary Lot No. Forty-six (46) a distance of Three Hundred Thirty (330) feet to the place of beginning.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
