

ORDINANCE NO. 23, 1962

AN ORDINANCE concerning the annexation of adjacent and contiguous territory pursuant to the filing of voluntary petitions for annexation.

WHEREAS, the Boundary of the City of Bloomington, Indiana is along and adjacent to the real estate described herein and

WHEREAS, the owners of the lands hereinafter described have submitted to the Common Council of the City of Bloomington, Indiana, a petition for and on their behalf for annexation of certain territory of which the petitioners are the owners.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

A part of the Northwest quarter of Section Twenty-eight (28), Township Nine (9) North, Range One (1) West, in Monroe County, Indiana, described as follows, to-wit: Beginning at a point on the now existing corporation line, said point being on the west right-of-way line of New State Highway No. 37, Six-hundred Six and Fifteen-hundredths (606.15) feet South of and at right angles to the north line of said Section No. 28; thence west to a point Ninety-nine (99) feet East of the center line of Old State Highway No. 37; thence southerly Ninety-nine (99) feet East of and parallel to said center line of Old State Highway No. 37; for a distance of Sixty-five and Seventenths (65.7) feet; thence West Ninety-nine (99) feet and to the center line of Old State Highway No. 37; thence southerly on and along said center line Two-hundred Eighty-three and Twenty-five-Hundredths (283.25) feet; thence South Eighty-one degrees (81°) Forty-eight minutes (48") East to the existing corporation line; thence northerly on and along said corporation line, the same being the west right-of-way line of New State Highway No. 37, to the point of the beginning.

SECTION 2. BE IT FURTHER ORDAINED, That the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
