ORDINANCE NO. 26, 1962

AN ORDINANCE TO AMEND THE BLOOMINGTON
ZONING MAP, DATED JULY 18, 1950

WHEREAS, the Common Council of the City of Bloomington, Indiana, passed a zoning ordinance and adopted a zoning map on July 18, 1950, which said ordinance and map became effective on November 17, 1950, and

WHEREAS, the City Plan Commission has recommended that the Bloomington Zoning Map be amended by the rezoning of certain property, now

THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174, ACTS OF 1947, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the Map entitled "Bloomington Zoning Map", dated July 18, 1950, be amended to rezone the following described land in the City of Bloomington, Monroe County, Indiana, from its present R-1 ONE FAMILY ZONE classification to an R-3 MULTIPLE DWELLING ZONE, to-wit:

A part of the north half of Seminary Lot Number One Hundred Thirty-four (134) (old number one) bounded as follows, to-wit: Commencing Two Hundred Sixty-four (264) feet and seven and one-fourth ($7\frac{1}{4}$) inches east of the northwest corner of said lot, running thence east Two Hundred Sixty-four (264) feet and seven and one-fourth ($7\frac{1}{4}$) inches, thence South Six Hundred Fifty-eight (658) feet and six (6) inches, thence west Two Hundred Sixty-four (264) and seven and one-fourth ($7\frac{1}{4}$) inches, thence North Six Hundred Fifty-eight (658) feet and Six (6) inches, to the place of beginning, containing four (4) acres, more or less, and being a part of Section Three (3), Township Eight (8) North, Range One (1) West, in Monroe County, Indiana.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
