ORDINANCE NO. 18, 1961

AN ORDINANCE TO AMEND THE BLOOMINGTON
ZONING MAP, DATED JULY 18, 1950

WHEREAS, the Common Council of the City of Bloomington, Indiana, passed a zoning ordinance and adopted a zoning map on July 18, 1950, which said ordinance and map became effective on November 17, 1950, and

WHEREAS, the Plan Commission has recommended that the Bloomington Zoning Map be amended by the rezoning of certain property, now

THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, UNDER AUTHORITY OF CHAPTER 174, ACTS OF 1947, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the Map entitled "Bloomington Zoning Map", dated July 18, 1950, be amended to rezone the following described land in the City of Bloomington, Monroe County, Indiana, from its present B2 DOWNTOWN BUSINESS ZONE classification to a B3 GENERAL BUSINESS ZONE, to-wit:

A part of the Northeast quarter of the Northwest quarter of Section 28, Township 9 North, Range 1 West, in Monroe County, Indiana, and further described as follows, to-wit: Beginning at a point on the North line, and 658 feet West of the Northeast corner of Northwest quarter of said Section 28 and running thence South 1 degree 30 minutes East 550 feet to a point, thence South 88 degrees 30 minutes West 626 feet to a point on the center line of New State Road 37, thence Northwesterly on and along the curve of the center of said Highway 560 feet to a point on the North line of said Section 28, thence North 88 degrees 30 minutes East along said North line of said Section 28 to the point of beginning, containing in all 8.41 acres, more or less.

SECTION 2. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
