

ORDINANCE NO. 12, 1960

An Ordinance concerning the annexation of adjacent and contiguous territory pursuant to the filing of voluntary petitions for annexation.

WHEREAS, the boundary of the City of Bloomington, Indiana, is along and adjacent to the real estate described herein, and

WHEREAS, the owners of the lands hereinafter described have submitted to the Common Council of the City of Bloomington, Indiana, a petition for and on their behalf for annexation of certain territory of which the petitioners are the owners.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL, OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

Being a part of the Southeast quarter of Section Twenty (20), Township Nine (9) North, Range One (1) West, in Monroe County, Indiana, more fully described as follows: Beginning at an iron pin at the Northwest corner of the Southeast quarter of Section Twenty (20), Township Nine (9) North, Range One (1) West, thence South 0 degrees 35 minutes 36 seconds East (assumed bearing) 280.00 feet to an iron pin; thence South 81 degrees 41 minutes 54 seconds East 144.47 feet to a point; thence South 45 degrees 32 minutes 54 seconds East 115.00 feet to a point; thence along an arc whose radius is 250.00 feet for a distance of 196.55 feet to a point, said arc would be subtended by a chord bearing North 66 degrees 58 minutes 26 seconds East and 191.52 feet in length; thence North 89 degrees 29 minutes 47 seconds East 287.84 feet to a point, being actual point of beginning; thence North 89 degrees 29 minutes 47 seconds East 213.00 feet to a point; thence along an arc whose radius is 100.00 feet, for a distance of 137.88 feet to a point, said arc would be subtended by a chord bearing South 51 degrees 00 minutes 18 seconds East and 127.21 feet in length; thence South 11 degrees 30 minutes 24 seconds East 2161.21 feet to a point; thence South 00 degrees 39 minutes 48 seconds West 231.30 feet to an iron pin; thence North 89 degrees 20 minutes 12 seconds West 300.00 feet to an iron pin; thence North 00 degrees 39 minutes 48 seconds East 165.55 feet to an iron pin; thence North 89 degrees 20 minutes 12 seconds West 61.23 feet to a point; thence North 00 degrees 39 minutes 48 seconds East 155.00 feet to a point; thence North 17 degrees 48 minutes 18 seconds East 166.97 feet to a point; thence North 30 degrees 30 minutes 24 seconds West 115.00 feet to a point; thence North 11 degrees 30 minutes 24 seconds West 1799.90 feet to the point of beginning, containing 16.16 acres.

ALSO:

Beginning at a point on the now existing corporation line, which said point is on the North line of the road known as the Old Water Works Road; thence West on and along said North line of the Water Works Road to the East right-of-way line of the Bloomington Southern Railway; thence Southeasterly on and along said East right-of-way line to the existing corporation line; thence North on and along existing corporation line to the point of beginning.

SECTION 2. BE IT FURTHER ORDAINED, That the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
