## ORDINANCE OF THE CITY OF BLOOMINGTON, COUNTY OF MONROE, STATE OF INDIANA.

## ORDINANCE NO. 25, 1960

AN ORDINANCE TO AMEND THE "MUNICIPAL CODE OF THE CITY OF BLOOMINGTON, INDIANA, 1957", BY AMENDING CHAPTER 30, ARTICLE IV, SECTION 30-29 AND CHAPTER 30, ARTICLE III, SECTION 30-28 OF SAID CODE WITH RESPECT TO THE ZONE CLASSIFICATION FOR THE MANUFACTURING, COMPOUNDING, PROCESSING, AND PACKAGING OF BAKERY GOODS.

WHEREAS, The Common Council of the City of Bloomington, Indiana, passed a Zoning Ordinance on July 18, 1950, which said Ordinance became effective on November 17, 1950, and

WHEREAS, Said Zoning Ordinance is now incorporated in the "Municipal Code of the City of Bloomington, Indiana, 1957", as Chapter 30 of said code, and

WHEREAS, The City Plan Commission has recommended that Chapter 30, Article IV, Section 30-29 and Chapter 30, Article III, Section 30-28 be amended with respect to the zone classifixation for the manfacture, compounding, processing, and packaging of Bakery Goods, now

THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDINNA, UNDER AUTHORITY OF CHAPTER 174, ACTS OF 1947, OF THE GENERAL ASSEMBLY OF THE STATE OF INDIANA:

SECTION 1. That the "Municipal Code of the City of Bloomington, Indiana, 1957", be amended by amending Chapter 30, Article IV, Section 30-29, paragraph 2, sub-paragraph (a), by deleting the term "bakery goods" as it appears in lines 2 and 3.

SECTION 2. That the "Municipal Code of the City of Bloomington, Indiana, 1957", be further amended by amending Chapter 30, Article III, Section 30-28, paragraph 6, by adding a sub-paragraph (f) as follows, to-wit:

(f) The manfacture, compounding, processing, and packaging of bakery goods.

SECTION 3. That this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.
