

ORDINANCE NO. 19, 1959

An Ordinance concerning the annexation of adjacent and contiguous territory pursuant to the filing of a voluntary petition for annexation.

WHEREAS, the boundary of the City of Bloomington, Indiana, is along and adjacent to the real estate described herein, and

WHEREAS, the owners of over fifty-one percent (51%) of the lands hereinafter described have submitted to the Common Council of the City of Bloomington, Indiana, a petition for and on their behalf for annexation of certain territory of which the petitioners are part owners.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

Beginning at a point on the existing corporation line, said point being the intersection of the North right-of-way line of Seventeenth Street with the East right-of-way line of State Highway No. 37, North bound; thence Northerly on and along said East right-of-way line to a point on same, which said point is Four Hundred Forty-nine and Eighty-one hundredths (449.81) feet South of the North line of Section Twenty-eight (28), Township Nine (9) North, Range One (1) West; thence North Eighty-eight (88) Degrees and Thirty (30) minutes East for a distance of Six Hundred Twenty-six (626) feet; thence North One (1) degree and Thirty (30) minutes West for a distance of Five Hundred Fifty (550) feet and to the North line of said Section Twenty-eight (28); thence East on and along the South line of Section Twenty-one (21), Township Nine (9) North, Range One (1) West, to a point on said South line Three Hundred Seventy (370) feet East of the Southeast corner of the Southwest quarter of said Section Twenty-one (21); thence North Four Hundred Eighty-two (482) feet; thence East Three Hundred Seventy (370) feet to the East line of the West half of said Section Twenty-one (21); thence North on and along said East line of the West half of said Section Twenty-one (21), to the North line thereof; thence West on and along the North line of said Section Twenty-one (21) to the West line thereof; thence South on and along the West line of said Section Twenty-one (21) a distance of Six Hundred Eighty-eight (688) feet, more or less, and to the North line of the City Park land located in Section Twenty (20), Township Nine (9) North, Range One (1) West; thence South Eighty-nine (89) degrees West a distance of One Thousand Forty-three and Seven tenths (1043.7) feet; thence South to the North line of the South half of the Northeast quarter of said Section Twenty (20); thence West on and along the North line of the South half of the Northeast quarter of said Section Twenty (20) to the West line thereof; thence South on and along the West line of the East half of said Section Twenty (20) to the Northwest corner of the Southeast quarter of said Section Twenty (20); thence South zero (0) degrees, Thirty-five (35) minutes, and Thirty-six (36) seconds East for a distance of Two Hundred Eighty (280) feet; thence South Eighty-one (81) degrees, Forty-one (41) minutes, and Fifty-four (54) seconds East for a distance of One Hundred Forty-four and Forty-seven hundredths (144.47) feet; thence South Forty-five (45) degrees Thirty-two (32) minutes, and Fifty-four (54) seconds East for a distance of One Hundred Fifteen (115) feet; thence along an arc with a radius of Two Hundred Fifty (250) feet and a cord that extends North Sixty-six (66) degrees, Fifty-eight (58) minutes, and Twenty-six (26) seconds East and which said cord is One Hundred Ninety-one and Fifty-two hundredths (191.52) feet in length for a distance of One Hundred Ninety-six and Fifty-five hundredths (196.55) feet; thence North Eighty-nine (89) degrees, Twenty-nine (29) minutes, and Forty-seven (47) seconds East for a distance of Five Hundred and Eighty-four hundredths (500.84) feet; thence along an arc with a radius of One Hundred (100) feet and a cord that extends south Fifty-one (51) degrees Zero (0) minutes, and Eighteen (18) seconds East and which said cord is One Hundred Twenty-seven and Twenty-one hundredths (127.21) feet in length, for a distance of One Hundred Thirty-seven and Eighty-eight hund-

redths (137.88) feet; thence South Eleven (11) degrees Thirty (30) minutes and Twenty-four (24) seconds East for a distance of Two Thousand One Hundred Sixty-one and Twenty-one hundredths (2161.21) feet; thence South Zero (0) degrees Thirty-nine (39) minutes and Forty-eight (48) seconds West for a distance of Two Hundred Thirty-one and three tenths (231.3) feet, more or less, and to the South line of said Section Twenty (20); thence East on and along the South line of said Section Twenty (20) to the East line thereof; thence North on and along the West line of Section Twenty-one (21), Township Nine (9) North, Range One (1) West, to the South line of the Northwest quarter of the Northwest quarter of said Section Twenty-one (21); thence East on and along the South line of the Northwest quarter of the Northwest quarter of said Section Twenty-one (21) to the West Right-of-Way line of State Highway No. 37; thence southerly on and along the West Right-of-Way line of State Highway No. 37 Southbound to a point on the existing corporation line, said point being the intersection of the South Right-of-Way line of Seventeenth Street with the West Right-of-Way line of North College Avenue.

SECTION 2. BE IT FURTHER ORDAINED, That the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
