

ORDINANCE NO. 7, 1958

An Ordinance concerning the annexation of adjacent and contiguous territory pursuant to the filing of a voluntary petition for annexation.

WHEREAS, the boundary of the City of Bloomington, Indiana, is along and adjacent to the real estate described herein, and

WHEREAS, the owners of the lands hereinafter described have submitted to the Common Council of the City of Bloomington, Indiana, a petition for and on their behalf for annexation of certain territory of which the petitioners are the owners.

NOW, THEREFORE, BE IT OBTAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. That the following described territory be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

BEECH WOOD MANORS ADDITION, being a part of the Northeast quarter of the Northwest quarter of Section Ten (10), Township Eight (8) North, Range One (1) West, described as follows, to-wit: Beginning at a point that is Twenty (20) feet South and Twenty (20) feet west of the northeast corner of the said quarter quarter; thence running south eighty-eight (88) degrees thirty (30) minutes west for four hundred fifty-four (454) feet; thence running south eighty-nine (89) degrees six (06) minutes west for three hundred thirty-six (336) feet; thence running south two (2) degrees east for five hundred eighty (580) feet; thence running north eighty-eight (88) degrees east for one hundred thirty-eight (138) feet; thence running north eighty-seven (87) degrees fifty-five (55) minutes East for sixty (60) feet; thence running south eighty-nine (89) degrees fifty-six (56) minutes east for two hundred ninety-six (296) feet; thence running north eighty-eight (88) degrees east for two hundred ninety-six (296) feet; thence running north two (2) degrees west for five hundred eighty (580) feet; and to the place of beginning. Containing in all Ten and fifty-four hundredths (10.54) acres, more or less.

SECTION 2. BE IT FURTHER OBTAINED, That the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
