

ORDINANCE NO. 13, 1958

An Ordinance annexing contiguous territory to the City of Bloomington, Indiana.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA:

SECTION 1. The following described territory be, and the same is, hereby annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

Beginning on the now existing corporation line of the City of Bloomington, Indiana, at the Northeast corner of Green Acres First Addition in Section 34, Township 9 North, Range 1 West, Monroe County, Indiana; thence North on and along the East line of said Section 34 to the Northeast corner thereof; thence East on and along the North line of Section 35 and Section 36 to the Northeast corner of the Northwest Quarter of said Section 36; thence South on and along the East line of the West half of Section 36 to the Northeast corner of the Southeast Quarter of the Southwest Quarter of said Section 36; thence West on and along the North line of the South half of the Southwest Quarter of Section 36 to a point Two Hundred (200) feet East of the West line of said Section 36; thence South on and along a line Two Hundred (200) feet East of and parallel to the West line of Section 36 to the South line of said Section 36, Township 9 North, Range 1 West; thence East to a point Two Hundred (200) feet East of the Northwest corner of Section 1, Township 8 North, Range 1 West; thence South on and along a line Two Hundred (200) feet East of and parallel to the West line of said Section 1 to the South line of the Northwest Quarter thereof; thence West on and along the South line of the North halves of Section 1, Section 2, Section 3, and such line extended to the West Right-of-Way line of South High Street; thence North on and along the West Right-of-Way line of South High Street to the now existing corporation line at the Southeast corner of Seminary Lot No. 129; thence following the now existing corporation line to the place of beginning.

SECTION 2. BE IT FURTHER ORDAINED, That the boundaries of the City of Bloomington shall be, and the same are, hereby declared to be extended so as to include all of the real estate hereinabove described as a part of the City of Bloomington, Indiana.

SECTION 3. This Ordinance shall be in full force and effect from and after its passage, promulgation and publication in accordance with the law.
