ORDINANCE OF THE CITY OF BLOOMINGTON COUNTY OF MONROE, STATE OF INDIANA, No. 13, 1957

An Ordinance to amend Ordinance No. 1 adopted by the Common Council of the City of Bloomington, on January 17, 1950.

BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, AS FOLLOWS:

Section 1. Ordinance No. 1, adopted by the Common Council of Bloomington, on January 17, 1950, be amended as follows:

(a) Section 8C of said Ordinance No. 1 is repealed;
(b) Section 10 of said Ordinance No. 1 is amended to read as follows: (b) Section 10 of said Urdinance NO. 1 is amenued to read as follows. "Section 10 PENALTIES. - Any person who violates Section 2, of this ordinance, or who refuses to comply with any lawful orders, rules or regulations of the Health Officer, shall, upon conviction, be punished for the first offense by a fine of not less than Ten Dollars (\$10.00) nor more than Fifty Dollars (\$50.00); for the second and any subsequent offenses by a fine of not less than Fifty Dollars (\$50.00) normore than Dollars (\$100.00). Each day of (\$50.00) normore than One Hundred Dollars (\$100.00). Each day of operation in veolation of the provisions of Section 2 of this Ordinance shall constitute a separate offense;'

(c) By adding a new section at the end of Section 27 of said Ordinance

No. 1 to be known as Section 7A to read as follows: "Section 7A. PLACARDING OF RESTAURANTS, The classification 'Sanitation Approved Restaurant' is established for those restaurants which effectively discharge their responsibility to protect the public in preparing, handling, and serving food as follows:

"1. A 'Sanitation Approved Restaurant' shall consistently meet the sanitary requirements of Section 5 of this ordinance.

"2. Upon the effective date of this ordinance every restaurant which complies with all of the requirement for a 'Sanitation Approved Restaurant' on two consecutive inspections by the health officer, which inspections are separated by at least 30 days, shall be provided with a 'Sanitation Approved' placard which may be displayed in said restaurant,

"3. The 'Sanitation Approved Restaurant' placard shall remain the property of the health officer and shall be removed by the health officer from any restaurant the permit of which has been revoked. Provided further, that the health officer shall remove the 'Sanitation Approved Restaurant' placard from any restaurant when said restaurant fails to meet the requirements for a 'Sanitation Approved Restaurant'

on two consecutive inspections separated by at least 30 days. ۳**4** . For the purpose of determining eligibility for the 'Sanitation Approved Restaurant' rating, the health officer shall not consider as violations minor violations which are corrected during the cuurse of the inspection."

This Ordinance shall take effect and be in full force Section 2, from and after its adoption by the Common Council, its approval by the Mayor, and its publication as provided by law.
