

APPROPRIATION ORDINANCE

NO. 4, 1954

CITY OF BLOOMINGTON, INDIANA

An Ordinance Specially Appropriating from the General Funds and Special Funds, not otherwise appropriated, of the City of Bloomington, Monroe County, Indiana, and reducing Funds heretofore appropriated for the use of various Departments of said City, to meet the extraordinary emergencies found to exist in these Departments at this time.

BE IT ORDAINED by the Common Council of the City of Bloomington, Monroe County, Indiana:

Section 1. That there be, and hereby is appropriated from the General Funds of said City, not otherwise appropriated, to meet the extraordinary emergencies found to exist for the expenditure of more money for the current year, 1954, than was set out in detail in the Budget as finally adopted and appropriations as finally made, the following sums to the Funds and Departments of the City of Bloomington, Indiana:

Section 2. That there be, and hereby is appropriated from the Special Funds of the respective Departments of said City, not otherwise appropriated, to meet the extraordinary emergencies found to exist in these Departments requiring the expenditure of more money for the current year, 1954, than was set out in detail in the Budget as finally adopted, and appropriations as finally made, the following sums to the Special Funds and Departments of the City of Bloomington, Indiana:
