ORTMANCT NO. 11, 1953
An Ordinance concerning the investment of funds now under the control of the city Clerk-measurer of the City of Bloomington.

WHBREAS, the City Clerk-mreasurer of the city of Bloomington has a fund knonn as the "Water Bond and lnterest Fund", the purpose of which is to accumblate funds to pay the interest on Bonds issued by the Water utility, and to redeem Bonds as the same mature, and

WHRFAS, there is in said account a sum in excess of une Jundred Piftymive Thousand ( $\$ 155,000.00$ ) Dollars: this being more funds than Mill be needed to pay the interest and retire said Bonds as the same mature during the next ensuing year.

Section R. That the bity Clerk-weasurer of the City of Bloomington, is authorized and directed to invest that part of the Fater Bond and Interest Fund which $i 11$ not be immediately required for the payment of Bonds and interest during the next ensuing year: In the bills, certificates of indebtedness, notes and bonds of the United States of America; provided, however, that no such investments shall be made at a cost in excess of the nar value of the securities purchased.

Section 2. The City Clerk-Treasurer is authorized to invest, pursuant to the authority granted in Section 1 , snecifically as Pollows:
(a) The sum of One Hundred Thousand ( $\$ 100,000.00$ ) Dollars shat be invested for a neriod of une (1) year.

Section. S. Since the gtatutes of the State of Inaiana provide that the Gity Clent-measurer shall recetve adthority of the womon Council to reminvest said money after the explration of one (1) year, it is hereby stipulated that the City Clerk-Treasurem shall ask the Comon Council for authority to reminvest said funds one (1) year hence, if such investment seems adyisable.

Section 4 . This urdinance shall be in full force and effect from and arter its passare.
