

## ORDINANCE NO. 13, 1953

An Ordinance authorizing the conveyance of the area, commonly known and designated as "Bryan Park", from the City of Bloomington, Indiana, to the Board of Park Trustees of the City of Bloomington, Indiana.

WHEREAS, the City of Bloomington, Monroe County, Indiana, is the owner of certain lots in Cummings Addition to the City of Bloomington, Indiana, together with an unplatted area, immediately South of said Addition, which said area is commonly known and designated as "Bryan Park", and

WHEREAS, said area will be used exclusively for Park purposes.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, INDIANA, AS FOLLOWS:

Section 1. That the City of Bloomington is hereby authorized and directed to convey by Warranty Deed, duly executed and acknowledged, in the name of the City, by its Mayor and Clerk-Treasurer, and attested by the Seal of the City, the following described real estate:

Lots numbered Nine (9) to Twenty-Four (24) inclusive;  
 Lots numbered Thirty-Six (36) to Forty (40) inclusive;  
 Lots numbered Forty-Two (42) to Fifty-Three (53) inclusive;  
 Lots numbered One Hundred (100) to One Hundred Twenty (120) inclusive;  
 Lots numbered One Hundred Forty-Seven (147) to One Hundred Sixty-Seven (167) inclusive;  
 Lots numbered One Hundred Ninety-One (191) to One Hundred Ninety-Eight (198) inclusive;

All in Cummings Addition to the City of Bloomington, Indiana as shown by the recorded Plat thereof.

And the unplatted area, bounded and described as follows, to-wit:

Commencing at the Southwest corner of Lot Numbered Sixteen (16) in Cummings Addition to the City of Bloomington, Indiana, thence running South along the East line of Henderson Street to the Northwest corner of the Lot numbered One (1) in Edgemont Park Addition to the City of Bloomington; thence running East along the North boundary line of Edgemont Park to the Northeast corner of Lot numbered Eighty-One (81) in Edgemont Park Addition, thence North along the West line of Maxwell Manors Addition to the Southeast corner of Lot numbered One Hundred Ninety-Eight (198) in Cummings Addition, thence West along the South line of said Cummings Addition to the point of beginning.

SUBJECT to the public highways located within said area, and reserving also a strip of land on the South side of said area, coinciding in width with the width of Davis Street, as shown by the recorded Plat of said Street, East and West of said Park; and perpetually reserving to the City of Bloomington such lands as may be necessary for the installation of sewer lines and water lines in said Park area.

BE IT FURTHER ORDAINED that the proper officials of the City shall take, or cause to be taken, all steps necessary, or in the opinion of the Mayor of this City desirable, in order that the terms of this Ordinance may be effected at the earliest practicable date.

This Ordinance shall be in full force and effect from and after its passage.
