

APPROPRIATION ORDINANCE NO. 4, 1953

City of Bloomington, Indiana

An Ordinance specially appropriating from the General Funds not otherwise appropriated of the City of Bloomington, Monroe County, Indiana, and reducing funds heretofore appropriated for the use of Departments of said City, to meet the extraordinary emergencies found to exist in the various Departments.

BE IT ORDAINED, by the Common Council of the City of Bloomington, Monroe County, Indiana:

Section 1. That there be, and hereby is, appropriated from the General Funds of said City, not otherwise appropriated, to meet the extraordinary emergencies found to exist for the expenditure of more money for the current year, 1953, than was set out in detail in the Budget as finally adopted, and appropriations as finally made, the following sums to the funds and Departments of the City of Bloomington, Indiana:

1. Mayor's Office

- (a) #721 - Furniture and Fixtures \$132.10

It has been found necessary to replace some of the furniture and fixtures in the Mayor's office, which was not anticipated at the time the 1953 Budget was prepared, causing this emergency.

2. Clerk-Treasurer

- (a) #38 - General Supplies \$ 35.00

The emergency which requires the additional appropriation in the above item is the necessity to purchase more supplies than anticipated at the time of preparing the 1953 Budget, and at higher cost.

Section 2. That there be, and hereby is, appropriated from the Special Funds of the respective Departments of said City, not otherwise appropriated, the following sums to the funds and Departments of the City of Bloomington, Indiana:

1. Street Department

- (a) #33 - Garage and Motors \$727.00
- (b) #38 - General Supplies 262.13

The emergency which requires additional appropriations in the above funds is caused by the need for more gasoline, oil, and other garage and motor items, and more general supplies, than was anticipated at the time of preparing the 1953 Budget.

2. Aviation Department

- (a) #214 - Telephone \$150.00

The loss of a subscriber who helped share the cost of the telephone, and the increase in toll traffic caused the emergency which requires the additional appropriations in the above item. The Aviation Department is reimbursed, however, for tolls made by individual users.

3. Parking Facilities Fund

- (a) #261 - Grading, Surfacing, Engineering, and Miscellaneous - Parking Lot \$28,000.00

The above appropriation is required because at the time of preparing the 1953 Budget, the development of the lot for off-street parking was not anticipated.

Section 3. That there be, and hereby is, reduced from certain funds of the various Departments of said City, hereinafter referred to, for the reason that the amounts previously appropriated are in excess of actual needs, and these funds may be returned to the unappropriated funds of the General or Special Funds from which they were appropriated, as follows:

1. Mayor's Office - #251-52 Repairs	\$87.10
#363 Other Office Supplies	30.00
#38 General Supplies	15.00
2. Clerk-Treasurer - #216 Travel Expense	35.00
3. Street Department - #26 Services, Other Contractual	989.13
4. Aviation Department - #712 Runway Drainage	150.00
5. Parking Meter Fund - #261 - Preparation Parking Lot	28,000.00

Section 4. This Ordinance shall be in full force and effect from and after its passage by the Common Council and its approval by the Mayor, subject to the approval of the State Board of Tax Commissioners.
