## ORDINANCE 03-03

## AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND CONTIGUOUS TERRITORY (Northwest Area)

WHEREAS, the boundary of the City of Bloomington, Indiana, is contiguous and adjacent to the real estate described herein; and

- WHEREAS, the City of Bloomington has determined it will provide capital and non-capital services and improvements to said real estate that are equivalent to the services and improvements currently received by the residents and property owners of the City of Bloomington as specified in the "Fiscal Plan, Annexation of the Northwest Area;" and
- WHEREAS, property taxes imposed on the annexed territory not used to meet basic services, including those of a non-capital nature and capital improvement nature, shall be impounded for a period of at least three years into a special fund to be used for the provision of additional services in the annexed territory within five years after the effective date of the annexation; and
- WHEREAS, Pursuant to IC § 36-4-3-7 & 8, postponing the effective date of this annexation to January 1, 2004 is fairly calculated to make the annexation equitable to the property owners and residents of the municipality and the annexed territory;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. That the following described land, commonly known as the Northwest Area, which includes 1616 – 1709 West 8th Street, 1300 – 1600 West 11th Street, 1300 – 1600 (odd only) West 12th Street, 1501 – 1502 West 13th Street, 1500 – 1600 West 14th Street, 1210 – 1600 West 15th Street, 1312 – 1900 West 17th Street, 1619 – 1900 West Gray Street, 1308 – 1819, 1920, and 2101 – 2335 (odd only) West Vernal Pike, 401 – 499 (odd only) North Adams Street, 910 – 1400 (even only), and 1411 North Crescent Road, 818 – 947 North Lemon Lane (a.k.a. School Lane), 1220 – 1488, 1661T and 1810T ("T" indicating a temporary address) North Arlington Park Drive, 700 – 1200 North Oolitic Drive, 701 – 800, 801 – 1199 (odd only), and 1201 – 1400 North Lindbergh Drive, 600 – 700 North North Street, 300 – 500 North Spring Street, including contiguous public roads and rights of way, be annexed to and declared a part of the City of Bloomington, Indiana, to-wit:

SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington, shall be, and the same are, hereby declared to be extended so as to include all the real estate hereinabove described as part of the City of Bloomington, Indiana.

SECTION 3. Pursuant to IC § 36-4-3-4(g), the above-described territory, which is hereby annexed to and declared a part of the City of Bloomington, Indiana, shall be assigned to Bloomington Common Council District 1 and District 2 in the following manner: The line separating these two districts shall run west along West 17<sup>th</sup> Street, then south along North Crescent Road, and then west along West Vernal Pike, with the area to the south being assigned to District 1 and the area to the north being assigned to District 2.

SECTION 4. Pursuant to IC § 36-4-3-8, in order to make the annexation equitable to the property owners and residents of the City of Bloomington and the area to be annexed, all the municipal property taxes imposed on the annexed territory after the annexation takes effect that are not used to meet the basic services described in the "Fiscal Plan, Annexation the Northwest Area" shall be impounded in a special fund to be called the Northwest Area Property Taxes for a period of three (3) years. The impounded property taxes shall be used to provide additional services that were not specified in the plan of annexation. The impounded property taxes in the fund shall be expended not later than five (5) years after the annexation becomes effective.

SECTION 5. Pursuant to IC § 36-4-3-8.1, an advisory board shall be appointed to advise the municipality on the provision of services to the annexed territory that are paid for with the municipal property taxes impounded as established in Section 4. The advisory board shall be appointed not later than ninety (90) days after the annexation becomes effective.

SECTION 6. Services will be provided to the annexed area in accordance with the "Fiscal Plan, Annexation of the Northwest Area" adopted by <u>Resolution 03-05</u> by the Bloomington Common Council.

SECTION 7. The effective date of this ordinance shall be January 1, 2004, following its passage and adoption by the Common Council of the City of Bloomington and approval of the Mayor, and the City herein acknowledges its obligations at the time of annexation.

This ordinance annexes the Northwest Area which includes 1616 - 1709 West 8th Street, 1300 - 1600 West 11th Street, 1300 - 1600 (odd only) West 12th Street, 1501 - 1502 West 13th Street, 1500 - 1600 West 14th Street, 1210 - 1600 West 15th Street, 1312 - 1900 West 17th Street, 1619 - 1900 West Gray Street, 1308 - 1819, 1920, and 2101 - 2335 (odd only) West Vernal Pike, 401 - 499 (odd only) North Adams Street, 910 - 1400 (even only), and 1411 North Crescent Road, 818 - 947 North Lemon Lane (a.k.a. School Lane), 1220 - 1488, 1661T and 1810T ("T" indicating a temporary address) North Arlington Park Drive, 700 - 1200 North North Street, 300 - 500 North Spring Street, including contiguous public roads and rights of way, effective January 1, 2004.

Upon annexation, the territory to the south of West 17<sup>th</sup> Street, North Crescent Road, and West Vernal Pike will become part of Council District 1 and the territory to the north of those roadways will become part of Council District 2. Also, in accordance with state law, the city will impound property taxes collected in excess of those needed to provide services described in the fiscal plan and appoint an advisory board to recommend the expenditure of any surplus funds.
