ORDINANCE 02-22

AN ORDINANCE CONCERNING THE ANNEXATION OF ADJACENT AND CONTIGUOUS TERRITORY

(Arlington Road Commercial & Business Park/Valhalla Area)

WHEREAS,

the boundary of the City of Bloomington, Indiana, is contiguous and adjacent to the real estate described herein; and

WHEREAS,

the City of Bloomington has determined it will provide capital and non-capital services and improvements to said real estate that are equivalent to the services and improvements currently received by the residents and property owners of the City of Bloomington as specified in the "Fiscal Plan, Annexation of Arlington Road Commercial & Business Park/Valhalla Area;" and

WHEREAS,

Pursuant to IC § 36-4-3-7 & 8, postponing the effective date of this annexation to January 1, 2004 is fairly calculated to make the annexation equitable to the property owners and residents of the municipality and the annexed territory;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. The following described land, commonly known as Arlington Road Commercial & Business Park/Valhalla Area, which includes 1210 – 2021 N. Arlington Road & 2699T N. Arlington Road (a temporary address assigned to the land bounded on the west by State Road, on the north and east by Arlington Road and on the south by the land of Banks and State Road 45/46 Bypass) 774 and 803 – 1319 W. Gourley Pike, 1319 – 1419 W. Hickory Lane, 901 – 1325 (odd only) N. Crescent Road, 1820, 1905, 2000 – 2100, 2102 – 2398 (even only) and 2400 – 2599 W. Vernal Pike, Knuckles (a.k.a. Nuckles) Road, 1601 – 1611 W. Gray Street, 220 – 310 (even only) Johnson Avenue, 1100 – 1304 (even only) W. 17th Street, 801 – 825 (odd only) N. Lemon Lane, and 2010 N. SECTION 2. Be it further ordained, that the boundaries of the City of Bloomington, shall be, and the same are, hereby declared to be extended so as to include all the real estate hereinabove described as part of the City of Bloomington, Indiana.

SECTION 3. Pursuant to IC § 36-4-3-4(g), the above-described territory, which is hereby annexed to and declared a part of the City of Bloomington, Indiana, shall be assigned to Bloomington Common Council District 1 and District 2 in the following manner: The line separating these two districts shall run west along West 17th Street, then south along North Crescent Road, and then west along West Vernal Pike with the area generally to the south being assigned to District 1 and the area generally to the north being assigned to District 2.

SECTION 4. Services will be provided to the annexed area in accordance with the "Fiscal Plan, Annexation of Arlington Road Commercial & Business Park/Valhalla Area" adopted by Resolution 02-27 by the Bloomington Common Council.

SECTION 5. The effective date of this ordinance shall be January 1, 2004, following its passage and adoption by the Common Council of the City of Bloomington and approval of the Mayor, and the City herein acknowledges its obligations at the time of annexation.

SYNOPSIS

This ordinance annexes Arlington Road Commercial & Business Park/Valhalla Area which includes 1210 – 2021 N. Arlington Road & 2699T N. Arlington Road (a temporary address assigned to the land bounded on the west by State Road, on the north and east by Arlington Road and on the south by the land of Banks and State Road 45/46 Bypass), 774 and 803 – 1319 W. Gourley Pike, 1319 – 1419 W. Hickory Lane, 901 – 1325 (odd only) N. Crescent Road, 1820, 1905, 2000 – 2100, 2102 – 2398 (even only) and 2400 – 2599 W. Vernal Pike, Knuckles (a.k.a. Nuckles) Road, 1601 – 1611 W. Gray Street, 220 – 310 (even only) Johnson Avenue, 1100 – 1304 (even only) W. 17th Street, 801 – 825 (odd only) N. Lemon Lane, and 2010 N. Monroe Street, including contiguous public roads and rights of way, effective January 1, 2004. Upon annexation, the territory to the south of the line along 17th Street, North Crescent Road and West Vernal Pike will become part of Council District 1 and the territory to the north will become part of Council District 2.

Note: The Council amended this ordinance at the public hearing on November 13, 2002. The amendment affected Section 3 and the Synopsis of the ordinance and reflected the new Council districts.
