WHEREAS, the Job Evaluation Committee recently reviewed several job descriptions with substantive revisions reflecting changes in the positions; and

WHEREAS, the Bloomington Police Department would like to delete two Records Clerks and replace it with two Front Desk Clerks;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SYNOPSIS

This ordinance amends the Civil City Salary Ordinance for the year 2003 (Ordinance 02-18) by changing the grade and title of the Employee Services Clerk Typist (grade 1) to Administrative Assistant (grade 2), changing the grade of Legal Secretary from 2 to 4, and changing the grade of the Parks Special Services Coordinator from 5 to 6. This ordinance also changes the grade of the following positions in the Police Department: Office Manager from 4 to 5, Records Supervisor from 5 to 7, Records Clerk from 3 to 4, Secretary from 2 to 3, and Special Investigations Clerk from 3 to 4. Additionally, the ordinance deletes two Records Clerks and replaces it with two Front Desk Clerks.
