RESOLUTION 02-03

TO AUTHORIZE USE OF THE SPECIAL NON-REVERTING IMPROVEMENT FUND TO MAKE IMPROVEMENTS TO PROFILE PARKWAY AND WAYNE'S LANE IN THE WESTSIDE INDUSTRIAL AREA

WHEREAS, Ordinance 79-74, as amended by Ordinance 87-25, provides that monies in the special non-reverting fund established by Ordinance 79-74 ("Westside Industries Fund") may be used by the City of Bloomington for the provision streets, curbs and gutters in order to serve the existing industries and encourage development in the vicinity of the industries, thereby strengthening the City's position for future annexation; and,

WHEREAS, the City finds that the extension and connection of Profile Parkway to Wayne's Lane and additional improvements to Wayne's Lane will substantially benefit traffic flow in and around the westside industry area; and,

WHEREAS, the City finds that it is in its interests to provide funding to Monroe County to assist with the completion of said improvements to Profile Parkway and Wayne's Lane; and,

WHEREAS, the City finds that use of these funds is consistent with the intent and purpose for which the special non-reverting improvement fund has been established;

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. The expenditure of One Hundred Twenty Thousand Dollars (\$120,000), is hereby approved. The money shall be granted to Monroe County to be used with county funds to pay for improvements to Profile Parkway and Wayne's Lane.

SECTION II. This resolution shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.

SYNOPSIS
