

APPROPRIATION ORDINANCE 02-01

PASSED (8-0-1; BANACH)

TO SPECIALLY APPROPRIATE FROM THE GENERAL FUND EXPENDITURES NOT OTHERWISE APPROPRIATED

(To Present a \$19,000 Grant to Indiana University for the Purpose of Sponsoring or Co-Sponsoring Arts Week Events)

- WHEREAS, Arts Week has been designated by Indiana University to be held from February 22 to March 2, 2002; and
WHEREAS, Indiana University is seeking to work cooperatively with the City and the Monroe County Convention and Visitors Bureau to promote and conduct Arts Week as a community-wide event to be held at many venues on both the campus of Indiana University and in the City of Bloomington; and
WHEREAS, the promotion of winter tourism in Bloomington through the promotion of a major arts and culture event is in the economic interest of the City; and
WHEREAS, it is in the City's interest to sponsor or co-sponsor arts and culture events at multiple locations throughout the City; and
WHEREAS, the City desires to grant \$19,000 to Indiana University for the purpose of sponsoring or co-sponsoring Arts Week events in the City, including the use of funds for the provision of patron transportation during this event;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. For the expenses of said municipal corporation, the following additional sums of money are hereby appropriated and ordered set apart from the funds herein named and for the purposes herein specified, subject to the laws governing the same:
