APPROPRIATION ORDINANCE 02-02

TO SPECIALLY APPROPRIATE FROM THE GENERAL FUND EXPENDITURES  
NOT OTHERWISE APPROPRIATED  
(Appropriating two Grants in the General Fund)

WHEREAS, the City has received a \$48,496.00 grant from the Indiana Development Finance Authority in order to pay a consultant to conduct environmental studies at the McDoel Switchyard; and

WHEREAS, the City has been awarded a \$27,918.00 grant from the Indiana Criminal Justice Institute for the Countywide DUI Taskforce to reimburse Monroe County law enforcement agencies for overtime incurred for additional DUI enforcement on a quarterly basis; and

WHEREAS, the City has received two quarterly payments of the Indiana Criminal Justice Institute grant;






