

APPROPRIATION ORDINANCE 02-11

**TO SPECIALLY APPROPRIATE FROM THE GENERAL FUND, PARKS GENERAL FUND, ROSEHILL CEMETERY FUND, BMFC LEASE RENTAL – SHOWERS FUND, AND THE MUNICIPAL ARTS FUND EXPENDITURES NOT OTHERWISE APPROPRIATED
(Various Year-end Requirements)**

- WHEREAS, the Bloomington Community Arts Commission sponsored a competition for three artist-designed bus shelters with benches along West Third Street; and
- WHEREAS, expenses for the competition have been paid from the General Fund – Public Works Department; and
- WHEREAS, the Bloomington Community Arts Commission desires to reimburse the Public Works Department with monies from the Municipal Arts Fund; and
- WHEREAS, the Public Works Department (General Fund) desires to expend the reimbursement during the current year for Other Services and Charges; and
- WHEREAS, the Common Council (General Fund) desires to transfer monies from Category 4 – Capital Outlays to Category 2 – Supplies for books; and
- WHEREAS, the City has secured an 80% reimbursable Small Urban/Rural Planning Program grant to be deposited in the General Fund from the Indiana Department of Transportation specifically for the purpose of conducting transportation related studies; and
- WHEREAS, the Engineering Department (General Fund) and Planning Department (General Fund) desire to purchase and maintain permanent traffic counting equipment and upgrade the current transportation hardware, software and data using the grant; and
- WHEREAS, the Fire Department desires to transfer monies from Category 4 – Capital Outlays to Category 1 – Personal Services for Overtime and to Category 3 – Other Services & Charges for pump testing and repairs; and
- WHEREAS, the Community and Family Resources Department (General Fund) desires to transfer monies from to Category 2 – Supplies, from Category 3 – Other Services and Charges, and from Category 4 – Capital Outlays to Category 1 – Personal Services for Regular Salaries, Temporary Salaries, PERF and Unemployment; and
- WHEREAS, the Community and Family Resources Department (General Fund) has determined the need to increase its budget for Unemployment; and
- WHEREAS, the Police Department (General Fund) desires to transfer monies from Category 1 – Personal Services, from Category 3 – Other Services & Charges, and from Category 4 – Capital Outlays to Category 2 – Supplies for fuel; and
- WHEREAS, the Information and Technology Services Department (General Fund) has expended \$35,000 for GIS software and expects a reimbursement of \$17,500 from the City of Bloomington Utilities Department; and
- WHEREAS, the Information and Technology Services Department desires to expend the reimbursement during the current year for Computer Maintenance; and
- WHEREAS, the Parks Department has received insurance reimbursements during 2002 and desires to expend the reimbursement during the current year for Other Services and Charges; and
- WHEREAS, the Parks Department merged the revenue and expenses of the Rosehill Cemetery Fund with the Parks General Fund beginning with the City's 2002 Budget; and
- WHEREAS, the Rosehill Cemetery Fund is now dormant and the Controller desires to transfer balance to the General Fund; and

WHEREAS, the proceeds from the biannual postcard competition sponsored by the Bloomington Community Arts Commission have previously been deposited into the BMFC Lease Rental – Showers Fund to reimburse the Showers project for expenses related to the Fountain; and

WHEREAS, the amount deposited into the BMFC Lease Rental – Showers Fund exceeded the amount owed; and

WHEREAS, the City desires to transfer the excess to the BCAC Operating Non-Reverting Fund established with Ordinance 02-38;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:




SECTION II. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval by the Mayor.





SYNOPSIS

This ordinance appropriates a reimbursement from the Municipal Arts Fund to the Public Works Department (General Fund) and appropriates the reimbursement for the Public Works Department (General Fund.) It also authorizes transfers in the General Fund for the Common Council, Fire Department, Community and Family Resources and Police Department. It appropriates additional monies to be used by the Community and Family Resources (General Fund) for Personal Services. It also appropriates an 80% reimbursable grant from the Indiana Department of Transportation awarded to the Engineering and Planning Departments (General Fund.) It appropriates a reimbursement from CBU for the Information and Technology Services Department (General Fund) and an insurance reimbursement in the Parks General Fund. It appropriates a transfer from a dormant fund (Rosehill Cemetery.) It also appropriates the proceeds from the biannual postcard competition previously deposited into the BMFC Lease Rental – Showers Fund to be transferred to the BCAC Operating Non-Reverting Fund.
