Greetings!

Welcome to the Citizens' Redistricting Advisory Commission, and thank you for volunteering your valuable time to make Bloomington a better place. City staff from the Common Council Office and Information and Technology Services Department will assist the Commission and would be happy to answer any questions you might have. As you know, this is a new Commission that will hold its first meeting on July 11, 2022 at 5:30pm. One of the items of business at this first Organizational Meeting will be to set a schedule for future meetings. Please come ready to discuss your availability.

Conduct of Meetings

During the COVID-19 pandemic, most governing bodies in the city met electronically using Zoom. Because the Governor's statewide public health emergency declaration ended in March 2022, public meetings must now be held in-person, though some electronic participation is still allowed. Members are encouraged to attend all meetings in person when able to do so, but may participate in meetings electronically under the following restrictions:

- At least half of the commission's members (i.e., three out of five members) must be present in person for each meeting.
- If any commission member is participating remotely, all votes must be taken by roll call.
- A commission member may only attend two consecutive meetings remotely (there are exceptions for illness/medical conditions, military service, death of a relative, or emergency situations involving actual or threatened injury to people or property).
- During the course of this year, a member may only attend half of all of the commission's meetings remotely (again, there are exceptions for illness/medical conditions, military service, death of a relative, or emergency situations involving actual or threatened injury to people or property).

- Any member who wants to participate in a meeting electronically should notify staff that they will be participating remotely at least 48 hours in advance of the meeting (for the July 11 meeting, please just provide notice as soon as possible). For now, please notify the Council Office at <u>council@bloomington.in.gov</u> if you intend to attend any upcoming meetings electronically.
- Members of the public must be able to attend, observe, and record the meeting in person.
- Current city guidelines state that masking is recommended but optional at public meetings. Masking rules apply both to City employees, commission members, and members of the public attending the meeting.

Redistricting Resources and Information

Please take some time to look read this memo and look through the materials contained in the packet. During the Organizational Meeting, city staff will further describe the rules that apply to redistricting and will provide a brief tutorial on some of the tools/information at your disposal. - Report of the Common Council's 2012 Redistricting Committee This is included for reference to give Commission Members a sense of how redistricting was completed in

2012. The report might also serve as a guide for the end product this Commission is tasked with producing.

Transparency

During the Organizational Meeting, the Commission should discuss how it would like to involve the public in its work. This should include providing the public with an opportunity to submit and comment on proposed districts. City staff plans to collect and publish on the Commission's webpage any public submissions for proposed districts. In addition to publicly posting and sharing its work, please know that the Commission is also subject to both the Indiana Open Door Law and Access to Public Records Act. These laws are meant to ensure that the work of governing bodies is conducted openly and is accessible to the public. These access laws are a large topic and have been summarized extensively by the State's Public Access Counselor in a handbook available here - https://www.in.gov/pac/files/pac-handbook-update-draft-3-1-2022.pdf. For your purposes, please follow the following guidelines:

- Commissioners should only deliberate and make decisions during public meetings.
- In order to meet and act as a Commission, a quorum of members (three out of five) must be present.
- Notice of any Commission meetings must be provided at least 48 hours in advance of the meeting (city staff will assist with posting notices and other materials). If notice of a

meeting has not been provided, members should avoid gathering together if a quorum might be present.

- Commissioners should save deliberations/discussions for public meetings and should avoid emailing, talking, or otherwise communicating with other members outside of a public meeting about how they will vote, reasons for voting a particular way, or the pros and cons of a proposal that may come before the commission.
- Under the Access to Public Records Act, any material that is created, received, retained, maintained, or filed by or with a public agency is a public record and subject to public disclosure. This includes emails sent and received via private email accounts if the email concerns public business. For this reason, email correspondence regarding the commission's business should generally copy city staff (council@bloomington.in.gov) so that the City has a record of the correspondence. Commissioners are otherwise responsible for retaining and producing emails and other records, including text messages, related to commission business that they have in their possession upon public records request.
- If you have questions or concerns about these rules, or are unsure how to best comply with the access laws, please contact Council Administrator/Attorney Stephen Lucas at lucass@bloomington.in.gov.

IC 36-4-6-3

36-4-6-3 Second class cities; division into six districts; boundaries; legislative body candidates; territory not included in any district or in more than one district; procedure for recertification of districts

Effective: March 18, 2022 Currentness

Sec. 3. (a) This section applies only to second class cities.

(b) The legislative body shall adopt an ordinance to divide the city into six (6) districts that:

(1) are composed of contiguous territory, except for territory that is not contiguous to any other part of the city;

(2) are reasonably compact;

- (3) do not cross precinct boundary lines, except as provided in subsection (c) or (d); and
- (4) contain, as nearly as is possible, equal population.

(c) The boundary of a city legislative body district may cross a precinct boundary line if:

(1) more than one (1) member of the legislative body elected from the districts established under subsection (b) resides in one (1) precinct established under IC 3-11-1.5 after the most recent municipal election; and

(2) following the establishment of a legislative body district whose boundary crosses a precinct boundary line, not more than one (1) member of the legislative body elected from districts resides within the same city legislative body district.

(d) The boundary of a city legislative body district may cross a precinct line if the districts would not otherwise contain, as nearly as is possible, equal population.

(e) A city legislative body district with a boundary described by subsection (c) or (d) may not cross a census block boundary line:

(1) except when following a precinct boundary line; or

(2) unless the city legislative body certifies in the ordinance that the census block has no population, and is not likely to ever have population.

(f) The legislative body may not adopt an ordinance dividing the city into districts with boundaries described by subsection (c) or (d) unless the clerk of the city mails a written notice to the circuit court clerk. The notice must:

(1) state that the legislative body is considering the adoption of an ordinance described by this subsection; and

(2) be mailed not later than ten (10) days before the legislative body adopts the ordinance.

(g) Except as provided in subsection (j), the division under subsection (b) shall be made only at times permitted under IC 3-5-10.

(h) The legislative body is composed of six (6) members elected from the districts established under subsection (b) and three (3) at-large members.

(i) Each voter of the city may vote for three (3) candidates for at-large membership and one (1) candidate from the district in which the voter resides. The three (3) at-large candidates receiving the most votes from the whole city and the district candidates receiving the most votes from their respective districts are elected to the legislative body.

(j) If the legislative body determines that a division under subsection (g) is not required, the legislative body shall adopt an ordinance recertifying that the districts as drawn comply with this section.

(k) A copy of the ordinance establishing districts or a recertification adopted under this section must be filed with the circuit court clerk of the county that contains the greatest population of the city not later than thirty (30) days after the ordinance or recertification is adopted. The filing must include a map of the district boundaries:

(1) adopted under subsection (b); or

(2) recertified under subsection (j).

(1) The limitations set forth in this section are part of the ordinance, but do not have to be specifically set forth in the ordinance. The ordinance must be construed, if possible, to comply with this chapter. If a provision of the ordinance or an application of the ordinance violates this chapter, the invalidity does not affect the other provisions or applications of the ordinance that can be given effect without the invalid provision or application. The provisions of the ordinance are severable.

(m) IC 3-5-10 applies to a plan established under this section.

Bloomington Municipal Code 2.12.130 - Citizens' redistricting advisory commission.

- (a) Establishment and Purpose. There is hereby established a five-member citizens' redistricting advisory commission, hereinafter "commission," whose purpose shall be to make recommendations to the common council regarding its decennial redistricting ordinance, which divides the city into the six council districts from which councilmembers shall be elected; and to make recommendations to the Monroe County Commissioners on dividing the city into precincts.
- (b) Term. Because of the time-limited nature of the commission's purpose, the commission shall be limited in term to two years from the date of its formation ("formation date"), after which time it shall disband. The commission's first formation date shall be January 1, 2021, and shall be reformed at the beginning of the year following each decennial United States Census ("census year"). All commission members shall be appointed to serve until final district boundaries are adopted by the common council, or until two years after the commission's formation date, whichever comes first. The commission shall be reformed in the event that the city is required, due to annexation or other legal procedures, to redraw council-district lines outside of these periods. The same membership selection process shall be followed in the event the commission is reformed.
- (c) Membership Qualifications. The commission shall consist of five members, subject to the following qualifications and limitations.
 - (1) Political Affiliations. Commissioners shall be divided by political affiliation as follows:
 - A. One member shall be a duly enrolled full-time student at Indiana University Bloomington affiliated with the Democratic Party;
 - B. One member shall be a non-student affiliated with the Democratic Party;
 - C. One member shall be a duly enrolled full-time student at Indiana University Bloomington affiliated with the Republican Party;
 - D. One member shall be a non-student affiliated with the Republican Party; and
 - E. One member shall be appointed who identifies as independent of either of the two major political parties in the state.
 - (2) Limitations. The following individuals are excluded from serving on the commission:
 - (A) Anyone who is currently a public office holder;
 - (B) Anyone who has been an employee for an elected official, including anyone who has been employed by the City of Bloomington, within ten years of the commission's formation date;
 - (C) Anyone who is currently an officer of any county-level political party in Monroe County (not including people serving as precinct committee persons);
 - (D) Anyone who has contributed a cumulative total of \$2,000.00 or more to any political candidate(s) within five years of the commission's formation date;

- (E) Anyone registered with the Indiana Lobby Registration Commission;
- (F) Immediate family members of any excluded person.
- (d) Membership Selection Process. Commissioners shall be selected after an open application process:
 - (1) Applicants shall attest that they are eligible to serve per the conditions of subsection 2.12.130(c).
 - (2) The process shall be conducted by a selection committee made up of the three atlarge councilmembers. The selection committee shall review all applications and in a public meeting choose ten applicants in five pools of two, one pool for each seat noted in subsection 2.12.130(c)(1), whom they believe are the most qualified to carry out the commission's duties.
 - (3) The ranking at-large councilmember shall administer a coin flip to select a member from each pool of applicants.
 - (4) If there is only one eligible applicant for a given seat after complying with the requirements of BMC 2.02, the selection committee may appoint the applicant to the seat. If there are no eligible applicants for a given seat after complying with the requirements of BMC 2.02, the seat may be left empty.
- (e) Redistricting Criteria.
 - The commission shall recommend council district boundaries that comply with the United States Constitution, the Indiana Constitution, and applicable federal and state laws, including the Federal Voting Rights Act and Indiana Code §§ 3-5-10 and 36-4-6-3.
 - (2) The commission shall prepare descriptions and a map of recommended council district boundaries.
 - (3) Whenever possible, the commission should avoid recommending districts that split communities of interest into multiple districts. These communities include, but are not limited to, political subdivisions, neighborhoods, school districts, historic districts and other areas where residents share common traits and concerns.
 - (4) Where it does not negatively impact the above criteria, districts shall be drawn to encourage political competition.
- (f) Commission Processes and Transparency.
 - (1) The city shall establish and maintain, at least until the redistricting process is concluded, a webpage for the commission where redistricting materials shall be published, including the roster of commissioners, meeting agendas and minutes, and draft maps created by the commission.
 - (2) The commission shall hold public hearings at least every other month, but may choose to meet more often.

- (3) The commission shall issue descriptions of recommended council districts, an accompanying map depicting the recommended districts, and a report that explains how the recommended districts comply with BMC 2.12.130(e).
- (4) Approval of recommended council districts, including a map and accompanying report, by the commission requires an affirmative vote from at least two-thirds of serving commissioners. All other actions of the commission require a simple majority vote to pass.
- (5) The commission shall be subject to the Indiana Open Door Law and the Access to Public Records Act.
- (g) Legislative Approval.
 - (1) The commission shall provide, and publish on its webpage, the descriptions of its recommended council districts, along with the accompanying map and report, to the common council no later than the first Wednesday in September of the second year following a decennial census.
 - (2) In performing its responsibilities under Indiana Code § 36-4-6-3, the common council shall determine whether the commission's recommended districts conform to the criteria contained in federal and state law.
 - (3) The common council shall act on the commission's recommended districts before November 1 of the second year following a decennial census. If the common council rejects the commission's recommended districts, the common council shall return the matter to the commission with a written statement of the reasons for the rejection.
 - (4) If the common council rejects the commission's recommended districts, the commission shall, before December 1 of the second year following a decennial census, consider the common council's written statement of reasons for the rejection, revise the map and descriptions accordingly, and return them along with any revised report, to the common council.
 - (5) After considering the commission's final recommendations, or if the commission fails to complete its work, the common council shall perform its duties under Indiana Code §§ 3-5-10 and 36-4-6-3. If the common council rejects the commission's final recommendations, it shall provide a written statement of the reasons for the rejection.

ORDINANCE 12-29

TO AMEND TITLE 2 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "ADMINISTRATION AND PERSONNEL"

- Re: Amending Article IV of Chapter 2.04 (Common Council) to Establish Councilmanic Districts for the City of Bloomington

- WHEREAS, I.C. 36-4-6-3 requires that the City be divided into six (6) councilmanic districts during the second year after a year in which a federal decennial census is conducted; and
- WHEREAS, this statute also requires that these districts be contiguous, reasonably compact, and, as nearly as possible, of equal population, and, with some specific exceptions, not cross precinct boundaries; and
- WHEREAS, Council President Mayer created the Redistricting Committee composed of the three at-large representatives and chaired by Councilmember Sandberg; and
- WHEREAS, prior to the first meeting, the City Clerk Regina Moore provided maps and an interactive table of precinct populations for Council members and the public to use to prepare maps that met the three requirements for consideration by the Committee; and
- WHEREAS, the Redistricting Committee held four meetings in November and submitted a report comprised of the Memoranda of the Meetings and documents kept in the Office of City Clerk which, by passage of this ordinance, will be approved by the Council; and
- WHEREAS, these meetings complied with the Indiana Open Door Law, including one meeting that was continued with the same agenda to later the same week, and were attended by the public at every meeting; and
- WHEREAS, the Council finds that the proposed districts are contiguous, reasonably compact, and, as nearly as possible, of equal population;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. Article IV of Chapter 2.04 of the Bloomington Municipal Code shall be amended by deleting Sections 2.04.500 (Definition of councilmanic districts) and 2.04.0510 (Repeal of former council districts) and replacing them with the following:

2.04.500 Definition of councilmanic districts.

The City of Bloomington is hereby divided into six (6) councilmanic districts which shall be known as the First District, Second District, Third District, Fourth District, Fifth District, and Sixth District. A copy of the map of these districts and the associated precinct populations are attached to this ordinance (Ordinance 12-29) as Exhibit "A." These districts shall consist of precincts as they were set forth in the "Order of the Monroe County Commissioners Regarding Additional Information or Corrections to the Precinct Boundaries and Submission of Corrected IEC-8 Forms" dated December 30, 2011. This Order and the associated precinct, and the IEC-8 forms are incorporated by reference into this ordinance and, in accordance with IC 36-1-5-4, two copies of this material shall be kept on file in the office of the City Clerk and Council for inspection by the public. These districts and their component precincts are as follows:

FIRST DISTRICT. The First Councilmanic District shall consist of the following designated precincts:

(a) Bloomington Township Precincts 2 & 6

(b) Perry Township Precincts 1, 3, 5 & 29

(c) Richland Precinct 9

(d) Van Buren Township Precinct 2

SECOND DISTRICT. The Second Councilmanic District shall consist of the following designated precincts:

(a) Bloomington Township Precincts 5, 7, 13, 14, 17 & 23

THIRD DISTRICT. The Third Councilmanic District shall consist of the following designated precincts:

(a) Bloomington Township Precincts 9, 10, 16, 21 & 22

(b) Perry Township Precincts 20 & 21

FOURTH DISTRICT. The Fourth Councilmanic District shall consist of the following designated precincts:

(a) Bloomington Township Precincts 8 & 18

(b) Perry Township Precincts 14, 15, 16, 17, 18, 19 & 26

FIFTH DISTRICT. The Fifth Councilmanic District shall consist of the following designated precincts:

(a) Perry Township Precincts 6, 8, 9, 10, 11, 12, 13, 28, 31 & 32

SIXTH DISTRICT. The Sixth councilmanic District shall consist of the following designated precincts:

(a) Bloomington Township Precincts 1, 3, 4, 19 & 20

(b) Perry Township Precincts 7 & 30

SECTION 2. The district boundaries established in this ordinance supersede those established in all previous ordinances.

SECTION 3. In accordance with I.C. 36-4-6-3(l), the City Clerk is directed to file the ordinance with the Monroe County Clerk not later than thirty (30) days after the ordinance is adopted.

SECTION 4. Severability. If any section, sentence or provision of this ordinance, or the application thereof to any person or circumstance shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

SECTION 5. This ordinance shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor.

SYNOPSIS

This ordinance fulfills the council's obligation, in accordance with IC 36-4-6-3, to establish six councilmanic districts in 2012 based upon data received as a result of the federal census in 2010. Under this statute, these districts must be contiguous, reasonably compact, and, as nearly as possible, of equal population. The ordinance brings forward recommendations of the Council Redistricting Committee, which invited members of the Council and public to offer maps for the Committee's consideration in light of the statutory requirements. The committee met four times, with members of the public and Council present at each meeting, considered various plans from council members and the public, and recommended this map which is in compliance with statutory requirements.
