## **MEMORANDUM**

**RE:** Request Approval of Update to Section 14 of Rules and Regulations

**Date:** August 22, 2022

CBU Engineering and City Legal recommend an update to Section 14 of the City of Bloomington Utilities Department's Rules, Regulations and Standards of Service. Section 14.2 and 14.3 deals with installation and maintenance of fire lines. This update reflects changes in the requirements for fire line installation.

The following edits are proposed:

- Eliminates the backflow treatment for firelines less than fifty feet in length;
- Establishes new options for firelines exceeding 100 feet
- Establishes new options for firelines of up to but not exceeding 100 feet.
- Establishes options where dual domestic/fire master meters are in use

### **MEMORANDUM**

**RE:** Request Approval of Updates to Section 24 of Rules and Regulations

**Date:** August 22, 2022

City Legal recommends updates to Section 24 of the City of Bloomington Utilities Department's Rules, Regulations and Standards of Service. Section 24 addresses comprehensive and systematic growth of CBU's sanitation sewer system. This update attempts reduce sanitary sewer expansion outside of City municipal boundaries down to those instances where a valid petition for voluntary annexation has been received. This edit is proposed against the backdrop of ever increasing legislative hostility towards annexation and the historic use of waivers of right to remonstrate.

The following edits are proposed:

- Eliminates the designation of areas A and B;
- Places greater emphasis on voluntary annexation as the preferred vehicle for receiving sanitary sewer service outside of the City's municipal boundaries;
- Emphasizes that waivers are no longer enough for CBU to rely upon in determining whether to provide sanitary sewer service outside of the City's municipal boundaries.
- Establishes factors that shall be considered in narrow circumstances where CBU might consider relying upon a waiver as opposed to voluntary annexation.
