We are entering the last legislative cycle of the year with the Regular Session followed by an extra Committee of the Whole next week. There are five items coming forward to the Regular Session from the previous Committee of the Whole. Please see the <u>17 November 2010</u> Council Legislative Packet and this packet for the relevant material and, in particular, the next part of this memo for some reminders of motions expected regarding items ready for final action that evening.

Please note that two items will be introduced that evening and can be found in this packet. One of those items, <u>App Ord 10-05</u>, will be discussed at the extra Committee of the Whole that evening and is scheduled for final action at a Special Session the following week (December 8<sup>th</sup>) at 7:30 p.m. immediately preceding the usual Committee of the Whole. The other item, <u>Ord 10-20</u> (Floodplain Amendments), is scheduled to be discussed at the Committee of the Whole on December 8<sup>th</sup> and given final action at the Regular Session on December 15<sup>th</sup>, along with three items scheduled to be distributed next Friday.

### **First Readings**

### Item 1 – <u>App Ord 10-05</u> (End of the Year Appropriation Ordinance)

**App Ord 10-05** is what is commonly known as the end-of-the-year appropriation ordinance. It would *transfer* monies *within* departmental budgets and, in a few instances, *add* monies to departmental budgets. The additional appropriations amount to \$490,668 which, once you account for reimbursements valued at \$362,000, would result in a net increase of about \$128,668, which are all in accounts outside of the General Fund. Please note, however, that because of reversions of unspent funds

expected at the end of the year, this ordinance will not lead to an increase in the overall appropriations for the year.

The following summary is derived from the enclosed memo from, and conversations with, Mike Trexler, Controller.

#### <u>Increased Appropriations – Fire Pension Fund, Risk Management Fund, and</u> <u>Various Bond Funds</u>

#### **Fire Pension Fund**

**Fire Department** – wishes to add \$362,000 to Category 3 - Other Services and Charges (Miscellaneous Other Services and Charges [Line 5399) as mentioned during the Departmental Budget Hearings. At that time, the Council learned that the pension payments were under-calculated and procedures are in place to avoid similar problems in the future. Please note that all of the funds are reimbursed by the State.

#### **Risk Management Fund**

**Risk Management Department** – wishes to add \$100,000 to Category 3 – Other Services and Charges (Workers' Compensation and Risk Administration [Line 5342]) to cover claims in excess of the original budget. Total payments in 2010 are expected to be around \$420,000 which is less than the approximately \$621,000 paid in 2009.

#### Various Bond Funds

The following additional appropriations correct errors in the 2010 budget which did not reflect aspects of the bond refunding done in 2009. Funds in the amount of \$9,500 would go towards lease payments and in the amount of \$19,168 for interest payments.

#### Item Two – <u>Ord 10-20</u> (Amending Title 20 – Unified Development Ordinance) to Conform Local Code to Federal Floodplain Requirements

**Ord 10-20** amends Title 20 of the Bloomington Municipal Code entitled "Unified Development Ordinance" to conform local code to federal floodplain requirements in the interest of keeping the community eligible for the National Flood Insurance Program. There are three key components to this insurance program. First, the Federal Emergency Management Agency (FEMA) prepares floodplain maps which identify flood-prone areas. In his memo, Tom Micuda, Director of Planning, says that his department received new floodplain maps earlier this year, which will go into effect on December 17<sup>th</sup>. Second, communities must adopt and enforce floodplain development regulations intended to mitigate flood losses that are at least as restrictive as the federal ones. Third, property owners may purchase subsidized insurance to cover losses due to floods. These amendments are timed to go in effect at the same time as the maps to avoid any suspension in that program.

As mentioned in the first paragraph, FEMA recently provided maps of flood-prone areas. It's my understanding that the affected property owners were notified of the new maps by the State and that a review by staff in the Planning department of draft maps reveal few changes from the current ones. These maps (which will be available at the meeting on December 8<sup>th</sup>) identify the entire floodplain, which is composed of the floodway and the floodway fringe. The floodway is the "flood hazard area required to store, convey and discharge peak flood flow of a regulatory

flood".<sup>1</sup> The floodway fringe is the area of the floodplain outside of the floodway which includes "adjoining wetlands, lakes or water courses."

The City's floodplain standards prohibit development in floodway except for open space uses, storm sewers and utility pipe lines. The same is true for the floodway fringe, except transportation facilities, water-related urban uses (such as wastewater treatment plants) and parking lots with permeable pavers are allowed as a conditional use. However, in no circumstances may a development or activity reduce the flood water storage capacity by impairing the flow of water, increasing the elevation of a regulatory flood, or any other means.

#### Amendments

Along with forwarding the new maps, officials at the Indiana Department of Natural Resources reviewed and recommended changes to the City's floodplain regulations. These changes:

#### Revise BMC 20.05.048 (d)(5)(A) Entitled "Location" by:

- Citing the maps dated December 17, 2010 rather than referring to previous maps and future amendments to them;
- Clarifying that the term "Special Flood Hazard Areas" (SFHA) is synonymous with the term "floodplain"; and
- Adding a sentence referring to "unstudied areas" where best available data must be used to determine the boundaries of high risk zones in floodplains fed by drainage areas in excess of one square mile.

# Revise BMC 20.05.048 (d)(5)(C) Entitled "Structure" by Applying Regulations to Entire Structures which Straddle the Floodplain Boundary"

Currently, when a structure straddles a floodplain boundary, only that portion of the structure which is less than 2-feet above the elevation of the base flood

<sup>&</sup>lt;sup>1</sup> A "regulatory flood" is also known as a "base flood" or 100-year flood, which is defined as an area which has a one percent or greater chance of flood in any year. The regulatory floodway is defined as the channel of a stream plus any adjacent floodplain areas that must be kept free of encroachment so that the entire Base Flood (100-year flood) discharge can be conveyed with no greater than a 1.0-foot increase in the Base Flood Elevation. FEMA, *National Flood Insurance Program – Program Description (August 1, 2002)*, http://www.fema.gov/library/viewRecord.do?id=1480.

elevation must comply with the regulations. Now, the entire structure must comply.

#### Revise BMC 20.05.048 (d)(6) Entitled "Watercourse Alterations" to Address Approvals, Notice and Maintenance:

Currently persons must obtain a Letter of Map Revision (LOMR) from FEMA as well as all necessary approvals and permits from the Department of Natural Resources (DNR), Indiana Environmental Management (IDEM), and the Army Corps of Engineers before altering any watercourse within a designated floodplain. With these changes, those persons would be explicitly required to maintain the altered or relocated watercourse so that it does not diminish its flood-carrying capacity. In addition, the City must notify any applicable adjacent communities and the State Floodplain Coordinator and submit copies of the notification to FEMA regarding these alterations.

#### Add Three New Provisions

The ordinance adds three new provisions:

- **Permits (BMC 20.05.048(d)(7))** which prohibits any floodplain development permit from being issued without receipt of all the necessary State and federal permits, which must be maintained on file with the development permit;
- Record Keeping (BMC 20.05.048(d)(8)) which elaborates upon what documents the City must maintain and furnish for public inspection. These include "local permit documents, damaged structure inventories, substantial damage determinations, regulatory flood data, SFHA maps, LOMA, LOMR, copies of DNR permits and floodplain analysis and regulatory assessments (letters of recommendation), federal permit documents, and "as-built" elevation and flood proofing data for all buildings constructed subject to this ordinance";
- Construction of Utilities and Waste Disposal Systems (BMC 20.05.048(d)(9)) which requires all utilities placed in the floodplain to be located and constructed to minimize or reduce flood damage. In addition, it requires that all sanitary sewage systems be designed to minimize or eliminate infiltration by flood waters and that on-site waste disposal systems be located and constructed to avoid their impairment by flood waters and to avoid contamination of the floodwaters by the waste.

#### Add or Modify Four Definitions

Lastly, the ordinance:

- Revises the term **Flood Insurance Rate Map** (**FIRM**) by indicating that it is the official map of the community identifying special flood hazard areas as well as various risk zones;
- Adds the term **Flood Insurance Study** (**FIS**) which is "the official hydraulic and hydrologic report ... contain(ing) flood profiles, as well as the Flood Insurance Rate Maps, Flood Boundary and Floodway Maps, and the water surface elevation of the base flood;"
- Revises the term **Floodplain** by making the term synonymous with Special Flood Hazard Areas (SFHA); and
- Adds the term **Special Flood Hazard Area** (**SFHA**) which is defined as "those lands subject to inundation by a regulatory flood" and "generally identified as such on the .... FIRM dated December 17, 2010 (and include) Zones A, AE. A10A30, AH, AR, A99 or AO."

Appropriation Ordinance 10-05 is our comprehensive 2010 year end appropriation. The total Appropriation comes to \$490,668. The majority of these appropriations are simple transfers within departments that have zero net impact on the total budget. \$362,000 of the total appropriation will be reimbursed in full by the State. \$28,668 of the total appropriation is needed for corrections related to bond refunding done at the end of 2009, and will come from funds already set aside for these bonds. The remaining \$100,000 is related to Worker's Compensation. None of these appropriations will increases spending in the City's General Fund.

- 1. **General Fund Animal Care & Control.** The Animal Care & Control Department has requested to transfer \$3,000 from Line 53130 Medical Services and \$2,000 from Line 53990 Other Services & Charges to Line 52210 Institutional & Medical Supplies to cover increasing costs for animal vaccines and medication.
- General Fund Engineering. The Engineering Department has requested to transfer \$4,211 from Line 53630 – Machinery & Equipment Repairs to Line 52420 – Other Supplies to fund additional traffic counting for the MPO. This amount will be 80% refundable through the MPO work program.
- 3. **General Fund Police.** The Police Department has requested to transfer \$21,040 from Line 53210 Telephone (\$3,040), Line 52420 Other Supplies (\$12,000), and Line 53990 Other Services & Charges (\$6,000) to Line 54440 Motor Equipment to replace one additional patrol car in 2010
- 4. **General Fund HAND.** The Housing & Neighborhood Development Department has requested to transfer \$1,000 from Line 51110 Salaries & Wages Regular to Line 52240 Fuel & Oil to supplement this line and ensure inspector will have enough fuel to continue Title 16 and Title 6 duties through the end of the year.
- 5. **General Fund CRFD.** The Community & Family Resources Department has requested to transfer \$1,400 from Line 52420 Other Supplies to Line 53990 Other Services & Charges to cover anticipated expenses through the end of the year.
- General Fund City Council. The City Council Office has requested to transfer \$2,100 from Line 53990 – Other Services & Charges to Line 51110 – Salaries & Wages – Regular (\$1,300) to cover additional payroll expenses not originally included in the

budget and Line 52420 – Other Supplies (\$800) for a docking station for the Deputy Administrator.

 Parking Enforcement Fund. The Parking Enforcement Department has requested to transfer \$74,000 from Line 53840 – Lease Payments to Line 51110 – Salaries & Wages -Regular (\$45,500), Line 51120 – Salaries & Wages - Temporary (2,500), and Line 54440 – Purchase of Equipment (\$26,000) to cover the cost of additional night time garage enforcement officers and to repair a pay station in Garage Market that has failed.

- 8. **Sanitation Fund.** The Sanitation Department has requested to transfer \$20,000 from Line 53950 Landfill Fees to Line 52240 Fuel & Oil to supplement this line and ensure the department will have enough fuel to continue its duties through the end of the year.
- Telecom Fund. The ITS Department has requested to transfer \$17,500 from Line 53170

   Mgt. Fees, Consultants & Workshops to Line 52420 Other Supplies to purchase desktop scanners as part of the city's effort to reduce paper usage.
- 10. **Fire Pension Fund.** The Fire Department has requested to increase its budget in Line 53999 Other Services and Charges by \$362,000 to correct an error included in the original 2010 budget.
- 11. **Risk Management Fund.** The Risk Department has requested to increase its budget in Line 53420 Worker's Comp & Risk Admin by \$100,000 to fund additional claims in excess of the original budget.
- 12. Bond Funds. The Controller's Office has requested to increase its budget in the BMFC Showers Fund Line 53840 Lease Payments by \$5,750, in the Golf Course Bond 99 Fund Line 53820 Interest by \$19,168, and in the BMFC 1998 Street Lease Fund Line 53840 Lease Payments by \$3,750 to correct an error included in the original 2010 budget due to the bond refunding done at the end of 2009 and beginning of 2010. There is a sufficient reserve in each of these bond funds to cover the requested appropriation.

The grand total of the appropriation is \$490,668. \$362,000 of this amount will be reimbursed in full by the State; and \$28,668 of this amount will come from bond reserve funds. Aside from the Worker's Compensation amount, this ordinance does not increase planned spending levels beyond those established in the original budget.

#### **ORDINANCE 10-20**

#### TO AMEND TITLE 20 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "UNIFIED DEVELOPMENT ORDINANCE" (Amendments to the Floodplain Standards [20.05.048] and Definitions [20.11.020] Sections to be Consistent with Federal Requirements)

- WHEREAS, Ordinance 06-24 approved the Unified Development Ordinance ("UDO"), which repealed and replaced both Title 20 of the Bloomington Municipal Code entitled, "Zoning," and Title 19 of the Bloomington Municipal Code, entitled "Subdivisions;" and
- WHEREAS, the UDO was substantially amended by <u>Ordinance 09-12</u>, which was effective December 7, 2009; and
- WHEREAS, the City has since been directed by the Federal Emergency Management Agency to update its floodplain regulations to be consistent with Federal regulations;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. Section 20.05.048(d)(3)(C) of the Bloomington Municipal Code shall be amended to add the following sentence at the end of the section: "The floodplain is also referred to as the Special Flood Hazard Area (SFHA)."

SECTION II. Section 20.05.048(d)(5)(A) of the Bloomington Municipal Code shall be amended by deleting the current provision and replacing it with the following:

(A) Location. The locations of the floodplain boundaries are based upon the regulatory flood elevation, floodway, and floodway fringe limits for the studied Special Flood Hazard Areas of the City of Bloomington as delineated on the 100-year profiles in the Flood Insurance Study of Monroe County and Incorporated Areas and the corresponding Flood Insurance Rate Map prepared by the Federal Emergency Management Agency and dated December 17, 2010. The flood profiles, and the Special Flood Hazard Areas delineated on the December 17, 2010 FIRM are a component of the official zoning map. The regulatory flood elevation, floodway, and fringe limits for each unstudied Special Flood Hazard Area of the City of Bloomington delineated as an "A Zone" on the FIRM of the Monroe County and Incorporated Areas prepared by the Federal Emergency Management Agency and dated December 17, 2010, shall be according to the best data available as provided by the Indiana Department of Natural Resources; provided the upstream drainage area from the subject site is greater than one square mile.

SECTION III. Section 20.05.048(d)(5)(C) of the Bloomington Municipal Code shall be amended to add that where a floodplain boundary divides a structure, the floodplain regulations apply to the entire structure so that the provision shall now read as follows:

(C) Structures Located on Boundary Lines: Where a floodplain boundary line divides a structure, these regulations shall apply to the entire structure.

SECTION IV. Section 20.05.048(d)(6) of the Bloomington Municipal Code shall be amended to add the following sentences at the end of the section:

Prior to any alteration or relocation of a watercourse, the City shall notify any applicable adjacent communities and the State Floodplain Coordinator. Copies of such notifications shall also be submitted to FEMA. Maintenance of any altered or relocated watercourse is required in order to ensure that no diminishing of flood-carrying capacity occurs.

SECTION V. Section 20.05.048(7) shall be added to the Bloomington Municipal Code and shall read as follows:

(7) No local floodplain development permit shall be issued unless all necessary federal or state permits have been received. Copies of such permits are to be maintained on file with the floodplain development permit.

SECTION VI. Section 20.05.048(8) Record Keeping - shall be added to the Bloomington Municipal Code and shall read as follows:

(8) Record Keeping: The City shall maintain for public inspection and furnish upon request local permit documents, damaged structure inventories, substantial damage determinations, regulatory flood data, SFHA maps, LOMA, LOMR, copies of DNR permits and floodplain analysis and regulatory assessments (letters of recommendation), federal permit documents, and "as-built" elevation and floodproofing data for all buildings constructed subject to this ordinance.

SECTION VII. Section 20.05.048(9) Construction of Utilities and Waste Disposal Systems - shall be added to the Bloomington Municipal Code and shall read as follows:

(9) Construction of Utilities and Waste Disposal Systems: Public utilities and facilities, such as sewer, gas, electrical, and water systems, shall be located and constructed so as to minimize or eliminate flood damage. New and replacement sanitary sewer systems shall be designed to minimize or eliminate infiltration of flood waters into the system. On-site waste disposal systems shall be located and constructed to avoid impairment to them or contamination from them during flooding.

SECTION VIII. Section 20.11.020 Defined Words - shall be amended in the following manner:

(a) The term "FIRM" shall be deleted and replaced with the following term and definition:

"Flood Insurance Rate Map (FIRM)" means the official map of the community, on which the Federal Emergency Management Agency (FEMA) has delineated both the areas of special flood hazard and the risk premium zones applicable to the community.

(b) The term and definition for Flood Insurance Study shall be added and shall read as follows:

"Flood Insurance Study (FIS)" means the official hydraulic and hydrologic report provided by the Federal Emergency Management Agency (FEMA). The report contains flood profiles, as well as the Flood Insurance Rate Maps, Flood Boundary and Floodway Maps, and the water surface elevation of the base flood.

(c) The term "Floodplain" shall be amended by adding the following sentence at the end of the definition: "The floodplain is also known as the Special Flood Hazard Area (SFHA)."

(d) The term and definition for Special Flood Hazard Area (SFHA) shall be added and shall read as follows:

"Special Flood Hazard Area (SFHA)" means those lands subject to inundation by the regulatory flood. The SFHAs within the City of Bloomington Planning Jurisdiction are generally identified as such on the Monroe County and Incorporated Area Flood Insurance Rate Map prepared by the Federal Emergency Management Agency, dated December 17, 2010. These areas are shown on a FHBM or FIRM as Zone A, AE, A1-A30, AH, AR, A99, or AO.

SECTION IX. If any section, sentence or provision of this ordinance, or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any other section, sentence, provision or application that can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are intended and declared to be severable.

SECTION X. This ordinance shall be in full force and effect from and after its passage by the Common Council and approved by the Mayor.

Attached are the ordinance, ordinance certification, and amendment text which pertain to Plan Commission Case # ZO-29-10. The Plan Commission heard this petition at its November 8, 2010 meeting and voted to send this petition to the Common Council with a positive recommendation.

**REQUEST:** The City Planning Department is requesting approval of a text amendment to the Unified Development Ordinance. This amendment will ensure that the Floodplain Standards section and Definitions section of the UDO are consistent with federal floodplain regulations.

Recently, the Planning Department received a new set of Floodplain maps from FEMA that will go into effect on December 17, 2010. In conjunction with the receipt of these maps, the Planning Department was informed that the Floodplain regulations of the UDO also need to be amended to reflect the date of the latest map revisions. This will ensure that the City's ordinance will maintain its consistency with federal enabling regulations starting December 17. If these revisions are not made by December 17, the local flood insurance program will be suspended until the revisions are adopted.

In addition to the new map reference change, staff has been directed by FEMA to make some minor terminology changes in the ordinance text to ensure consistency with the new FEMA language. For example, FEMA now refers to the Floodplain as the Special Flood Hazard Area. Other proposed revisions required by FEMA include: 1) changes in the application of floodplain regulations for structures located on floodplain boundary areas, 2) notification requirements, 3) maintenance of watercourses, 4) permitting and record keeping requirements, 5) construction requirements for utilities and waste disposal systems, and 6) additional definitions.

**RECOMMENDATION:** The Plan Commission voted unanimously (7-0) to forward Case # ZO-29-10 to the Common Council with a positive recommendation.

#### Amendment #: UDO-001

#### Synopsis:

This is a minor amendment to the UDO to ensure that our Floodplain regulations are in sync with the latest Federal standards from FEMA. The Planning Department has received a new set of Floodplain maps from FEMA that will go into effect on December 17, 2010. We need to update the UDO to reflect the date of the latest map revisions so that our ordinance will also remain in effect on December 17. If we do not make this change by December 17, the local flood insurance program will be suspended until the change is made. In addition to the date change, there will be some minor terminology changes to ensure that we are consistent with the new FEMA language. For example, FEMA now refers to the Floodplain as the Special Flood Hazard Area. Other revisions include: 1) the application of floodplain regulations for structures located on floodplain boundary areas, 2) notification requirements, 3) maintenance of watercourses, 4) permitting and record keeping requirements, 5) construction requirements for utilities and waste disposal systems, and 6) additional definitions.

The locations of the floodplain boundaries are based upon the regulatory flood profile, as delineated on the one hundred year flood profiles in the most current Flood Insurance Study prepared by FEMA. elevation, floodway, and floodway fringe limits for the studied Special Flood Hazard Areas of the City of Bloomington as delineated on the 100-year profiles in the Flood Insurance Study of Monroe County and Incorporated Areas and the corresponding Flood Insurance Rate Map prepared by the Federal Emergency Management Agency and dated December 17, 2010. The flood profiles, <del>delineated on those maps, and</del> the floodplain boundaries, as delineated on a copy of the FIRM, and the Special Flood Hazard Areas delineated on the December 17, 2010 FIRM are a component of the official zoning map., including any future amendments to the FIRM. Where FEMA flood profiles are not available, the base flood elevation and the required flood protection elevation shall be determined from the best available data by the Indiana Department of Natural Resources (DNR). Whenever a party disagrees with the best available data, the party submitting the detailed engineering study needs to replace existing data with better data and submit it to DNR for review and approval. The regulatory flood elevation, floodway, and fringe limits for each unstudied Special Flood Hazard Area of the City of Bloomington delineated as an "A Zone" on the FIRM of Monroe County and Incorporated Areas prepared by the Federal Emergency Management Agency and dated December 17, 2010, shall be according to the best data available as provided by the Indiana Department of Natural Resources; provided the upstream drainage area from the subject site is greater than one square mile.

(C) Structures Located on Boundary Lines: Where a floodplain boundary line divides a structure, these regulations shall apply to any portion of the structure that is less than two feet above the elevation of the base flood elevation the entire structure.

(6) *Watercourse Alterations*: No alteration shall be made to any watercourse in any floodplain area as shown on the Official Zoning Map or any area otherwise subject to the jurisdiction of DNR or FEMA without first securing a LOMR from FEMA, as well as any necessary permits and approvals from DNR, IDEM, and the Army Corps of Engineers. Prior to any alteration or relocation of a watercourse, the City shall notify any applicable adjacent communities and the State Floodplain Coordinator. Copies of such notifications shall also be submitted to FEMA. Maintenance of any altered or relocated watercourse is required in order to ensure that no diminishing of flood-carrying capacity occurs.

(7) *Permits*: No local floodplain development permit shall be issued unless all necessary federal or state permits have been received. Copies of such permits are to be maintained on file with the floodplain development permit.

(8) *Record Keeping*: The City shall maintain for public inspection and furnish upon request local permit documents, damaged structure inventories, substantial damage determinations, regulatory flood data, SFHA maps, LOMA, LOMR, copies of DNR permits and floodplain analysis and regulatory assessments (letters of recommendation), federal permit documents, and "as-built" elevation and floodproofing data for all buildings constructed subject to this ordinance.

(9) *Construction of Utilities and Waste Disposal Systems*: Public utilities and facilities, such as sewer, gas, electrical, and water systems, shall be located and constructed so as to minimize or eliminate flood damage. New and replacement sanitary sewage systems shall be designed to minimize or eliminate infiltration of flood waters into the system. On-site waste disposal systems shall be located and constructed to avoid impairment to them or contamination from them during flooding.
