Two Legislative Rounds for the First Four Weeks of September - No Meetings on September 8th -

The Council typically squeezes two legislative rounds into the first legislative cycle of September which, this year, includes meetings on September 1st, September 15th, and September 22nd. Please note that the Annual Schedule skipped a meeting on September 8th because it falls on Rosh Hashanah (the Jewish New Year) and added a meeting on the fifth Wednesday, in order to hold the usual number of four meetings this month.

Providing for two legislative rounds in the first legislative cycle in September allows the Council to take action on the budget well before the November 1st deadline (which was changed from September 30th in 2009) and also handle the other items that are ready for action by the middle of September.

<u>Budget Related Legislation.</u> The first legislative round will be set aside for seven pieces of legislation which are directly or indirectly related to the 2011 budget. This legislation will be introduced at the Regular Session on September 1st, discussed at Committee of the Whole which will be held immediately after the Regular Session, and is scheduled for final action at a Special Session on September 15th. These documents can be found in the special budget packet distributed simultaneously with the weekly packet and are briefly discussed in the latter part of this memo.

<u>Other Legislation</u>. Along with the budget-related ordinances, there is a non-budget related ordinance that will be considered during the second legislative round. Again, this

round begins with the introduction of the ordinance on the first Wednesday, continues with discussion of the legislation at a Committee of the Whole after the Special Budget Session on the third Wednesday, and concludes with final action on that item at the second Regular Session in September (which will be on September 22nd this year). This ordinance, <u>Ord 10-14</u>, would amend BMC 2.04.380 to change the order of business at Council Regular Sessions.

2011 Budget Packet

The 2011 budget packet has been enclosed with, but is separate from, the weekly packet. The Budget Packet contains:

- o an index of all 2011 budget-related materials;
- o six ordinances and background material constituting the 2011 budget (including Transit);
- one ordinance (<u>Ord 10-13</u>) changing the name of the Employee Services Department to the Human Resources Department; and
- a list of responses to questions raised but unanswered during the Departmental Budget hearings in July.

The ordinances are accompanied by memos and background material which are briefly highlighted below:

• <u>App Ord 10-02</u> (Civil City Budget for 2011) – includes a spread sheet from Mike Trexler, Controller, indicating the changes in the budget from July to September. Those changes amount to a net decrease of \$296,723 in the General Fund. As you will see below, this includes an increase of about \$34,893 due to corrections identified during or soon after the July budget hearings and about \$331,616 in reductions due to the loss of \$1.3 million in anticipated County Option Income Tax (COIT) revenue. The rest of the lower revenues will be offset by higher revenues in 2010 (about \$250,000 in COIT) and City reserves (about \$700,000). Here is the breakdown of those changes:

• App Ord 10-03 (Utilities Budget for 2011) – none

- Ord 10-09 (Salary Ordinance for Police Officers and Firefighters for 2011) a memo from Daniel Grundmann, Director of Employee Services, briefly summarizes the compensation package these police officers and fire fighters will receive as a result of collective bargaining agreements negotiated with the City. Under the current agreement, the fire fighters will receive a 3% increase along with longevity, education, certification, training, and other miscellaneous qualifications defined in the agreement.
 - <u>Note</u>: The current four-year Collective Bargaining Agreement with the Fraternal Order of Police expires at the end of this year (approved in <u>Res</u> <u>06-08</u>) and the parties are in the process of negotiating a new Agreement. Given the Evergreen Clause in the existing Agreement and on-going status of the negotiations regarding the new Agreement, this ordinance does *not* include any changes for positions covered by the existing Agreement. Once the parties arrive at an agreement, the Council would need to consider a(n):
 - resolution approving it,
 - amendment to this salary ordinance reflecting its terms, and in all likelihood,
 - appropriation ordinance in 2011authorizing any additional funds necessary to implement the agreement.
- <u>Ord 10-10</u> (Salary Ordinance for Civil City for 2011) a memo from Daniel Grundmann, Director of the Employee Services (to be called Human Resources), highlights the changes between the 2010 and 2011 Civil City Salary Ordinances. This annual ordinance sets forth the:
 - Title, grade and salary range for all employees not covered by the other salary ordinances;
 - Compensation received by members of certain boards (i.e. Board of Public Works, Board of Public Safety, and Utilities Services Board); and
 - Other provisions affecting compensation, including shift differentials, treatment of transfers and employees whose salaries fall outside of the pay range (typically due to longevity), gainsharing, emergency call out, on-call status, temporary reassignments, tool allowances, licenses and certifications, and holiday pay.

The changes over last year's ordinance (as amended by <u>Ord 10-05</u>) are in the following departments or parts of the ordinance and will:

- Section I Human Resources change the name of the department from Employee Services to the Human Resources department to correspond with generally accepted term for a department with those responsibilities;
- Section I Planning change the title for the *Long Range Planner* to *Zoning and Long Range Planner* and change the title for the *Transportation Planner* to the *Bicycle and Pedestrian Coordinator*;
- Section IIA Salary Ranges for Non-Union Employees increase the salary range for non-union positions by 5% to better reflect the City's market based structure. This table was last adjusted in 2007 and the annual fiscal impact (in the event the City reinstitutes its merit/market system for compensating these non-union employees) is estimated to be under \$10,000; and
- Section IID Labor, Trades and Crafts (AFSCME Union) Positions change pay the ranges for union positions (near the end of the ordinance) pursuant to Work Agreement and Memorandum of Understanding with this union (which will result in a base increase of about 3% for those employees).
- Ord 10-11 (Salary Ordinance for Elected Officials for 2011) a memo from Daniel Grundmann, Director of the Human Resources Department, indicates that the elected officials will receive no increase this year. This is consistent with the past practice of tying the increase in elected officials salaries to compensation for non-union employees which, this year, has been set at zero (rather than by the merit-market, compensation grid).
- Ord 10-12 (Reviewing and Adopting the Transit Budget for 2011) includes the Transit memo and budget materials, which remains unchanged from July. Please note that the City Council is poised to adopt the Transit budget, tax levy and tax rates (rather than merely review and modify the budget) because the percentage increase in the proposed 2011 budget is higher than the assessed value growth quotient minus one (as recently required by I.C. 6-1.1-17-20). For that reason, the budget materials include State forms 3, 4A, 4B and 2.

Ancillary Legislation Submitted Along with the Budget Package

Ord 10-13 Amending Title 2 Entitled "Administration and Personnel" to Change the Name of the Employee Services Department to the Human Resources Department

During his departmental budget presentation in July, Daniel Grundmann said that he would be requesting that the Council amend Title 2 of the Bloomington Municipal Code entitled "Administration and Personnel" in order to change the name of his department from Employee Services to Human Resources. This would follow the customary usage of the term in this field and make the responsibilities of his department clearer to those who are outside of City Hall. <u>Ord 10-13</u> accomplishes that change (and nothing more) and is coming forward now in order for the new name to be reflected in the 2011 Salary Ordinance.

Non-Budgetary Legislation Scheduled for the First Legislative Cycle in September

Ord 10-14 Amending BMC 2.04.380 Setting Forth the Order of Council Business at its Regular Sessions

<u>Ord 10-14</u> is coming forward as a result of the Report from the Rules Committee adopted by the Council on August 4, 2010. The Report focused on regulating public comment on non-agenda items at Regular Sessions and included a recommendation to amend BMC 2.04.380, which sets forth the order of business at those meetings.

Most of the recommendations do no more than reflect existing practices vetted by the Rules Committee and adopted by the Council. In that regard, the ordinance:

- Explicitly sets aside 20 minutes for each the four categories of Reports: Council members, the Mayor and City Offices; Council Committees, and Public; and
- Limits members of the public addressing the Council during Reports from the Public to speak for no more than five minutes about matters of community concern not on that evening's agenda; and

- Allows the Presiding Officer to reduce those individual time limits in order to accommodate an excess of speakers; and,
- In furtherance of existing practices, renames "Privilege of the Floor" to "Additional Reports from the Public" in order to make it clear to the public that they may address the Council on non-agenda items later in the agenda (but still keeps the 25-minute allotment for that section of the agenda).

However, after much deliberation by the Committee, the Report did recommend one change from existing practices, which is being codified by this ordinance. That change limits speakers who address the Council during Reports from the Public to one, rather than two, opportunities to make their comments. This was proposed in order to avoid repetition and help shorten the meetings.

In the course of reviewing this section of the code, staff also identified and proposes some additional changes. Some of these changes reflect or further existing practices. These would:

- Allow the Council, by a majority vote, to amend the time limits set forth in the ordinance (which is done now on occasion at the behest of the Presiding Officer); and
- Include an agenda item for "Appointments to Boards and Commissions"; and
- Add an agenda item for the "Council Schedule" in order to avoid the need to suspend the rules in order to deal with changes in the schedule.

One change proposed by staff and supported by the Council President would delete part (b) of BMC 2.04.380 because it's difficult to discern what it means and the most likely interpretation would neither comport with existing practice nor improve Council deliberations. The provision could be reinserted by an amendment and reads as follows:

Whenever possible, brief comments or questions concerning a statement made by a council member or any other person shall be made and addressed before further discussion proceeds, but more extensive discussion may occur later when the member raising the objection or question has been recognized to speak.

ORDINANCE 10-14 TO AMEND TITLE 2 OF THE BLOOMINGTON MUNICIPAL CODE ENTITLED "ADMINISTRATION AND PERSONNEL" Re: Amending BMC 2.04.380 (Order of Business at Regular Sessions)

- WHEREAS, on August 4, 2010, the Common Council adopted a Report of the Rules Committee which, in part, recommended that the Council amend Bloomington Municipal Code 2.04.380 (Order of Business) to reflect the Committee recommendations; and
- WHEREAS, while most of these recommendations do no more than reflect current practices, some offer changes; and
- WHEREAS, those changes limit speakers wishing to comment upon items not on the agenda to one, rather than two, opportunities to address the Council in order to avoid repetition and to shorten meetings; and
- WHEREAS, those changes also rename the "Privilege of the Floor" section on the agenda to "Additional Reports from the Public," in order to make it clear that the public may address the Council at that point on the agenda; and
- WHEREAS, in addition, while reviewing the section, staff identified and recommends further changes; and
- WHEREAS, these changes add a section entitled "Appointments to Boards and Commissions" to the agenda to reflect existing practice and add a section entitled "Council Schedule" in order to simplify the actions necessary for the Council to amend or approve its schedule; and
- WHEREAS, these changes also delete part (b) of BMC 2.04.380, which expressed a preference for the Presiding Officer to recognize a speaker who intended to address the previous speakers comments, because it would neither comport with existing practice nor improve Council deliberations;

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION 1. Title 2 of the Bloomington Municipal Code entitled "Administration and Personnel" shall be amended by deleting Section 2.04.380 entitled "Order of Business" and replacing it with the following, entitled 2.04.380 "Order of business at Regular Sessions." This new name for the section shall also replace the old name as it appears in the table of contents for this Chapter. The new section shall read as follows:

2.04.380 Order of business at Regular Sessions.

The council shall transact its business in the following order, but it may by majority vote amend the normal order of business and time limits set forth below:

- (1) Roll call;
- (2) Agenda summation;
- (3) Approval of minutes;
- (4) Reports (A maximum of twenty minutes is set aside for each part of this section.):
 - (A) Council members,
 - (B) The mayor and city offices,
 - (C) Council committees, and

(D) Public (During the two parts of the agenda set aside for Reports from the Public, speakers may speak only once, for no more than five minutes, on matters of community concern not on the agenda. The Presiding Officer may reduce the individual time limits to accommodate an excess of speakers.);

- (5) Appointments to Boards and Commissions;
- (6) Legislation for second readings and resolutions;
- (7) First readings;
- (8) Additional Reports from the Public (A maximum of twenty-five minutes is set aside for this section of the agenda. See also (4)(D) above.);
- (9) Council Schedule;
- (10) Adjournment.

SECTION 2. If any sections, sentence or provision of this ordinance, or the application thereof to any person or circumstances shall be declared invalid, such invalidity shall not affect any of the other sections, sentences, provisions, or applications of this ordinance which can be given effect without the invalid provision or application, and to this end the provisions of this ordinance are declared to be severable.

SECTION 3. This ordinance shall be in full force and effect from and after its passage by the Common Council of the City of Bloomington and approval of the Mayor.

SYNOPSIS

This ordinance amends BMC 2.04.380 entitled "Order of Business," which sets forth the order of items on the Council's Regular Session agenda. It implements recommendations made in the Report of the Rules Committee adopted by the Council on August 4, 2010 and also recommendations made by staff after reviewing the current section. In general, these changes reflect existing practices, many of which were adopted by the Council through Reports from the Rules Committee. One change is new and would allow speakers who wish to make a Report from the Public only one opportunity to address the Council rather than two. It was proposed in order to avoid repetition and to help shorten the length of the meetings.

However, after much deliberation by the Committee, the Report did recommend one change from existing practices, which is being codified by this ordinance. That change limits speakers who address the Council during Reports from the Public to one, rather than two, opportunities to make their comments. This was proposed in order to avoid repetition and help shorten the meetings.

In the course of reviewing this section of the code, staff also identified and proposes some additional changes. Some of these changes reflect or further existing practices. These would:

- Allow the Council, by a majority vote, to amend the time limits set forth in the ordinance (which is done now on occasion at the behest of the Presiding Officer); and
- Include an agenda item for "Appointments to Boards and Commissions"; and
- Add an agenda item for the "Council Schedule" in order to avoid the need to suspend the rules in order to deal with changes in the schedule.

One change proposed by staff and supported by the Council President would delete part (b) of BMC 2.04.380 because it's difficult to discern what it means and the most likely interpretation would neither comport with existing practice nor improve Council deliberations. The provision could be reinserted by an amendment and reads as follows:

Whenever possible, brief comments or questions concerning a statement made by a council member or any other person shall be made and addressed before further discussion proceeds, but more extensive discussion may occur later when the member raising the objection or question has been recognized to speak.
