- Commission re-structuring

 - Debby suggested continuing to build and nurture the partnerships and relationships that we already have, especially within the City
 - Monroe County Domestic Violence Coalition, Commission on the Status of Children and Youth, etc.
 - Discussed potentially partnering with MCDVC for an campaign on Interpersonal Violence
 - Commissioners discussed the idea of assigning a commissioner to each of these 3 topics, who would then report out monthly to the group.
 - Pros: It could help split up leadership and hold the commission more accountable to its mission and goals, while promoting more involvement
 - Cons: Big concerns over continuity. Attendance is not that great currently, and we have experienced some commissioner turnover. Assigning these subjects to individuals may slow down progress if that person is absent, resigns, etc.
 - A better solution may be to add Communications, Legislature and Community Partnerships to the agenda as standing monthly items that will be discussed at each meeting, without assigning them to an individual person.
