## **Survey Methodology**

- 4th time conducting the Bloomington Resident Survey
  - Previous iterations in 2017, 2019 and 2021
- Survey conducted from March 20th to May 1st, 2023
- Sampling approach employed:
  - Multi-contact approach (postcard + printed survey + postcard)
  - Probability-based, mail-based sample of 3,000 households
  - 367 total responses received
  - 13% overall response rate
- Results statistically weighted to reflect Bloomington population

Subject:	Environmental importance to Old State Road 37 and Lower Cascades Park		

The purpose of this memo is to convey the Environmental Commission's (EC) thoughts regarding the environmental impacts and other sustainability factors (environmental protection, economic viability, and social equity) used to consider changes made to Old 37 and Lower Cascades Park.

As we know, the decision as to whether to keep the road as it is, close it, or design something inbetween is a complex and contentious topic. Therefore, the EC does not intend to promote any of the four options, per se, but merely list issues they believe should go into making the choice. This park is the oldest in Bloomington, and deserves to be protected and available to everyone, which translates into choosing the alternative with the least environmental and economic impacts, and the least obstacles to park-visitor access.

In no particular order, here are some issues to consider:

- 1. Stream stabilization will be required for all options, but disturbing the least amount is best.
- 2. Utility improvements will also be required for all options, but disturbing the least new ground is best.
- 3. All choices will require maintenance, but the less new construction, the easier and cheaper it will be.
- 4. Choose the minimum disturbance for new stream work.
- 5. Pick the option that will leave room for riparian buffer improvement.
- 6. Conserve the most vegetation, especially mature trees, needed for climate-change mitigation.
- 7. Preserve the greatest amount of habitat connectivity.
- 8. Minimize additional impervious surface disturbance.
- 9. Maximum protection for sensitive soils.
- 10. Prevent disturbance to wetland and flood plain areas.
- 11. Avoid karst features, as that could change the flow of the waterfalls and the creek downstream.
- 12. Steer clear of any disturbance to additional steep slopes.
- 13. Choose the option that uses the least amount of new pavement material. Environmental and financial.
- 14. Disturb the smallest amount of wildlife habitat.

- 15. Reduce damaging vehicular emissions the most.
- 16. Prevent further flooding downstream by not adding more impervious surfaces or straightening the creek.
- 17. Provide the most pedestrian and bicycling accessibility.
- 18. Use the most existing hardscape.
- 19. Consider safety risks for non-motorists.
- 20. Bear in mind all aspects of sustainability.
- 21. Remember that the many different City plans and feasibility studies that called for better trail connections, better bicycle and pedestrian infrastructure, and few automobile emissions were examined, scrutinized, and chosen by the public and local leaders.
- 22. Take into account the unsafe situation of pedestrians and bicycles sharing the road with weekend, game-day cut-through vehicles.
- 23. Consider the parallel roads very close on both sides of Old SR 37 that can be used.
- 24. Use permeable pavement for all new surfaces.
