CALL TO ORDER - ROLL CALL

The meeting was called to order by Kathleen Mills at 4:30pm Present: Kathleen Mills, Ellen Rodkey, Israel Herrera and James Whitlatch

BOARD COMMENTS: The Board of Park Commissioners occasionally held special meetings when topics need to be addressed separately from other business in Park Board regular meetings. Today's meeting would be to review Resolution 23-02 - Policy #13220. A change of how structures and what types of structures were permitted in/on Park Properties.

A. BUSINESS

A1. Review/Approval of Resolution 23-02 - Policy #13220 "Use of Structures on Park Properties" <u>Paula McDevitt, Director</u> the Parks and Recreation Department and staff recommend approval of Resolution 23-02 Titled "Use of Structures on Park Properties". The parks, properties and facilities, under the authority of the Board of Park Commissioners and the Bloomington Parks and Recreation Department, are intended for the recreational use of the whole Community. The department is responsible for maintaining parks and trails and program spaces throughout the whole park system. The Board of Park Commissioners have the authority to set policy to support the mission and work of the department.

Camping structures and makeshift enclosures have been set up in park locations prohibiting the use and enjoyment of these spaces by the whole community. Camping structures and makeshift enclosures have become a serious public health risk and safety issues due to vandalism, illegal activity, and the accumulation of abandoned property and garbage.

Resolution 23-02 outlines the reasons for the resolution, and the adoption of Policy #13220 entitled "Use of Structures on Park Properties". The policy addresses the concerns presented by enclosures while still permitting the appropriate use of shade structures. The policy however, is not intended to preclude the use of tents or similar enclosures that are authorized by the Department's Special Use permit process, or in association with Bloomington Parks and Recreation events programs and tournaments. Nor is the policy intended to prohibit unenclosed shade structures. Unenclosed shade structures provide relief to park users

from exposure to sun, rain and snow, and other elements but do not shield activities occurring beneath the shade structures from public view. The make shift structure that will no longer be permissible are shade structures that are located in areas so that an activity beneath the shade structure is fully or partially obstructed from view, or obstructions or other materials are placed around a shade structure as to fully or partially obstruct the activity beneath the shade structure.

<u>Tim Street, Operations and Development Division Director</u>, provided data compiled from August 2022 through July 2023, based off of incident reports.

- Security was in the parks every day, with exception of two holidays
- Contract for 2023 security in parks and on trails would cost \$297,840
- Marshall Security reported 1724 incidents at sites they patrol
- 2022 Bloomington Police Department reported 3688 call for services in parks and on trails

PUBLIC COMMENT

<u>Kathleen Mills</u> opened the floor to public comments. The Board received public comments both in favor and opposed to Resolution 23-02 – Policy #13220 "Use of Structures on Park Properties".

Board Comments: *Jim Whitlatch commented:* I appreciate hearing all the input from everyone that has made input today. There's no question that we need social services and other issues dealt with, and available for everyone that's involved in these issues. Our issue as the Park Commissioners is to take care of the parks, and to make the parks accessible to all, and to have a safe environment for all that utilize the parks regardless of their housing status and other issues that may be involved. This is not an effort to ban people from the parks. This proposal, it's not kicking people out of the parks, it's assisting us in ensuring that we have a safe environment in the parks. I'm in support of the Ordinance and Resolution and would support it passing today.

Kathleen Mills commented: I would just add a little to what Jim has said. That unfortunately when these issues come up it becomes, and I totally understand this, it comes a little bit of a referendum on how we as a society are helping people who are unhoused. Those are all great questions to ask. We are tasked with overseeing what goes on in Parks. The Parks Department is always in liaison with social service agencies and has a partnership program with Centerstone to help. We cannot solve the problem of being unhoused in Bloomington. There definitely should be more resources, and definitely there should be more space. We are here to make sure that the parks properties are safe and accessible for everyone. As the people also oversee what the decisions the parks department makes, we can't really continue this cycle the needle removal, the trash removal, and the storing of belongings. It gets a little bit hard as a Parks Commissioner, to say we're just doing the same thing over and over again, and we don't seem to be finding our way out of it. I would also tend to be in support of this. I don't know if it's going to make a difference, but I know we're at a crisis point.

Ellen Rodkey commented: I would also just echo, this is really a complex issue. I would caution our community from having a stigma against the unhoused population. They're all members of our community, everyone is welcome in parks. They need to be accessible for everyone. I would just say again it's just it's a really complex issue. Our role is making sure that Park staff can do the job that they have to do to maintain our facilities. I think everyone in this room realizes that this is a community issue, and that we all play a part in it. I am going to vote in favor of passing this resolution. We still have a lot of work to do with our Community and Family Resources and with the Heading Home Group to figure out what's going to happen now that the Wheeler Women's Shelter is closing. We all have a part to play in helping solve those issues.

Israel Herrera commented:

We hear through public comment that there is the need for conversation in our city, and in our community. Since the last time we voted for a resolution there was involvement of everyone the community, the organizations, the administration because this conversation was needed. Since the last time there has been

this kind of a conversation there are things that need to be improved. One of the things that my colleagues have mentioned, is that our charge to see how parks has been working in recent years, the health problems, and safety. We care, and we take into account unhoused people. The results that we have seen from the reports show we have to be concerned with the parks, and the best way to take care of the parks. To behave in a way that all citizens should be in a in a parks. So as my colleagues have mentioned, I'm also in favor of this ordinance

Ellen Rodkey made a motion to approve Resolution 23-02 adopting Policy #13220 entitled "Use of Structures on Park Properties". *Jim Whitlatch* seconded the motion. Vote take: motion is unanimously carried 4-0

The Board thank everyone who came to comment.

B. PUBLIC HEARINGS/APPEARANCES

B-1. Bravo Award

Emily Buuck, Community Relations Coordinator presented Kip and Whitney Schlegel August Bravo. They had been vendors with the Farmers' Market since 1999, and hosted the Banneker Summer Nature Club since 2017. They introduce campers to their animals, and explain how their farm produces the crops, eggs, meat, and wool. They provide the children with an experience that most of them would likely never have otherwise. Staff were grateful to Kip and Whitney for their hospitality and dedication to Banneker campers.

Whitney Schlegel thanked the Board and staff for the award and opportunity to work with the City.

The Board thanked Kip and Whitney for their support.

C. OTHER BUSINESS

C-1. Review/Approval of Partnership Agreement with Summer Star Foundation for Nature, Art, and Humanity, Inc.

<u>Rebecca Swift, Natural Resources Coordinator</u> staff wished to continue to provide fourth grade Monroe County Community School Corporation students with an experiential environmental education program. Staff recommended approval of the Agreement with Summer Star Foundation for the Griffy Lake Nature Day program for the 2023-2024 school year. The Summer Star Foundation would provide a maximum \$7,500 to cover program expenses.

Ellen Rodkey made a motion to approve the agreement with Summer Star Foundation. *Israel Herrera* seconded the motion. Vote take: motion unanimously carried 3-0

C-2. Review/Approval of Contract with 858 Industries for Installation of Sound Equipment at Switchyard Park *Leslie Brinson, Community Events Manager* to provide the community with a better experience at events, staff wished to have new sound equipment installed. Contractor would permanently place monitors, subwoofers and an amplifier at the Switchyard Park Main Stage. Staff recommended approval of the contract with 858 Industries in an amount not to exceed, \$6,500. Project would be funded through ARPA funds.

Board Comments: *Kathleen Mills inquired:* if the equipment would be an upgrade. *Leslie Brinson responded:* it would be an upgrade, but would also keep staff from having to transport sound equipment from location to location. *Israel Herrera inquired:* about the possibility of vandalism. *Leslie Brinson responded:* the equipment is under the awning, and will be installed with brackets. The equipment is built for the outside environment.

Ellen Rodkey made a motion to approve contract with 858 Industries. *Israel Herrera* seconded the motion. Vote take: motion unanimously carried 3-0

C-3. Review/Approval of Contract with Electric Plus for Switchyard Park Sound Equipment

<u>Leslie Brinson, Community Events Manager</u> to provide the community with a better experience at events, staff wished to have power ran to new sound equipment. Contractor would run conduit and power to the new sound equipment installed at Switchyard Park Main Stage. Staff recommended approval of the contract with Electric Plus in an amount not to exceed \$10,500. Project would be funded through ARPA funds.

Ellen Rodkey made a motion to approve the contract with Electric Plus. *Israel Herrera* seconded the motion. Vote take: motion unanimously carried 3-0

C-4. Review/Approval of Contract with BSN Sports for Soccer Field Turf Replacement at Twins Lakes Recreation Center

<u>Daren Eads</u>, <u>Sports Facility Coordinator</u> due to age and high usage, the indoor field at Twin Lakes Recreation Center needed replaced. Contractor would remove and replace the synthetic field surface. Staff recommended approval of the contract with BSN Sports in an amount not to exceed \$222,762.86. The project would be funded through Parks Non-Reverting budget.

Board Comments: *Kathleen Mills inquired:* time frame for replacement, and how long the field would be unavailable for use. *Daren Eads responded:* approximately one week, and would be during the off season. The new turf would be cleaner and more environmentally friendly. *Ellen Rodkey inquired:* if the new turf would bring in new groups. *Daren Eads responded:* the fields was booked the majority of the time. Daytime hours were available.

Ellen Rodkey made a motion to approve contract with BSN Sports. *Israel Herrera* seconded the motion. Vote take: motion unanimously carried 3-0

C-5. Review/Approval of Partnership Agreement with Bloomington Soccer, LLC for Soccer Program at Twin Lakes Recreation Center

<u>Mark Sterner, General Manager, Twin Lakes Recreation Center</u> staff wished to continue to provide the community with an opportunity to participate in a youth and adult soccer program. The programs include developmental programs, as well as recreational and competitive soccer leagues for youth and adults. Staff recommended approval of the partnership with Bloomington Soccer, LLC. Total revenue from agreement would be approximately \$40,000, and would be deposited into Twin Lakes Recreation Center Non-Reverting fund. A 30% revenue share would be paid to FSC on all facility-generated subscriptions.

Israel Herrera inquired: if scholarships were offered. Mark Sterner responded: they do not.

Ellen Rodkey made a motion to approve the agreement with Bloomington Soccer, LLC. *Israel Herrera* seconded the motion. Vote take: motion unanimously carried 3-0

C-6. Review/Approval of Contract with LiveBarn to Live stream Hockey Games from Frank Southern Center <u>*Dee Tuttle, Sports Facility/Program Manager*</u> staff wished to provide the community, fans, and family members the opportunity to view home hockey games played at Frank Southern Center online. LiveBarn was a zero cost, completely automated solution for viewing youth and amateur athletic events in any size facility. It was subscription based to access Live Stream and On Demand broadcasts. The LiveBarn IOS App allowed subscribers to access the service on many mobile devices. Staff recommended approval of the contract with LiveBarn, at no cost to the department. There would be a 30% revenue share paid to Frank Southern Center on facility-generated subscriptions.

Board Comments: *Kathleen Mills inquired:* if it was an app that was downloaded. *Dee Tuttle responded:* that was correct. *Ellen Rodkey inquired:* on support, and privacy issues.

LiveBarn representative explained fee structure and explained technical support provided. Staff would have ability to black out times and signs would be posted regarding live streaming occurring.

Ellen Rodkey made a motion to approve contract with LiveBarn. *Israel Herrera* seconded the motion. Vote take: motion unanimously carried 3-0

C-7. Review/Approval a Change to the Price Schedule for Holiday Market Electricity

<u>Leslie Brinson, Community Events Manager</u>, due to availability and increasing requests for sites with electricity at Holiday Market, staff wished to increase the optional electricity fee for the 2023 Holiday Market from \$10.00 to \$15.00. The market provided the community to shop locally from local artists, farm vendors, and local product vendors.

Board Comments: *Kathleen Mills inquired:* have vendors been denied electricity. *Leslie responded:* it had happened occasionally, and was getting harder to manage. *Ellen Rodkey inquired:* if the five dollar increase was enough. *Leslie responded:* staff thought it would be enough. *Ellen Rodkey inquired:* if it was different from the Price Scheduled approved each year. *Paula McDevitt responded:* it was different. Any new charges or changes had to be brought before the Board for approval and then they were incorporated into the Price Schedule.

Ellen Rodkey made a motion to approve price change to the Holiday Market Electricity price. *Israel Herrera* seconded the motion. Vote take: motion unanimously carried 3-0

C-8. Review/Approval of Contract Bluestone Tree LLC for Tree Replacements in Roadway Medians

<u>Haskell Smith, Urban Forester</u> due to tree loss, new trees needed planted in medians. Contractor would plant twentyone trees in four street medians; W. Third, W. Second, S. Henderson, and College. Staff recommend approval of the contract with Bluestone Tree LLC, in an amount not to exceed \$36,038. Project would be funded through the Bicentennial Tree fund.

Ellen Rodkey made a motion to approve contract with Bluestone Tree LLC. *Israel Herrera* seconded the motion. Vote take: motion unanimously carried 3-0

C-9. Review/Approval Contract with Davey Resource Group

<u>Haskell Smith, Urban Forester</u> to allow Urban Forestry staff and the public to keep updated records on areas of growth or loss, and to address each instance, staff wished to have trees re-inventoried. Contractor would inventory trees and stumps in City street rights-of-way or City parks in council districts 1 and 3. It would be the first round of a 10 year

program. Staff recommended approval of the contract with Davey Resource Group, in an amount not to exceed \$43,980.50. The project would be funded from Urban Forestry General Fund.

Ellen Rodkey made a motion to approve contract with Davey Resources Group. *Israel Herrera* seconded the motion. Vote take: motion unanimously carried 3-0

C-10. Review/Approval of Contract with West Inc. for Griffy Lake Wetland Delineation

<u>Steve Cotter, Natural Resources Manager</u> to determine future trails and construction, staff wished to determine the extent of wetlands east of Headley Rd. Contractor would delineate wetlands and waterbodies at the east end of Griffy Lake and would include initial desktop assessments, fields surveys and report preparation. Staff recommended approval of the contract with West Inc., in an amount not to exceed \$10,153. The project would be funded from Natural Resources General Fund.

Board Comments: *Ellen Rodkey inquired:* on what future trails in the wetland area would look like. *Steve Cotter responded:* the design had not been established, one option would be precast concrete.

Ellen Rodkey made a motion to approve the contract with West Inc. *Israel Herrera* seconded the motion. Vote take: motion unanimously carried 3-0

C-11. Review/Approval of Contract with James Hall for Historic Consultation Work for Lower Cascades Park

Tim Street, Operations and Development Division Director the contract was for outstanding follow up work to be completed by J.P. Hall, a professor at Ball State University, to acquire the National Register of Historic Places designation for Lower Cascades Park. The work was related to (and was required) as part of the Lower Cascades Trail Phase 5 and Streambank Stabilization project in 2022. The nomination was completed but was awaiting state review. It would replace an existing carryover purchase order to Eagle Ridge Civil Engineering for the same amount, as the City would be working directly with the consultant to finish the work. Staff recommended approval of the contract with James Hall, in an amount not to exceed \$5,400. Project would be funded from Bicentennial Bond 980-18-1818B-54510. Project Code: 980-2020B.

Ellen Rodkey made a motion to approve contract with James Hall. *Israel Herrera* seconded the motion. Vote take: motion unanimously carried 3-0

C-12. Review/Approval of Temporary Encroachment Agreement with Wininger Construction, Inc. for Rail Trail Connection to Southern Meadows Development

<u>Tim Street, Operations and Development Division Director</u> the encroachment agreement would allow Wininger Construction to build a connection to the Bloomington Rail Trail on Parks property from the northern end of their development, Southern Meadows, located at the intersection of S. Rogers St. and That Rd. After building the connection, the developer would maintain responsibility for the portion of trail on their property and Parks will accept and assume responsibility for portions on Parks property. Staff recommended approval of the Encroachment Agreement with Wininger Construction, Inc.

Board Comments: *Kathleen inquired*: if it would be a soft service trail. *Tim Street commented*: yes, it would be constructed of crushed gravel.

Ellen Rodkey made a motion to approve encroachment agreement with Wininger Construction. *Israel Herrera* seconded the motion. Vote take: motion unanimously carried 3-0

C-13. Review/Approval of Contract with Bledsoe, Riggert, Cooper & James, Inc. for RCA Park Accessible Path Design to a New Picnic Shelter

<u>Tim Street</u>, <u>Operations and Development Division Director</u> in 2022, due to deteriorating condition, the large picnic shelter was removed from RCA Park. Staff planned to install a new picnic shelter at a new locations in RCA Parks. As part of the new relocation, a new accessible pathway would need to be designed and constructed. Contractor would survey the area and complete the civil engineering design work necessary to be able to construct a fully compliant ADA pathway. Staff recommended approval of the contract with E&B Paving, in an amount not to exceed \$13,580. Project for the funding would be from Operations General Fund.

Board Comments: Kathleen Mills inquired: if the previous shelter had been assessable. Tim Street responded: yes.

Ellen Rodkey made a motion to approve contract with Bledsoe, Riggert, Cooper & James. *Israel Herrera* seconded the motion. Vote take: motion unanimously carried 3-0

C-14. Review/Approval of Contract with E&B Paving, Inc. for Rogers St. Sidewalk and Culvert Extension Project

Tim Street, Operations and Development Division Director staff wished to have a missing section of sidewalk completed. Contractor would build a retaining wall and complete the sidewalk on the east side of Rogers St. from the Switchyard Park entrance to the Warehouse. Staff recommended approval of the contract with E&B Paving in an amount not to exceed \$330,833. The project would be funded form the 2022 Parks GO bond 985-18-180000-54510, Project Code: 985 2023a.

Ellen Rodkey made a motion to approve contract with E&B Paving. *Israel Herrera* seconded the motion. Vote take: motion unanimously carried 3-0

COOPERATIVE PROGRAM PARTNERSHIP AGREEMENT

PAINT BLOOMINGTON

This agreement is made and entered into this _____ day of _____, 2023, by and between the City of Bloomington Parks and Recreation Department ("BPRD") and Paint Bloomington ("Paint Bloomington").

WHEREAS, BPRD and Paint Bloomington desire to cooperate in the provision of free painting workshops for the benefit of the general public; and

WHERAS, Paint Bloomington is qualified to perform such services with BPRD; and

WHERAS, BPRD is authorized to plan and develop partnerships and contractual arrangements with non-city organizations to ensure delivery of services;

NOW, THERFORE, in consideration of the terms and conditions set forth herein, the Partners to this Agreement agree as follows:

1.0 Purpose of Agreement:

The purpose of this Agreement is to outline a program partnership which provides for a free outdoor painting event opportunity for the Bloomington community and for the youth participating in Parks Summer Programs by combining available resources from each partner to the Agreement.

2.0 Duration of Agreement:

This agreement shall be in full force and effect from July 1, 2023 to November 1, 2023, unless early termination occurs as described in Article 7 of this Agreement

3.0 Bloomington Parks and Recreation

The goal of BPRD is to build a positive relationship with Paint Bloomington in order to provide more affordable painting opportunities for the Bloomington community. BPRD agrees to:

3.1 Provide Bryan Park and the Woodlawn Shelter for a Paint Bloomington! Paint-Out event on October 7, 2023 from 10:00 a.m.-3:00 p.m.

- **3.2** Connect Paint Bloomington with Kid City Camp and the Banneker Camp Program for free painting workshops during the summer programs.
- **3.3** Promote the October 7th event through social media, listing Paint Bloomington as a cosponsor in all publicity.

4.0 Paint Bloomington

The goal of Paint Bloomington is to provide free and accessible opportunities for the community to receive painting support and create an accessible opportunity for all ages. Paint Bloomington is a collaborative art event hosted by Arts Alliance of Greater Bloomington, Artists for Climate Awareness, Bloomington Watercolor Society, Portrait Group, and Upland Plain Air. Paint Bloomington agrees to:

- **4.1** Promote the event through their social media outlets, listing BPRD as a co-sponsor in all publicity.
- **4.2** Provide volunteers and painting supplies for the October 7th Paint –Out Event.
- **4.3** Provide adequate staff and volunteers to manage the event.
- 4.4 Provide volunteers to work with the Kid City and Banneker Camp programs.
- **4.5** Provide free art supplies to any member of the public who like to participate in these programs.

5.0 Terms Mutually Agreed To By All Partners To This Agreement:

The intent of this Agreement is to document a mutually beneficial partnership between BPRC and Paint Bloomington.

- **5.1** The staff and personnel involved will at all times represent all partners to this Agreement in a professional manner and reflect the commitment of both partners to quality services and customer satisfaction.
- **5.2** To commitment of personnel, promotions, equipment, and funding sources will be honored according to the timetable agreed upon by all partners.
- **5.3** Bloomington Municipal Code sections 6.12.030 and 14.36.090, respectively, prohibit smoking in public places and the consumption of alcoholic beverages on City of Bloomington property.
- **5.4** The possession of drugs and other illegal controlled substances, fireworks, air rifles, paintball guns, bow and arrows, crossbows, swords, and pellet guns is strictly prohibited in any park or park facility. In addition, pursuant to Bloomington Municipal Code 14.20.020, the discharge of a firearm is strictly prohibited within the City's jurisdiction.

5.5 This Agreement and the services provided will be evaluated in March 2024.

7.0 Termination:

- **7.1** Termination by mutual agreement: The partners may terminate this Agreement prior to December 31, 2023, by mutual written agreement only.
- **7.2** Unilateral termination: In the event that one of the partners to this Agreement breaches any of its terms and conditions, the non-breaching party shall serve written notice of the breach to the other party by certified mail. The breaching party shall then have ten (10) days from the date of mailing in which to cure the breach. If the breaching party fails to cure the breach within ten (10) days, the non-breaching party may, at its option and in writing, unilaterally terminate the Agreement.

8.0 Waiver

No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the other party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

9.0 Release and Hold Harmless Agreement:

Paint Bloomington, including its representatives, agents, and assigns, does hereby agree to release, hold harmless, and indemnify the City of Bloomington, its Parks and Recreation Department, and any and all employees, agents, and assigns from any and all claims, causes of action, suits, proceedings,

or demands, including but not limited to claims involving personal injury or death, which may arise from this Agreement, even if caused by negligence of releases.

10.0 Non-Discrimination

Paint Bloomington shall comply with City of Bloomington Ordinance 2.21.020 and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment. Paint Bloomington_understands that the City of Bloomington prohibits its employees from engaging in harassing or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If Paint Bloomington believes that a City employee engaged in such conduct towards Paint Bloomington and/or any of its employees, Paint Bloomington or its employees may file a complaint with the City department head in charge of the Paint Bloomington work, and/or with the City human resources department or the Bloomington Human Rights Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct

11.0 E-Verify

Paint Bloomington required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Paint Bloomington shall sign an affidavit, attached as Exhibit C, affirming that Paint Bloomington does not knowingly employ an unauthorized alien. "Unauthorized alien" is defined at 8 U.S. Code 1324a(h)(3) as a person who is not a U.S. citizen or U.S. national and is not lawfully admitted for permanent residence or authorized to work in the U.S. under 8 U.S. Code chapter 12 or by the U.S. Attorney General. Paint Bloomington and any subcontractors may not knowingly employ or contract with an unauthorized alien, or retain an employee or contract with a person that the Paint Bloomington or subcontractor subsequently learns is an unauthorized alien. If the City obtains information that the Paint Bloomington or subcontractor employs or retains an employee who is an unauthorized alien, the City shall notify the Paint Bloomington subcontractor of the contract violation and require that the violation be remedied within 30 days of the date of notice. If the Paint Bloomington or subcontractor verified the work eligibility status of the employee in question through the E-Verify program, there is a rebuttable presumption that Paint Bloomington or subcontractor did not knowingly employ an unauthorized alien. If the Paint Bloomington or subcontractor fails to remedy the violation within the 30 day period, the City shall terminate the contract, unless the City Commission or department that entered into the contract determines that terminating the contract would be detrimental to the public interest or public property, in which case the City may allow the contract to remain in effect until the City procures a new Contractor. If the City terminates the contract, the Paint Bloomington or subcontractor is liable to the City for actual damages. Paint Bloomington shall require any subcontractors performing work under this contract to certify to the Paint Bloomington that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Paint Bloomington shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

12. Non- Collusion

Paint Bloomington is required to certify that it has not, nor has any other member, representative, or agent of the firm, company, corporation or partnership represented by them, entered into any combination, collusion or agreement with any person relative to the price to be offered by any person nor to prevent any person from making an offer nor to induced anyone to refrain from making an offer and that this offer is made without reference to any other offer. Paint Bloomington shall sign

and affidavit, attached hereto as Exhibit B, affirming that Paint Bloomington has not engaged in any collusive conduct. Exhibit B is attached hereto and incorporated by reference as through fully set forth.

SERVICE AGREEMENT/SHORT CONTRACT BETWEEN CITY OF BLOOMINGTON PARKS AND RECREATION DEPARTMENT

AND

Intra Collegiate Emergency Medical Service (IU-EMS)

This Agreement, entered into on this ______ day of ______, 2023, by and between the City of Bloomington Department of Parks and Recreation (the "Department"), and Intra Collegiate Emergency Medical Service ("Contractor").

Article 1. <u>Scope of Services</u>. Contractor shall provide **non-transport basic life support emergency medical services for the duration of the** Veteran's 5k race ("Services"). IC-EMS will provide 2 EMTs and 3 First Aid Providers at a cost of \$228.00.

Contractor shall diligently provide the Services under this Agreement and shall complete the Services described in this Agreement in a timely manner consistent with the Standard of Care identified in Article 2. Contractor shall complete the Services required under this Agreement on or before Nov. 11, 2023, unless the parties mutually agree to a later completion date. Completion shall mean completion of all work related to the Services. In the performance of Contractor's work, Contractor agrees to maintain such coordination with the Department as may be requested and desirable, including primary coordination with Shelby Drake as the Department's Project Manager. Contractor agrees that any information or documents, including digital GIS information, supplied by the Department pursuant to Article 3, below, shall be used by Contractor for this project only, and shall not be reused or reassigned for any other purpose without the written permission of the Department.

Article 2. <u>Standard of Care</u>. Contractor shall be responsible for completion of the Services in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances ("Standard of Care"). The Department shall be the sole judge of the adequacy of Contractor's work in meeting the Standard of Care; however, the Department shall not unreasonably withhold its approval as to the adequacy of Contractor's performance. Upon notice to Contractor and by mutual agreement between the parties, Contractor will, without additional compensation, correct or replace any and all Services not meeting the Standard of Care.

Article 3. <u>Responsibilities of the Department.</u> The Department shall provide all necessary information regarding requirements for the Services. The Department shall furnish such information as necessary for the orderly progress of the work, and Contractor shall be entitled to rely upon the accuracy and completeness of such information. The Department's Project Manager shall act on its behalf with respect to this Agreement.

Article 4. <u>Compensation</u>. The Department shall pay Contractor for all fees and expenses in an amount not to exceed two hundred and twenty-eight dollars (\$228.00). Contractor shall submit an invoice to the Department upon the completion of the Services described in Article 1. The invoice shall be sent to: Shelby Drake, City of Bloomington, 401 N. Morton, Suite 250, Bloomington, Indiana 47404. Invoices may be sent via first class mail postage prepaid or via email. Payment will be remitted to Contractor within forty-five (45) days of receipt of invoice. Additional services not set forth in Article 1, or changes in the Services must be authorized in writing by the Department or its designated project coordinator prior to such work being performed, or expenses incurred. The Department shall not make payment for any unauthorized work or expenses.

Article 5. <u>Appropriation of Funds</u>. Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of this Agreement by the Department are at any time not forthcoming or are insufficient, through failure of any entity, including the Department itself, to appropriate funds or otherwise, then the Department shall have the right to terminate this Agreement without penalty.

Article 6. <u>Schedule</u>. Contractor shall perform the Services according to the following schedule:

Saturday, November 11, 2023 from 8:00-11:00am

The time limits established by this schedule shall not be exceeded, except for reasonable cause as mutually agreed by the parties.

Article 7. <u>Termination</u>. In the event of a party's substantial failure to perform in accordance with the terms of this Agreement, the other party shall have the right to terminate the Agreement upon written notice. The nonperforming party shall have fourteen (14) calendar days from the receipt of the termination notice to cure or to submit a plan for cure acceptable to the other party. Additionally, the Department may terminate or suspend performance of this Agreement at the Department's prerogative at any time upon written notice to Contractor. Contractor shall terminate or suspend performance of the Services on a schedule acceptable to the Department shall pay the Contractor for all the Services performed up to the date that written notice is received, plus reasonable termination or suspension expenses. Upon restart, an equitable adjustment shall be made to Contractor's compensation and the schedule of services. Upon termination or suspension of this Agreement, all finished or unfinished reports, drawings, collections of data and other documents generated by Contractor in connection with this Agreement shall become the property of the Department, as set forth in Article 9 herein.

The Parties understand and agree that due to the ongoing COVID-19 pandemic, there may be limitations and restrictions enacted that will affect the ability of the Parties to perform as required under this Agreement. The Parties agree that, in the event a limitation or restriction is enacted which prevents performance of the terms of the Agreement, Parks may terminate the Agreement in its sole discretion if it determines that there is no reasonable alternative means of performance under the Agreement. Parks shall notify Contractor of any such termination and the reasons therefor in writing.

Article 8. <u>Identity of the Contractor</u>. Contractor acknowledges that one of the primary reasons for its selection by the Department to perform the Services is the qualifications and experience of Contractor. Contractor thus agrees that the Services to be performed pursuant to this Agreement shall be performed by Contractor. Contractor shall not subcontract any part of the Services without the prior written permission of the Department. The Department reserves the right to reject any of the Contractor's personnel or proposed outside professional sub-Contractors, and the Department reserves the right to request that acceptable replacement personnel be assigned to the project.

Article 9. <u>Ownership of Documents and Intellectual Property</u>. All documents, drawings and specifications, including digital format files, prepared by Contractor and furnished to the Department as part of the Services shall become the property of the Department. Contractor shall retain its ownership rights in its design, drawing details, specifications, databases, computer software and other proprietary property. Intellectual property developed, utilized or modified in the performance of the Services shall remain the property of Contractor.

Article 10. <u>Independent Contractor Status</u>. During the entire term of this Agreement, Contractor shall be an independent contractor, and in no event shall any of its personnel, agents or sub-contractors be construed to be, or represent themselves to be, employees of the Department. Contractor shall be solely responsible for the payment and reporting of all employee and employer taxes, including social security, unemployment, and any other federal, state, or local taxes required to be withheld from employees or payable on behalf of employees.

Article 11. <u>Indemnification</u>. Contractor shall defend, indemnify, and hold harmless the City of Bloomington, the Department, and the officers, agents and employees of the City and the Department from any and all claims, demands, damages, costs, expenses or other liability arising out of the Agreement or occasioned by the reckless or negligent performance of any provision thereof, including, but not limited to, any reckless or negligent act or failure to act or any misconduct on the part of the Contractor or its agents or employees, or any independent contractors directly responsible to it (collectively "Claims"). If Contractor is a design professional, architect, landscape architect, surveyor, engineer, geologist, or geotechnical / environmental consultant contracting to provide professional services, then Contractor shall not have the duty to defend against a professional liability claim or indemnify against liability other than liability for damages and losses arising out of third-party claims to the extent the damages and losses are caused by Contractor's willful misconduct or negligence.

Article 12. <u>Insurance</u>. During the performance of any and all Services under this Agreement, Contractor shall maintain the following insurance in full force and effect: a) General Liability Insurance, with a minimum combined single limit of \$1,000,000 for each occurrence and \$2,000,000 in the aggregate; b) Automobile Liability Insurance, with a minimum combined single limit of \$1,000,000 for each person and \$1,000,000 for each accident; c) Workers' Compensation Insurance in accordance with the statutory requirements of Title 22 of the Indiana Code; and d) Professional Liability

Insurance ("Errors and Omissions Insurance") with a minimum limit of \$1,000,000 annual aggregate. All insurance policies shall be issued by an insurance company authorized to issue such insurance in the State of Indiana. The City of Bloomington, the Department, and the officers, employees and agents of each shall be named as insureds under the General Liability, Automobile, and Worker's Compensation policies, and such policies shall stipulate that the insurance will operate as primary insurance and that no other insurance of the City's will be called upon to contribute to a loss hereunder. Contractor shall provide evidence of each insurance policy to the Department prior to the commencement of work under this Agreement.

Article 13. <u>Conflict of Interest</u>. Contractor declares that it has no present interest, nor shall it acquire any interest, direct or indirect, which would conflict with the performance of Services under this Agreement. Contractor agrees that no person having any such interest shall be employed in the performance of this Agreement.

Article 14. <u>Waiver</u>. No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

Article 15. <u>Severability</u>. The invalidity, illegality or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of the Agreement shall be construed and enforced as if it did not contain the particular provision to be held void. The parties further agree to amend this Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this Article shall not prevent this entire Agreement from being void should a provision which is of the essence of this Agreement be determined void.

Article 16. <u>Assignment</u>. Neither the Department nor the Contractor shall assign any rights or duties under this Agreement without the prior written consent of the other party. Unless otherwise stated in the written consent to an assignment, no assignment will release or discharge the assignor from any obligation under this Agreement.

Article 17. Third Party Rights. Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the parties.

Article 18. <u>Governing Law and Venue</u>. This Agreement shall be governed by the laws of the State of Indiana. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

Article 19. <u>Non-Discrimination</u>. Contractor shall comply with City of Bloomington Ordinance 2.21.020 and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment.

Contractor understands that the City of Bloomington prohibits its employees from engaging in harassing or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If Contractor believes that a City employee engaged in such conduct towards Contractor and/or any of its employees, Contractor or its employees may file a complaint with the City department head in charge of the Contractor's work, and/or with the City human resources department or the Bloomington Human Rights Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct.

Article 20. <u>Compliance with Laws.</u> In performing the Services under this Agreement, Contractor shall comply with any and all applicable federal, state and local statutes, ordinances, plans and regulations, including any and all regulations for protection of the environment. Where such statutes, ordinances, plans or regulations of any public authority having any jurisdiction over the project are in conflict, Contractor shall proceed using its best judgment only after attempting to resolve any such conflict between such governmental agencies, and shall notify the Department in a timely manner of the conflict, attempts of resolution, and planned course of action.

Article 21. <u>E-Verify</u>. Contractor is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Exhibit A, affirming that Contractor does not knowingly employ an unauthorized alien. Contractor shall require any subcontractors performing work under this contract to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

Article 22. Notices. Any notice required by this Agreement shall be made in writing to the individuals/addresses specified below:

Nothing contained in this Article shall be construed to restrict the transmission of routine communications between representatives of the Department and Contractor.

Article 23. <u>Integration and Modification</u>. This Agreement, including all Exhibits incorporated by reference, represents the entire and integrated agreement between the Department and the Contractor. It supersedes all prior and contemporaneous communications, representations and agreements, whether oral or written, relating to the subject matter of this Agreement. This Agreement may be modified only by a written amendment signed by both parties hereto.

Article 24. <u>Non-Collusion</u>. Contractor is required to certify that it has not, nor has any other member, representative, or agent of Contractor, entered into any combination, collusion, or agreement with any person relative to the price to be offered by any person nor prevented any person from making an offer nor induced anyone to refrain from making an offer and that this offer is made without reference to any other offer. Contractor shall sign an affidavit, attached hereto as Exhibit B, affirming that Contractor has not engaged in any collusive conduct. Exhibit B is attached hereto and incorporated by reference as though fully set forth.

This Second Extension of Lease Agreement ("Second Extension"), entered into this _____ day of _____, 2023, by and between the City of Bloomington Parks and Recreation Department and The Project School.

Witnesseth:

Whereas, the City of Bloomington Department of Parks and Recreation, by its Board of Parks Commissioners ("Landlord") and The Project School ("Tenant") first entered into a lease ("Original Lease") for the property located at 349 S. Walnut, Bloomington, Indiana beginning on April 21, 2009; and

Whereas, the initial term of the Original Lease began on April 21, 2009 and ended on June 30, 2019; and

Whereas, the Original Lease provided the opportunity to extend the initial term by two additional five-year terms; and this was later modified to allow for additional terms in the Second Amendment to the Lease Agreement; and

Whereas, the parties agreed to Amendment Number 3 to the Original Lease on October 11, 2010, providing that the rental amounts for the first and second extended terms would be \$88,125.00 annually, plus the lesser amount of the consumer price index or two percent, adjusted annually;

Whereas, the parties agreed to extend the Original Lease, as amended, by one additional five-year term, beginning on July 1, 2019, and ending on June 30, 2024; and

Whereas, in compliance with Amendment Number 3, the annual rental amount was adjusted annually during the first five-year extension; and

Whereas, the parties wish to extend the Original Lease, as amended, by a second fiveyear term, beginning on July 1, 2024, and ending on June 30, 2029; and

Whereas, the rental amount shall continue to be adjusted annually in compliance with Amendment Number 3.

Now, therefore, in consideration of the premises, the mutual representations, warranties, covenants and undertakings contained in the Original Lease, as amended, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree to extend the Original Lease, as amended, as follows:

1. Term: The extended term shall begin on July 1, 2024, and will end on June 30, 2029.

2. Future Rent Adjustments: The annual rent during the last year of the 2019-2024 lease extension was \$95,297.51. The rent under this second lease extension will be increased annually, by the lesser amount of two percent (2%) or the consumer price index for the preceding twelve months. Parties agree that a negative CPI shall not be applied to annual rent and in no event shall rent decrease from year to year.

3. Article V, Section 5.2: Article V, Section 5.2 of the Original Lease is repealed and replaced with the following language:

Subject to Section 9.3 of this Lease, all maintenance, repairs, or replacements relating to the Premises that are not the obligation of the Landlord, including maintenance, repair, and replacement of the roof and HVAC system for the Premises, shall be the obligation of the Tenant and shall be made by Tenant at Tenant's sole cost and expense, and Tenant shall maintain the Premises in a manner commensurate with a first class school building in the Bloomington, Indiana area. The covenants of repair herein by Tenant shall be subject to any warranties of contractors given in connection with Tenant's build out of the Premises.

If an event occurs damaging the HVAC or Roof that is covered by Landlord's insurance, then Landlord shall seek insurance coverage for those costs and Tenant shall reimburse Landlord for any out of pocket expenses Landlord incurs as a result.

4. Article IX, Section 9.2: Article IX, Section 9.2 of the Original Lease is repealed and replaced with the following language:

Tenant shall cause its insurer(s) to furnish to Landlord certificates evidencing the insurance required to be maintained hereunder and stating that no policy change or cancellation will be made without giving thirty (30) days notice to Landlord or Landlord's designee.

Tenant agrees that any contractors selected by Tenant to perform the Tenant Improvements to the Building shall be fully licensed, to the extent required by state or county or local law or ordinance, and bonded in the State of Indiana and shall provide evidence of same to Landlord. Tenant shall be solely responsible for securing a policy or policies providing coverage for damage or loss of Tenant's personal property, equipment, trade fixtures, or furniture. Notwithstanding any provision contained herein to the contrary, any proceeds of insurance maintained by Tenant for damage to the contents owned by Tenant within the Premises shall be and remain the sole property of Tenant.

At all times during the lease term, Tenant shall maintain in force and effect, at its own cost and expense, a policy or policies of

liability insurance for the protection, indemnification, and defense of Tenant (with Landlord listed as an additional insured) against claims, demands, and causes of action arising out of or in connection with the use, maintenance, operation, and occupancy of the Premises. Tenant's policy or policies shall act as a primary noncontributing insurance and shall have limits of not less than Two Million Dollars (\$2,000,000.00) for injuries (including death) to one person, Five Million Dollars (\$5,000,000.00) for injuries (including death) to more than one person in one accident, and Two Million Dollars (\$2,000,000.00) for damages to property in one accident.

All other terms of the Original Lease, as amended by Amendments Number 1, dated June, 2009; Number 2, dated August, 2009 and Number 3, dated October 11, 2010, remain in effect.

Why We Exist

We equitably enrich community well-being by providing quality parks, trails, facilities, programs and services, and through the stewardship of natural spaces.

Background

The Parks and Recreation Department manages 2,300 acres of property including 34 parks and 38 miles of trails, 28 playgrounds, 2 municipal pools, spray pad, 27-hole golf course, 3 community centers, ice arena, 2 cemeteries, 3 outdoor fitness stations, 2 dog parks, 8 pickle ball courts19 tennis courts, 17 outdoor basketball courts, 6 indoor basketball courts,1 indoor turf soccer field, 16 ballfields, 2 skate parks, 20,481 public trees, nature preserve and lake. In 2022, direct participants counted through program registrations include 2,040 youth, 739 adults and 363 senior adults. Further breakdown of program registrations include: Female - 1,470; Male - 1,519; Other or Prefer Not to Say – 21. This is a 38% increase from 2021 program registrations. The department is staffed by 62 full-time employees, comprising 22 union and 40 non-union employees. An additional 351 seasonal staff were employed by the department in 2022, earning hourly pay rates of \$15.29 - \$17.23, an increase schedule initiated in 2018.

National Accomplishments - National Recreation and Park Association (NRPA)

The Bloomington Parks and Recreation Department was re-accredited in June, 2021, for another five years. The department met every single one of the 154 standards of operations for the first time in our history. Accreditation is awarded by the National Recreation and Park Association

Commission for Accreditation of Park and Recreation Agencies 2001. The department is currently one of 166 accredited departments across the country.

The department was honored to win the 2018 National Recreation and Park Association National Gold Medal Award for Class III (population 75,000–150,000). The Gold Medal Award honors one community of its size in the country that demonstrates excellence in long-range planning, resource management and innovative approaches to delivering superb park and recreation services with fiscally sound business practices. The department is eligible to apply for a 3rd Gold Medal Award in 2024.

5 Year Master Plan 2021-2025

The department is in year three of its five-year Master Plan. The department has long used the master planning process to set priorities in meeting the community's needs for parks, recreation and open spaces. A five-year master plan is a requirement to receive grant funds from the Indiana Department of Natural Resources and for NRPA accreditation.

Four Master Plan goals guide budget goals with associated strategies:

- Maintain and enhance the assets and natural resources of the Department
 - The Operations Division is responsible for maintaining roughly \$82 million dollars in assets the department oversees. The work is initiated and tracked through the five year Capital Development Plan. This plan allows staff to identify funding sources, life cycles and maintenance schedules. While major capital projects can take center stage, day to day trail, park and facility maintenance are vital to the visitor experience and department reputation for high standards of operation.
- Reinforce activities and programs to positively impact public health, sustainability and climate action
 - The department's work on climate action and sustainability is guided by the City's Climate Action Plan. The department is committed to action in order to impact climate change where possible on park properties. Projects, programs and initiatives accomplished by the Parks department include increasing green infrastructure capacities; access to healthy local food; manage 258 community garden plots and 52 raised beds at three locations; natural resources education programs at Griffy Nature Preserve and Leonard Springs Nature Park; hosted 178 "Weed Wrangler" events with community volunteers; diverting green yard waste from landfills to city-owned green yard waste composting site; installation of energy efficient LED's; facilitating 69 volunteers contributing 858 hours to the Adopt-A-Stream, Adopt-A-Trail and Adopt-A-Acre programs; solar panels on park properties; electric vehicles and charging stations.
- Prioritize diversity, equity and inclusion
 - Community Events implemented the International Festival promoting cultural awareness, encouraging cross-cultural engagement and celebrating the diverse

cultures represented in the community; annual staff retreat education topic was "Inclusive Leadership" addressing inclusive language, gender-identity-sexual expression and macroaggressions; All Kids Swim provides swimsuits, towels, backpacks and goggles for Banneker summer program participants; and the Bloomington Parks Foundation Scholarship application is now available as a google doc online in addition to in person submission; capital project to increase accessibility include the Lower Cascades accessible trail through the park to the waterfall; accessible .3 mile pathway along Griffy Lake includes five fishing access points and connects users to the north and south shore hiking trails; accessible cameo and kayak launching fishing pier.

- Develop administrative and staffing capacity
 - Completed Organizational Assessment study with Raftelis resulting in 16 recommendations addressing programming support, customer service, park and facility maintenance and employee relations/administrative support. The study was completed in March 2023 with several recommendations in progress or reflected in the 2024 budget request.

The department's Strategic Action Plan (SAP) details annual budget goals, tracking status and due dates. In 2022 the department established 72 goals, accomplished 36; substantially accomplished 16, did not meet 19 and 1 not met due to COVID. The SAP is presented to the Board of Park Commissioners annually.

Department staff work together in teams to identify efficiencies and meet the community demand for programs and services. This work is strategically done in five actions teams:

- Staff Morale
 - Monthly staff newsletter; staff gatherings, and morale booster activities
- Process Improvement
 - Department resource list
 - RecTrac training
- Employment
 - Seasonal employees all on Time Trac
 - Consolating hiring paperwork
- Sustainability and Climate Action
 - Purchased \$52K in battery operated equipment including three mowers, blowers, pressure washer
 - Purchase of three electric vehicles
- Public Interfacing
 - Social media and digital content
 - Website organization and management
 - Accessible meeting documents

Non-Reverting Budget

The Department non-reverting fund serves as an enterprise fund, allowing maximum flexibility for the Department to offer services in response to trends and customer demand while minimizing reliance on the general fund tax base.

The Parks and Recreation Non-Reverting fund budget and program unit structure reflects ongoing changes in service provision and true cost allocations by activity and program unit. A bottom-up process has incorporated input from staff specialists, supervisors, managers and division directors. The Non-Reverting fund is reviewed, approved and managed by the Board of Park Commissioners.

Each program unit has a set cost recovery goal established by the Board of Park Commissioners. Program and service fees are set using a Pricing & Cost Recovery Pyramid. Program units with noto low-cost recovery goals typically generate the most community benefit and rely most heavily on the general fund. Program units with higher cost recovery goals typically rely more on the nonreverting fund as they more generally benefit individuals.

Bicentennial Projects

Bicentennial projects began in 2018, and the current projects in progress include the Miller-Showers Gateway with design complete and work scheduled to begin in early September. The project will include a 40-foot monolith with color LED's, native trees and plants complete with limestone blocks. A second gateway location will be identified upon the completion of the Miller-Showers Gateway. Urban Forestry continues to make progress with Bicentennial tree planting with 270 trees planted in 2022, 140 trees planted in Q2 2023, and 90 downtown trees scheduled for fall planting in Q4. The Griffy Loop Trail South is under construction with completion by the end of 2023. This 4-mile trail will connect with the Griffy Dam Crossing Trail, also currently under construction. The final phase of the Griffy Loop Trail will be on the north side of the lake and scheduled for completion in 2024. The Power Line Trail will run along Duke's power lines east - west with a trailhead on Rogers Street across from the Switchyard Park. Design has been delayed but will start up again once easement approval is received from the County Commissioners. Completion of this trail project has been delayed to at least 2025 due to Duke's reliability project, pandemic impact, and the now delayed easement approval.

7.0 Termination:

- **7.1.** Termination by mutual agreement: The partners may terminate this Agreement prior to December 31, 2023 by mutual written agreement only.
- **7.2.** Unilateral termination: In the event that one of the partners to this Agreement breaches any of its terms and conditions, the non-breaching party shall serve written notice of the breach to the other party by certified mail. The breaching party shall then have ten (10) days from the date of mailing in which to cure the breach. If the breaching party fails to cure the breach within ten (10) days, the non-breaching party may, at its option and in writing, unilaterally terminate the Agreement.

8.0 Waiver

No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the other party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

9.0 Release and Hold Harmless Agreement:

Lisa Greathouse, including its representatives, agents, and assigns, does hereby agree to release, hold harmless, and indemnify the City of Bloomington, its Parks and Recreation Department, and any and all employees, agents, and assigns from any and all claims, causes of action, suits, proceedings, or demands, including but not limited to claims involving personal injury or death, which may arise from this Agreement, even if caused by the negligence of releasees.

10.0 E-Verify

Lisa Greathouse is required to enroll in and verify the work eligibility status of all newlyhired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Lisa Greathouse shall sign an affidavit, attached as Exhibit A, affirming that Lisa Greathouse does not knowingly employ an unauthorized alien. Lisa Greathouse shall require any subcontractors performing work under this contract to certify to Lisa Greathouse that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Lisa Greathouse shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

11.0 <u>Non-Discrimination</u>

Lisa Greathouse shall comply with City of Bloomington Ordinance 2.21.020 and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment. Lisa Greathouse understands that the City of Bloomington prohibits its employees from engaging in harassing or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If Lisa Greathouse believes that a City employee engaged in such conduct towards Lisa Greathouse and/or any of its employees, Lisa Greathouse or its employees may file a complaint with the City department head in charge of the Lisa Greathouse work, and/or with the City human resources department or the Bloomington Human Rights Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct.

12.0 <u>E-Verify</u>

Lisa Greathouse is required to enroll in and verify the work eligibility status of all newly-hired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists).

Lisa Greathouse shall sign an affidavit, attached as Exhibit C, affirming that Lisa Greathouse does not knowingly employ an unauthorized alien. "Unauthorized alien" is defined at 8 U.S. Code 1324a(h)(3) as a person who is not a U.S. citizen or U.S. national and is not lawfully admitted for permanent residence or authorized to work in the U.S. under 8 U.S. Code chapter 12 or by the U.S. Attorney General.

Lisa Greathouse and any subcontractors may not knowingly employ or contract with an unauthorized alien, or retain an employee or contract with a person that the Lisa Greathouse or subcontractor subsequently learns is an unauthorized alien. If the City obtains information that the Lisa Greathouse or subcontractor employs or retains an employee who is an unauthorized alien, the City shall notify the Lisa Greathouse or subcontractor of the contract violation and require that the violation be remedied within 30 days of the date of notice. If the Lisa Greathouse or subcontractor verified the work eligibility status of the employee in question through the E-Verify program, there is a rebuttable presumption that the Lisa Greathouse or subcontractor did not knowingly employ an unauthorized alien. If the Lisa Greathouse or subcontractor fails to remedy the violation within the 30 day period, the City shall terminate the contract, unless the City Commission or department that entered into the contract determines that terminating the contract would be detrimental to the public interest or public property, in which case the City may allow the contract to remain in effect until the City procures a new Contractor. If the City terminates the contract, the Lisa Greathouse or subcontractor is liable to the City for actual damages.

Lisa Greathouse shall require any subcontractors performing work under this contract to certify to the Lisa Greathouse that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Lisa Greathouse shall maintain

on file all subcontractors' certifications throughout the term of the contract with the City.

13.0 <u>Non-Collusion</u>

Lisa Greathouse is required to certify that it has not, nor has any other member, representative, or agent of the firm, company, corporation or partnership represented by them, entered into any combination, collusion or agreement with any person relative to the price to be offered by any person nor to prevent any person from making an offer nor to induced anyone to refrain from making an offer and that this offer is made without reference to any other offer. Lisa Greathouse shall sign and affidavit, attached hereto as Exhibit B, affirming that Lisa Greathouse has not engaged in any collusive conduct. Exhibit B is attached hereto and incorporated by reference as through fully set forth.

The City of Bloomington would like to see a maintenance of traffic plan created that follows the guidelines below. Some substitutions may be approved on submission of MOT plan. MOT plan does not need to be submitted with bid.

Temporary Crossings - establish two temporary pedestrian crossings using pavement marking tape (shown as yellow lines on this map)

Pedestrian Crossing signs (4) - include one MUTCD-compliant Ped Crossing sign on each side of the temporary crossings. Provide some type of compliant flashing light with each sign for pedestrian safety.

Between temporary crossings, place 4-5 orange barrels along north and south curbs of Grimes to narrow lines and slow traffic.

Place 2 "Pedestrian Crossing Ahead" style MUTCD-compliant signs on the east and west sides of the project limits on Grimes Lane.

Place MUTCD bike and ped directional detour signs along detour route (green) as needed - "Detour Ahead" signs shown, but directional signs not specifically shown on this map.

Orange barrels restrict lane width on entry to Switchyard Park to give detour users ability to take eastbound curb ramp to temporary crosswalk.
