- 1. Call to Order/Welcome
- 2. BAC Minutes/Financials
 - Gerard moves to approve. Natalie seconded. Approved.
 - All funds for Projects and Operations grants have been sent to recipients. \$32,709 remaining from initial allocation for grants. Holly was able to reallocate some other funds which were unlikely to be used this year, bringing the total to \$50k for Emerging Artist grants (\$5k earmarked for professional development grants, \$3,500 public art, \$8,791from other 2023 arts funds).
- 3. Staff update Holly
 - Following yesterday's election, the new mayor and council members are now set. Holly reached out to Kerry Thomson today to discuss what the BAC does and the needs of the local arts community. Her transition committee has commissioner email addresses and may be in contact with us.
 - City has temporarily paused the Gateway project (aka the Monolith). Not entirely clear what the means wrt next steps, but it's possible the BAC will be consulted for further feedback.
 - A few commissioners' terms will expire at the end of Jan 2024. For those eligible for a 2nd term, you're encouraged to re-apply. If you have any recommendations for new commissioners, please flag with Holly and Gerard.
- 4. Update: Public Art Natalie Almanza, chair
 - Since the Public Art Master Plan went public, the site has seen some engagement with the micro grants info, but no applications yet. These are rolling grants, so no strict timeline for review.
 - The National Science Foundation mural near Wonderlab is being installed now by artist Erin Tobey. Tentative dedication on Dec 3.
 - The design for the Duke substation mural is close to finalized.
 - Engineering has talked to Holly about the Hopewell phase 1 public art integration. Based on that, we'll be writing a draft for an artist call soon.
 - Next meeting will be rescheduled from this Friday Nov 10 (Veteran's Day), hopefully for next week.
- 5. Update: Grants Elliot Josephine Leila, chair
 - Emerging Artist grant reviews were completed this weekend. Thanks to those who

participated. Tomorrow a group will meet to finalize a funding proposal, which will be discussed and voted on in the next Grants meeting Friday Nov 17. Lots of good feedback on how we can tweak the process to refine it for next year.
