There is one item ready for final action and no items ready for introduction at the Regular Session next week. The one item ready for final action is included in this packet and summarized herein.

Motion to Cancel Committee of the Whole in Order

Given the lack of legislation ready to be discussed at the Committee of the Whole scheduled for February 11th, the Council should consider a motion to cancel it. Since the agenda makes note of the possible motion, it will not be necessary to suspend the rules in order to consider a motion to cancel the meeting.

Final Actions

Item One – <u>Res 09-02</u> - Waiving Payments in Lieu of Taxation (PILOT) from the Bloomington Housing Authority to the City

<u>Res 09-02</u> is an annual resolution requested by the Bloomington Housing Authority which waives any payment in lieu of taxes (PILOT) we might require of them. I.C. 36-7-18-25 exempts housing authorities from the payment of property taxes, but allows these authorities to enter into agreements with political subdivisions to pay a PILOT for the estimated cost of services, improvements, and facilities that are provided by the political subdivisions. In the early 1960s, the Housing Authority agreed to pay the City a PILOT. After acknowledging the services performed by the Housing Authority that might have been provided by the City, and acknowledging the benefits we received from its other services, the resolution waives this obligation. Jennifer Osterholt has submitted a *memo*, which explains the history of the PILOT obligation, and a *payment calculation sheet*, which is a HUD form used to estimate the \$8,623.20 that the Housing Authority would otherwise pay the City for services it received during the fiscal year running from October 1, 2007 to September 30, 2008. She will be present on February 4th to explain and support the resolution.

RESOLUTION 09-02

WAIVING CURRENT PAYMENTS IN LIEU OF TAXES BY THE BLOOMINGTON HOUSING AUTHORITY TO THE CITY

- WHEREAS, the Bloomington Housing Authority provides a public service to the Bloomington community by providing sanitary, safe and affordable housing for low income people; and
- WHEREAS, the Bloomington Housing Authority also provides services to its residents which, if not so provided, would be provided by the City of Bloomington at additional expense to the City; and
- WHEREAS, according to I.C. 36-7-18-25, the Bloomington Housing Authority is exempt from all property taxes, but may enter into an agreement with a political subdivision to pay no more than the estimated costs of services, improvements, or facilities provided by that political subdivision; and
- WHEREAS, on May 2, 1961, the Bloomington Housing Authority and City of Bloomington entered into a Cooperation Agreement under which the Bloomington Housing Authority agreed to make annual payments in lieu of taxation based upon the value of services established by Housing and Urban Development guidelines; and
- WHEREAS, the City of Bloomington does not desire for the Bloomington Housing Authority to make these payments in lieu of taxes this year;

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE COMMON COUNCIL OF THE CITY OF BLOOMINGTON, MONROE COUNTY, INDIANA, THAT:

SECTION I. In consideration for the provision of services to its residents and property by the Bloomington Housing Authority, the City of Bloomington hereby waives its right to any and all payments in lieu of taxes for the year 2008.

The Housing Authority of the City of Bloomington entered into a Cooperation Agreement with the City of Bloomington, Indiana on May 2, 1961 as allowed by the Department of Housing and Urban Development.

The Cooperation Agreement states "Under the constitution and statutes of the State of Indiana, all Projects are exempt from all real and personal property taxes levied or imposed by the Taxing Body, as long as the projects continue to serve low income citizens this rule applies". The Authority also agreed to pay, as do most housing authorities, a Payment in Lieu to Taxes, following HUD's guidelines, which set forth how that calculation is to be done. Indiana State Statute does allow for the Common Council to forgive the PILOT.

I have attached a copy of our PILOT computation.

Following HUD's prescribed formula the Housing Authority of the City of Bloomington is requesting the Bloomington Common Council to forgive the PILOT for fiscal year ending September 30, 2008.

In the Council Chambers of the Showers City Hall on Wednesday, January 7, 2009 at 7:30 pm with Council President Susan Sandberg presiding over the Organizational Session of the Common Council.

Council President Sandberg gave the Agenda Summation

There were no minutes to approve at this meeting.

Isabel Piedmont-Smith wished everyone a Happy New Year and said her positive outlook for the year was dampened because of a shooting near the bus depot on 4th Street. She extended her condolences to the victim and police who were involved, adding that she hoped for the best outcome for this serious incident.

Piedmont-Smith noted that there is no such thing as clean coal. She said that on December 22, 2008 in Tennessee a pond that was holding coal ash sludge sprung a leak and more than 1 billion gallons of sludge were released from a Tennessee Valley Authority coal plant. She said that this covered nearly 300 acres of rural community and has contaminated water in the area. She noted that a side of coal use that we don't see, is an implication for the wet sludge retention pond in which the company could have converted from wet sludge to dry sludge, which is more easily contained. She said the clean up costs, and costs of health issues involving this spill will be much more than the cost would have been for using safer methods of drying the sludge. She noted the implications for the long term well-being of our society, and hoped that regulators on the state and national levels would take a cue to invest in alternative energy sources rather than building more coal plants.

Andy Ruff wished a Happy New Year to all and hoped that 2009 would bring about a lot of positive changes in this country and in people's lives around the world.

Tim Mayer wished all a Happy New Year.

Chris Sturbaum said his happy thoughts were the prospect of President Obama, and that as he came to the meeting tonight the Hoosiers were winning.

Steve Volan wished all a Happy New Year, and said as parliamentarian he had been very interested in rules of the council, and referred to the report from last year's Rules Committee. He said that the council needed to keep rules of formality, addressing comments to the chair, and using title and surname for people addressing the council. He said the point of these rules was to restrict people or to be formal, but to treat everyone with the courtesy and respect that they deserve. He said that at the outset of 2009 he would like to reaffirm this idea and asked that his colleagues join him in upholding the standards of this forum for the benefit of public discourse.

President Susan Sandberg said that this was a good time to put a spotlight on the accomplishments of the past year as we look to the future and delivered the following statement:

2008 has been an exciting year because of the historic presidential election with record voter turnout here in Bloomington. All American cities face challenges in 2009 and we will have our share. perspective, and that we must do. Last year we were asked to dig deep into community resources as the news broke of the future closing of GE. The GE Task Force continues its work toward meaningful responses to this bad economic news. We've experienced plant closure before, and we are poised to do our best in the wake of yet another.

Also on the horizon are changes in the future of Bloomington Hospital. The City of Bloomington will remain vigilant and active in offering solutions to ensure that Bloomington Hospital thrives and yet remains a major resource for the citizens of Bloomington who rely on its commitment to a healthy community.

We've forged new partnerships for economic development in both technical and life science arenas and we expect to do more. In both social services and the arts, opportunities are ripe to lead with our strengths and create more jobs to meet changing needs in a new economy. The emerging B-Line trail and all the activity and commerce it will bring remind us of our potential for manageable growth. Its development represents a vibrant City with a heart for people and the political will to be the best we can be with respect to environmental concerns and a sustainable quality of life.

We welcome future opportunities to partner with our colleagues in Monroe County to look for efficiencies in government and areas for city/county collaborations in meeting constituent needs. The strong educational institutions of Indiana University and Ivy Tech are fundamental to the ongoing success of Bloomington, and it is our privilege to partner with them in solving community problems and identifying shared strengths and resources.

With this as our framework, 2009 will bring more opportunity for economic development and effective public policy. In the context of economic adversity, we'll do what we must to tighten our belts, hunker down, and reach out to one another for ideas and support. I'm optimistic, because this is Bloomington, a very special place with generous citizens and dedicated community leaders. By necessity we will need to carefully analyze resources and future needs in order to prioritize our agenda. That requires us all to be good listeners to hear all voices in our community and heed the advice of professionals as we approve legislation and craft public policy to shape the future of Bloomington.

On New Year's Day as we observed our County colleagues taking their oaths of public office, we were reminded of our own promise to uphold the Constitutions of the United States and the State of Indiana. As council members we serve Bloomington to the best of our skills and abilities, and we've accomplished much in this past year. There have been a number of legislative highlights in addition to the basic budget oversight that keeps Bloomington ahead of the curve.

And here's a review of the best of 2008:

The Council and Mayor worked together to adopt a budget for 2009 that looked ahead to the needs of the City in the coming year while recognizing fiscal restraints. Soon we'll meet with the administration to discuss our budget priorities for 2010.

With respect to Council administration, we instituted a Rules Committee to improve meeting procedures and travel policy.

The Council Sidewalks Committee deliberated with City staff in their recommendations for infrastructure improvements.

Promoting economic development we authorized expenditures from the Indiana Development Fund for Cook Pharmica, IEC, LLC, and Predictive Physiology & Medicine. We approved the annual tax abatement report.

To improve social services delivery and alleviate poverty we approved bonds for renovation of Henderson Courts Apartments and waived payment in lieu of taxes for the Housing Authority. Allocations were approved for Community Development Block Grants and the Jack Hopkins Social Service Funds. As community need grows, so does our commitment to increase funding for social safety nets.

In planning and zoning, we amended the Woolery Farm Parcel G and Clarizz PUDs. We amended the Growth Policies Plan to adopt a new bicycle and pedestrian transportation and greenways systems plan. Planning meetings have been underway to evaluate the Unified Development Ordinance.

Outgoing President's Report (cont'd)

In the public interest, the City of Bloomington vacated right of ways to support Fairview School, Cook Pharmica and Indiana University.

To support neighborhoods and historic preservation, we established the Prospect Hill Historic District and approved the Preserve America Designation.

With great respect for the work of our award-winning Parks and Recreation Department, we approved acquisition of land for the Cascades Park Budget.

To improve traffic and public safety we passed the Omnibus Traffic Ordinance and the Fire Prevention Code. Seeing results from past legislation, we welcomed the opening of the new small arms training facility in support of the Bloomington Police Department and other first responders.

In regard to interlocal cooperation, we approved the animal care and control agreement with Monroe County and Ellettsville.

We amended the enabling legislation for the Bloomington Commission on Sustainability with respect to residency requirements and voting status of its members. We reenacted the Tree Ordinance and amended legislation for the Tree Commission. We were pleased to expand the membership of the Commission on the Status of Women, and extend the Peak Oil Task Force. This year we established the Economic and Sustainable Development Department.

The Bloomington Entertainment and Arts District continued to grow with the emergence of new public art projects. Colorful building murals are starting to appear along with artwork on downtown stoplight utility boxes. Along the B-Line we welcome the whimsical metal sculpture, Animal Island, created by the artists of Stone Belt. We were pleased with the announcement of a new limestone sculpture by Dale Enochs called Bloomington Banquet that will soon grace the Showers Plaza along the B-Line. The new bridge above 3rd Street is a sleek and attractive addition to the city landscape. The Bloomington Community Arts Council will continue to expand their "**art**nerships" through grants for local arts nonprofits and downtown commercial entities.

In regard to broader statements on state and national affairs, the majority of Council opposed logging in the backcountry of Morgan Monroe and Yellowwood State Forests. We signed a resolution in support of diplomatic solutions to conflict in Iran. While our main focus is on the daily business of Bloomington, we can't ignore the conditions around us that impact local citizens. We always welcome public comment and are pleased to offer our regular meetings as community forums for citizen input.

I'm proud of our collective commitment to local public service in the midst of a changing America. It has been my privilege to preside, and a greater honor to serve as an at-large representative and advocate for Bloomington. I end my year as President with a personal pledge to be a better listener in the coming year. I encourage my fellow council members to continue working with constituents, petitioners, city staff, and each other in an environment of mutual respect and civility.

I conclude with a heartfelt thank you to my council colleagues... our highly professional council staff, Attorney Dan Sherman and Stacy Jane Rhoads... our collegial City Clerk, Regina Moore... the Honorable Mayor Mark Kruzan and his capable administration, for all their hard work and vigilance on behalf of Bloomington. And let's thank the broadcast crew in the back room from Community Access Television Services who diligently cover public meetings from gavel to gavel, to the bitter end. If you would please join me in a round of applause for the professionals of CATS......

Happy New Year all!

Mayor Mark Kruzan said it was important for the council, Board of Public Safety and members of the public to hear that the police department will be issuing a report about the shooting near the bus station that occurred today. He said that based on the original 911 call, the officer statements, and eyewitness accounts, the Bloomington Police Department responded professionally to the incident to protect citizens in the area as well as their own safety in the face of an armed assailant. He said the site was secured and an internal investigation begun.

Outgoing President's Report (cont'd)

He said that the findings would be reviewed by the citizen members of the Board of Public Safety. He said he appreciated the job that all the public safety officials do every day, as they often put themselves at risk to protect the rest of us. He said he was sorry that an officer was put in the position where he had to act in the manner which occurred today, and added that the officers were sorry about that too. He said to be careful about the use of the term "victim" in this circumstance. He added that more information would be forthcoming about the entire incident.

He thanked the street department crews for their work, and added that the same folks who were in charge of paving and patching potholes were the same folks who were in charge of cleaning up after wind and ice storms, and picking up leaves and ice and snow control. He said sometimes three of these things were happening at the same time, and that the city would be catching up on leaf collection soon.

Kruzan noted that there would be a rush on Washington for any money available from an economic stimulus package. He noted that if money would come blindly to the state of Indiana, it could be directed to the construction of I-69, something that he would continue to oppose, and something that we need to communicate to our congressional delegation, White House and state representatives. He said if 2 billion dollars was available to this state, a portion of which could be made available to our community, we could fund so many projects rather than a highway. He added that options such as passenger rail travel would be among the better projects or road projects to be funded.

Kruzan thanked outgoing President Sandberg for her year of service as president of the council. He thanked her particularly for her advocacy of social services as economic developers in the community and advocacy for artisans adding to the culture and economy. He introduced Stonebelt's Director of Development Amy Jackson to deliver a piece of Stonebelt art. Jackson thanked Sandberg for her service and added appreciation for her demonstration that individuals with disabilities can be part of the artistic community, economic development and part of the community as a whole.

Sandberg thanked Jackson and the mayor and noted that this was the eighth piece for her collection and that these pieces made her happy

There were no council committee reports at this meeting.

Michelle Cole noted that Bloomington Transportation Options for People would meet on January 8, 2009 for their annual planning meeting at the Presbyterian Church. She said that BTOP was committed to making Bloomington a more walkable city.

Marc Haggerty heard about the shooting today and took some time to research the last two shootings that involved Bloomington Police Department. He said the shootings involved mentally ill young men. He said that the city should adopt a better crisis intervention program that would have better outcomes for both the police and citizens, and should have citizen evaluation. He noted the need for a community center on the near north west side of town, and said that we can't wait for Obama to fix these things; we need to fix them ourselves. Report from Mayor (cont'd)
