I. ROLL CALL

Commissioners Present: Deb Hutton, Deborah Myerson, Sue Sgambelluri, and John West attended in person. Randy Cassady attended via Zoom.

- **II. READING OF THE MINUTES** Sue Sgambelluri moved to approve the April 1, 2024 minutes via roll-call vote. Deborah Myerson seconded the motion. The motion passed unanimously.
- **III. EXAMINATION OF CLAIM REGISTERS** John West moved to approve the claim register for April 12, 2024, for \$974,132.92 via roll-call Sue Sgambelluri seconded the motion. The motion passed unanimously.

Deb Hutton asked that future claim register cover sheets be updated with Anna Killion-Hanson as the Director.

IV. EXAMINATION OF PAYROLL REGISTERS – Deborah Myerson moved to approve the payroll registers for April 5, 2024, for \$38,404.17 and April 19, 20241 for \$36,579.43 via roll-call vote. Randy Cassady seconded the motion. The motion passed unanimously.

V. REPORT OF OFFICERS AND COMMITTEES

A. Director's Report. Anna Hanson was available to answer questions.

- **B.** Legal Report: Larry Allen stated Resolution 24-31, Approval of Model Lease for Trades District Tech Center needs to be withdrawn from the agenda.
- **C. Treasurer's Report**: Jessica McClellan updated the commission on expense and fund balances. A draft of the requested TIF fund status report was emailed to the commissioners before the meeting. Commissioners gave feedback and suggestions on the report.
- **D.** Business Development Updates: Jane Kupersmith was available to answer questions.
- E. Hopewell Update: Deb Kunce gave a brief update on current Hopewell activities.

VI. NEW BUSINESS -

Note: Randy Cassady was unable to vote due to a technical malfunction and a non-working camera.

A. Resolution 24-35: Approval of Change Order Package #2 to Project Agreement with Milestone Contractors for Hopewell Phase 1 East. Kendall Knoke stated that change order package #2 changes the contract amount with Milestone by an additional \$14,599.44, for a final contract amount of \$13,552,509.53. Knoke outlined the five change orders included in package #2.

City staff and Deb Kunce answered questions from the commissioners.

Deb Hutton asked for public comment. There were no comments from the public.

John West moved to approve Resolution 24-35 via roll-call vote. Deborah Myerson seconded the motion. The motion passed unanimously.

B. Resolution 24-36: Approval of Secondary Plat for Hopwell West. Kendall Knoke stated this resolution will authorize the Engineering Department, on behalf of the RDC, to file for the necessary approvals of the Hopewell West secondary plat. The primary plat has previously been approved. This plat legally creates all of the lots and public rights-of- way on Hopewell West.

City Staff and Deb Kunce answered questions from the commissioners.

Deb Hutton asked for public comment. There were no comments from the public.

John West moved to approve Resolution 24-36 via roll-call vote. Sue Sgambelluri seconded the motion. The motion passed unanimously.

C. Resolution 24-37: Approval of Neighborhood Improvement Grants. Angela Van Roy stated neighborhood improvement grants are offered annually. This year the City has \$30,000 available for neighborhood groups to apply for funding. The City has solicited and received the advice and input of the community as to the allocation of the Neighborhood Improvement Grant Program funds through the Council for Neighborhood Improvement Grants. The allocation recommendations are listed below:

Park Ridge East	\$8,500
Prospect Hill	\$12,750
Rockport Hills	\$1,350
Woodlands	\$7,400

The Woodlands received a Neighborhood Improvement Grant for \$11,000 in 2023 for the first phase of their project. The 2024 award recommendation is for phase 2 of their 2023 project and will be awarded if the HOA can provide written documentation, on or before July 1, 2024, of the HOA's ability to raise the remaining funding necessary to complete the entire project by the end of 2024.

Van Roy answered questions from the commissioners. Deb Hutton asked for public comment. There were no comments from the public.

Sue Sgambelluri moved to approve Resolution 24-37 via roll-call vote. Deborah Myerson seconded the motion. The motion passed unanimously.

D. BUSINESS/GENERAL DISCUSSION

Deb Hutton asked that staff put together an RDC retreat.

Deb Hutton and Deborah Myerson will not be available for the May 6, 2024, RDC meeting. John West, Randy Cassady, and Sue Sgambelluri will all be available to attend in person.

Randy Cassady wanted to know the annual TIF revenue amount. The commissioners would like to have revenues added to the TIF project status report.

XI. ADJOURNMENT – Deborah Myerson moved to adjourn. Sue Sgambelluri seconded the motion. The meeting adjourned at 6:00 p.m.

APPROVAL OF AMENDMENT OF AGREEMENT FOR SECURITY PATROLS AT HOPEWELL PROPERTIES

- WHEREAS, pursuant to Indiana Code 36-7-14 *et seq.*, the Redevelopment Commission of the City of Bloomington ("RDC") and the Common Council of the City of Bloomington created an economic development area known as the Consolidated Economic Development Area ("Consolidated TIF"); and
- WHEREAS, the Consolidated TIF is an allocation area for purposes of tax increment financing; and
- WHEREAS, tax increment from the Consolidated TIF may be used—among other things—to pay expenses incurred by the RDC for local public improvements that are in the Consolidated TIF or that serve the Consolidated TIF; and
- WHEREAS, in Resolution 18-10, the RDC approved a Project Review and Approval Form ("Form") which sought the support of the RDC for the purchase and redevelopment the Old Bloomington Hospital Site ("Hopewell"); and
- WHEREAS, the RDC approved an agreement with Marshall Security LLC dba Marshall Security and Private Investigations ("Marshall") in Resolution 22-45 to provide the security patrols for the RDC-owned property in Hopewell ("Services"), and extended the agreement in Resolution 23-56, 23-69, 23-88, and 24-21; and
- WHEREAS, City staff believe it is in the best interest of the project to extend this agreement until August 1, 2024, and shift the patrols from 24 hours per day to 12 hours per day; and
- WHEREAS, the increase in duration will require additional payment for the security services in an amount not to exceed \$35,162.40; and
- WHEREAS, an addendum to the Agreement is attached to this Resolution as Exhibit A; and
- WHEREAS, there are sufficient funds in the Consolidated TIF to pay for the Services pursuant to the terms of the Agreement; and
- WHEREAS, the City has brought the RDC an Amended Project Review Form ("Amended Form"), which is attached to this Resolution as <u>Exhibit B</u>.

NOW, THEREFORE, BE IT RESOLVED BY THE BLOOMINGTON REDEVELOPMENT COMMISSION THAT:

- 1. The RDC reaffirms its support of the Project, as set forth in the Amended Form, and reiterates that it serves the public's best interests.
- 2. The RDC finds the Project is an appropriate use of TIF, and that the Project serves the public's best interests.
- 3. The RDC hereby approves the Amendment to the Agreement and authorizes the City of Bloomington to expend an amount not to exceed an additional \$35,162.40 and total amount not to exceed \$269,657.35 to pay for the Services, to be payable in accordance with the terms of the amended Agreement ("Payment").
- 4. The Payment authorized above may be made from the Consolidated TIF. Nothing in this Resolution shall remove the requirement to comply with the City or the RDC's claims process.
- 5. Unless extended by the Redevelopment Commission in a resolution, the authorizations provided under this Resolution shall expire on September 1, 2024.
