I. ROLL CALL

- **II. READING OF THE MINUTES** Sue Sgambelluri moved to approve the July 15, 2024 minutes. John West seconded the motion. The motion passed unanimously.
- **III. EXAMINATION OF CLAIM REGISTERS** John West moved to approve the claim register for August 2, 2024, for \$1,298,354.40. Sue Sgambelluri seconded the motion. The motion passed unanimously.
- **IV. EXAMINATION OF PAYROLL REGISTERS** Randy Cassady moved to approve the payroll register for July 26, 2024, for \$41,088.87 via roll-call vote. Sue Sgambelluri seconded the motion. The motion passed unanimously.

V. REPORT OF OFFICERS AND COMMITTEES

A. Director's Report. On April 22, 2024, the RDC approved \$8,500 for the Park Ridge East Neighborhood Association project. The approved amount was \$4,325 less than the requested amount. During the April 22 meeting, there was discussion of a plan to fully fund the project if additional funds became available. Anna Killion-Hanson said additional funds have been identified and therefore HAND is increasing the grant by an additional \$4,325 for a total budget amount of \$12,825.

HAND continues to work on the required 5-year Consolidated Plan. Community outreach will occur later this month.

Heading Home is hosting an "inspection palooza" on September 18, 2024, from 11:00 a.m. to 12:30 p.m.

Anna Killion-Hason said that eight members of the HAND staff, including herself, recently became NSPIRE certified, which is the National Standard of the Physical Inspection of Real Estate.

- C. Treasurer's Report: Jessica McClellan was available to answer questions.
- **D.** Business Development Updates: Jane Kupersmith was available to answer questions.

E. Hopewell Update: Deb Kunce was available to answer questions.

VI. NEW BUSINESS

A. Resolution 24-55: Approval of an Agreement with Presidio for Hopewell Phase 1 East Hardware and Camera Installation. Roy Aten stated that a portion of the Hopewell East infrastructure project included wireless access points and cameras in the Hopewell Common Park. The infrastructure project included the installation of conduits to prepare for the wireless access points. The purchase of the wireless access points and the cameras themselves were not included in the infrastructure project. City staff solicited quotes for services from Presidio for the access points and cameras and negotiated an agreement for an amount not to exceed \$49,174.43.

City staff answered questions from the commissioners.

Deborah Myerson asked for public comment. There were no comments from the public.

Randy Cassady moved to approve Resolution 24-55. John West seconded the motion. The motion passed unanimously.

B. Resolution 24-57: Approval of TIF Refunding Bond. Buzz Crohn and Hannah Clendening outlined the refunding bond. This bond would refinance the outstanding 2015 TIF bonds, which could save the Commission over \$1 million. However, if the markets shift and the refunding does not save the Commission an adequate amount of money, no bonds would be issued. The next step in this process is approval in a resolution from the Common Council.

City staff answered questions from the commissioners.

Deborah Myerson asked for public comment. There were no comments from the public.

John West moved to approve Resolution 24-57. Sue Sgambelluri seconded the motion. The motion passed unanimously.

C. Resolution 24-58: Amendment to Agreement with J.S. Held for Project Management Services for the Hopewell Site. Jane Kupersmith stated that this amendment is for an extension of time to the initial contract with J.S. Held. The extension will go through the remainder of the year. There is approximately \$100,000 remaining on the contract.

City staff answered questions from the commissioners.

Deborah Myerson asked for public comment. There were no comments from the public.

Sue Sgambelluri moved to approve Resolution 24-58. John West seconded the motion. The motion passed unanimously.

D. Resolution 24-59: Approval of Payment of Water Meter Installation Fee for Hopewell East. Roy Aten stated that the project has two water fountains and an irrigation system which needed to be hooked up to city utilities. The installation fee is \$3,989.

City staff answered questions from the commissioners.

Deborah Myerson asked for public comment. There were no comments from the public.

Sue Sgambelluri moved to approve Resolution 24-59. John West seconded the motion. The motion passed unanimously.

E. Resolution 24-60: First Amendment to Agreement with U3 Advisors for Owner's Representative Consultant Services for Hopewell. In Resolution 23-45, the RDC approved an agreement with U3 advisors for owner's representative consultant services for Hopewell. The City temporarily paused U3s work in January 2024 due to a change in administration and a need for an in-depth briefing on the direction and developments at Hopewell. The City is ready to resume the consultation services. Deb Kunce stated that this amendment is a request for an extension of time through May 1, 2025.

City staff answered questions from the commissioners.

Deborah Myerson asked for public comment. There were no comments from the public.

John West moved to approve Resolution 24-60. Sue Sgambelluri seconded the motion. The motion passed unanimously.

Resolution 24-61: Approval of Second Amendment to Agreement with Weber Group for Trades District Gateway Art. Jane Kupersmith stated that last year the RDC approved \$106,500 to support the new piece of public art that is going into the Trade District. The original contract was amended in Resolution 24-07 because there were a variety of drivers that increased costs to \$133,642. Additional services are necessary for the completion of the project. City staff negotiated a second amendment to the agreement for the additional services in the amount not to exceed an additional \$33,825. Additional funding will be paid by the Bloomington Urban Enterprise Association (BUEA), and there will not be any additional use of TIF funding.

City staff answered questions from the commissioners.

John West stated that the fifth "WHEREAS" states that the staff anticipates additional funding will be paid by the BUEA, however, the BUEA already approved the funding. It was suggested to amend the resolution to clarify that additional funding will be paid by the BUEA and TIF funding will not be utilized. Deborah Myerson pointed out a spelling error in the fourth "WHEREAS".

Deborah Myerson asked for public comment. There were no comments from the public.

Sue Sgambelluri moved to approve Resolution 24-61. John West seconded the motion. The motion passed unanimously.

APPROVAL OF AMENDMENT OF AGREEMENT FOR SECURITY PATROLS AT HOPEWELL PROPERTIES

- WHEREAS, pursuant to Indiana Code 36-7-14 *et seq.*, the Redevelopment Commission of the City of Bloomington ("RDC") and the Common Council of the City of Bloomington created an economic development area known as the Consolidated Economic Development Area ("Consolidated TIF"); and
- WHEREAS, the Consolidated TIF is an allocation area for purposes of tax increment financing; and
- WHEREAS, tax increment from the Consolidated TIF may be used—among other things—to pay expenses incurred by the RDC for local public improvements that are in the Consolidated TIF or that serve the Consolidated TIF; and
- WHEREAS, in Resolution 18-10, the RDC approved a Project Review and Approval Form ("Form") which sought the support of the RDC for the purchase and redevelopment the Old Bloomington Hospital Site ("Hopewell"); and
- WHEREAS, the RDC approved an agreement with Marshall Security LLC ("Marshall") in Resolution 22-45 to provide security patrols for Hopewell ("Services"), and extended the agreement in Resolution 23-56, 23-69, 23-88, 23-114, 24-21, and 24-38; and
- WHEREAS, City staff believe it is in the best interest of the project to extend this agreement until March 1, 2025; and
- WHEREAS, currently, funds remain from what had been approved in Resolution 24-38, and the funds shall be expended before increasing funding approval; and
- WHEREAS, an addendum to the Agreement is attached to this Resolution as Exhibit A; and
- WHEREAS, there are sufficient funds in the Consolidated TIF to pay for the Services pursuant to the terms of the Agreement; and
- WHEREAS, the City has brought the RDC an Amended Project Review Form ("Amended Form"), which is attached to this Resolution as <u>Exhibit B</u>.

NOW, THEREFORE, BE IT RESOLVED BY THE BLOOMINGTON REDEVELOPMENT COMMISSION THAT:

- 1. The RDC reaffirms its support of the Project, as set forth in the Amended Form, and reiterates that it serves the public's best interests.
- 2. The RDC finds the Project is an appropriate use of TIF, and that the Project serves the public's best interests.
- 3. The RDC hereby approves the Amendment to the Agreement and extends its authorization for the City of Bloomington to expend an amount not to exceed a grand total of \$269,657.35 to pay for the Services, to be payable in accordance with the terms of the amended Agreement ("Payment").
- 4. The Payment authorized above may be made from the Consolidated TIF. Nothing in this Resolution shall remove the requirement to comply with the City or the RDC's claims process.
- 5. Unless extended by the Redevelopment Commission in a resolution, the authorizations provided under this Resolution shall expire on March 1, 2025.

APPROVAL OF CONTRACT WITH BELCHER FENCING LLC TO MODIFYING FENCING IN HOPEWELL

- WHEREAS, pursuant to Indiana Code 36-7-14 *et seq.*, the Redevelopment Commission of the City of Bloomington ("RDC") and the Common Council of the City of Bloomington created an economic development area known as the Consolidated Economic Development Area ("Consolidated TIF"); and
- WHEREAS, the Consolidated TIF is an allocation area for purposes of tax increment financing; and
- WHEREAS, tax increment from the Consolidated TIF may be used—among other things—to pay expenses incurred by the RDC for local public improvements that are in the Consolidated TIF or that serve the Consolidated TIF; and
- WHEREAS, in Resolution 18-10, the RDC approved a Project Review and Approval Form ("Form") which sought the support of the RDC for the purchase and redevelopment the Old Bloomington Hospital Site ("Hopewell"); and
- WHEREAS, as part of the closing on the real estate, IU Health conveyed its construction fence surrounding the Hopewell West properties; and
- WHEREAS, because of the anticipated conveyance and start of construction on separate projects in Hopewell West in the coming months, City staff has solicited quotes for a firm to modify the fencing in Hopewell West, which will create two fenced-in areas around the Kohr Administration Building and the existing parking garage ("Services"); and
- WHEREAS, after obtaining quotes from different providers, Staff identified Belcher Fencing LLC ("Belcher Fencing") as the best provider of the Services; and
- WHEREAS, Staff has negotiated an Agreement with Belcher Fencing, which is attached to this Resolution as <u>Exhibit A</u> ("Agreement"). Pursuant to the terms of the Agreement, Belcher Fencing is willing to perform the Services for an amount not to exceed Fourteen Thousand Seven Hundred Twenty-Three Dollars and Fifty Cents (\$14,723.50); and
- WHEREAS, the RDC has available funds in the Consolidated TIF (Expanded Adams Crossing) to pay for the Services;

NOW, THEREFORE, BE IT RESOLVED BY THE REDEVELOPMENT COMMISSION OF THE CITY OF BLOOMINGTON, INDIANA, THAT:

- 1. The RDC hereby approves the Agreement attached to this Resolution as <u>Exhibit A</u> with Belcher Fencing for the Services.
- 2. The RDC hereby approves payment not to exceed Fourteen Thousand Seven Hundred Twenty-Three Dollars and Fifty Cents (\$14,723.50) plus any reasonable permit fees to be paid from the Consolidated TIF (Expanded Adams Crossing Area) for the Services. The payment shall be payable in accordance with the terms of Exhibit A.
- 3. For the avoidance of doubt, nothing in this Resolution nor the terms of the Agreement remove the requirement to comply with the City and the RDC's claims process.
- 4. The funding authorizations contained in this Resolution shall terminate on December 1, 2024, unless extended by the RDC in advance.

AGREEMENT BETWEEN THE CITY OF BLOOMINGTON REDEVELOPMENT COMMISSION AND BELCHER FENCING LLC

This Agreement, entered into on this _____ day of September, 2024, by and between the City of Bloomington Redevelopment Commission (the "City"), and Belcher Fencing LLC ("Contractor").

Article 1. <u>Scope of Services</u> Contractor shall perform services as detailed in Exhibit A, "Scope of Work," which includes the removal and relocation of fencing on the Hopewell West site.

Contractor shall diligently provide the Services under this Agreement and shall complete the Services described in this Agreement in a timely manner consistent with the Standard of Care identified in Article 2. Contractor shall complete the Services required under this Agreement on or before December 31, 2024, unless the parties mutually agree to a later completion date. Completion shall mean completion of all work related to the Services. In the performance of Contractor's work, Contractor agrees to maintain such coordination with the City as may be requested and desirable, including primary coordination with JD Boruff, Operations and Facilities Director for the City. Contractor agrees that any information or documents supplied by the City pursuant to Article 3, below, shall be used by Contractor for this project only, and shall not be reused or reassigned for any other purpose without the written permission of the City.

Article 2. <u>Standard of Care</u> Contractor shall be responsible for completion of the Services in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances ("Standard of Care"). The City shall be the sole judge of the adequacy of Contractor's work in meeting the Standard of Care; however, the City shall not unreasonably withhold its approval as to the adequacy of Contractor's performance. Upon notice to Contractor and by mutual agreement between the parties, Contractor will, without additional compensation, correct or replace any and all Services not meeting the Standard of Care.

Article 3. <u>Responsibilities of the City</u> The City shall provide all necessary information regarding requirements for the Services. The City shall furnish such information as necessary for the orderly progress of the work, and Contractor shall be entitled to rely upon the accuracy and completeness of such information. The City's Project Manager shall act on its behalf with respect to this Agreement.

Article 4. <u>Compensation</u> The City shall pay Contractor for all fees and expenses in an amount not to exceed Fourteen Thousand Seven Hundred Twenty-Three Dollars and Fifty Cents (\$14,723.50). Contractor shall submit invoices to the City monthly throughout completion of the Services described in Article 1. Invoices shall be sent via email to boruffj@bloomington.in.gov or via first class mail postage prepaid to Bloomington Redevelopment Commission, ATTN: Christina Finley, 401 N. Morton Street, Suite 130, Bloomington, IN 47404. Payment will be remitted to the Contractor within forty-five (45) days of receipt of invoice. Additional services not set forth in Article 1, or changes in the Services must be authorized in writing by the City or its designated project coordinator prior to such work being performed, or expenses incurred. The City shall not make payment for any unauthorized work or expenses.

Article 5. <u>Appropriation of Funds</u> Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of this Agreement by the City are at any time not forthcoming or are insufficient, through failure of any entity, including the City itself, to appropriate funds or otherwise, then the City shall have the right to terminate this Agreement without penalty.

Article 6. <u>Schedule</u> Contractor shall perform the Services according to the following schedule: Services will be on as needed basis upon request of the City. The time limits established by this schedule shall not be exceeded, except for reasonable cause as mutually agreed to by all parties. **Article 7.** <u>Termination</u> In the event of a party's substantial failure to perform in accordance with the terms of this Agreement, the other party shall have the right to terminate the Agreement upon written notice. The nonperforming party shall have fourteen (14) calendar days from the receipt of the termination notice to cure or to submit a plan for cure acceptable to the other party. Additionally, the City may terminate or suspend performance of this Agreement at the City's prerogative at any time upon written notice to Contractor. Contractor shall terminate or suspend performance of the Services on a schedule acceptable to the City and the City shall pay the Contractor for all the Services performed up to the date that written notice is received, plus reasonable termination or suspension expenses. Upon restart, an equitable adjustment shall be made to Contractor's compensation and the schedule of services. Upon termination or suspension of this Agreement, all finished or unfinished reports, drawings, collections of data and other documents generated by Contractor in connection with this Agreement shall become the property of the City, as set forth in Article 9 herein.

Article 8. <u>Identity of the Contractor</u> Contractor acknowledges that one of the primary reasons for its selection by the City to perform the Services is the qualifications and experience of Contractor. Contractor thus agrees that the Services to be performed pursuant to this Agreement shall be performed by Contractor. Contractor shall not subcontract any part of the Services without the prior written permission of the City. The City reserves the right to reject any of the Contractor's personnel or proposed outside professional sub-Contractors, and the City reserves the right to request that acceptable replacement personnel be assigned to the project.

Article 9. <u>Ownership of Documents and Intellectual Property</u> All documents, drawings and specifications, including digital format files, prepared by Contractor and furnished to the City as part of the Services shall become the property of the City. Contractor shall retain its ownership rights in its design, drawing details, specifications, databases, computer software and other proprietary property. Intellectual property developed, utilized or modified in the performance of the Services shall remain the property of Contractor.

Article 10. <u>Independent Contractor Status</u> During the entire term of this Agreement, Contractor shall be an independent contractor, and in no event shall any of its personnel, agents or sub-contractors be construed to be, or represent themselves to be, employees of the City. Contractor shall be solely responsible for the payment and reporting of all employee and employer taxes, including social security, unemployment, and any other federal, state, or local taxes required to be withheld from employees or payable on behalf of employees.

Article 11. <u>Indemnification</u> Contractor shall defend, indemnify, and hold harmless the City of Bloomington, the City, and the officers, agents and employees of the City and the City from any and all claims, demands, damages, costs, expenses or other liability arising out of the Agreement or occasioned by the reckless or negligent performance of any provision thereof, including, but not limited to, any reckless or negligent act or failure to act or any misconduct on the part of the Contractor or its agents or employees, or any independent contractors directly responsible to it (collectively "Claims").

Article 12. <u>Insurance</u> During the performance of any and all Services under this Agreement, Contractor shall maintain the following insurance in full force and effect: a) General Liability Insurance, with a minimum combined single limit of \$1,000,000 for each occurrence and \$2,000,000 in the aggregate; b) Automobile Liability Insurance, with a minimum combined single limit of \$1,000,000 for each occurrence in accordance with the statutory requirements of Title 22 of the Indiana Code; and d) Professional Liability Insurance ("Errors and Omissions Insurance") with a minimum limit of \$1,000,000 annual aggregate. All insurance policies shall be issued by an insurance company authorized to issue such insurance in the State of Indiana. The City of Bloomington, the City, and the officers, employees and agents of each shall be named as insureds under the General Liability, Automobile, and Worker's Compensation policies, and such policies shall stipulate that the insurance will operate as primary insurance and that no other insurance of the City's will be called upon

to contribute to a loss hereunder. Contractor shall provide evidence of each insurance policy to the City prior to the commencement of work under this Agreement.

Article 13. <u>Conflict of Interest</u> Contractor declares that it has no present interest, nor shall it acquire any interest, direct or indirect, which would conflict with the performance of Services under this Agreement. Contractor agrees that no person having any such interest shall be employed in the performance of this Agreement.

Article 14. <u>Waiver</u> No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

Article 15. <u>Severability</u> The invalidity, illegality or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of the Agreement shall be construed and enforced as if it did not contain the particular provision to be held void. The parties further agree to amend this Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this Agreement be determined void.

Article 16. <u>Assignment</u> Neither the City nor the Contractor shall assign any rights or duties under this Agreement without the prior written consent of the other party. Unless otherwise stated in the written consent to an assignment, no assignment will release or discharge the assignor from any obligation under this Agreement.

Article 17. <u>Third Party Rights</u> Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the parties.

Article 18. <u>Governing Law and Venue</u> This Agreement shall be governed by the laws of the State of Indiana. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

Article 19. <u>Non-Discrimination</u> Contractor shall comply with City of Bloomington Ordinance 2.23.110 and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment. Contractor understands that the City of Bloomington prohibits its employees from engaging in harassment or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If the Contractor believes that a City employee engaged in such conduct towards Contractor and/or any of its employees, Contractor or its employees may file a complaint with the City department head in charge of the Contractor's work and/or with the City human resources department or the Bloomington Human Rights Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct.

Article 20. <u>Compliance with Laws</u> In performing the Services under this Agreement, Contractor shall comply with any and all applicable federal, state and local statutes, ordinances, plans and regulations, including any and all regulations for protection of the environment. Where such statutes, ordinances, plans or regulations of any public authority having any jurisdiction over the project are in conflict, Contractor shall proceed using its best judgment only after attempting to resolve any such conflict between such governmental agencies, and shall notify the City in a timely manner of the conflict, attempts of resolution, and planned course of action.

Article 21. <u>E-Verify</u> Contractor is required to enroll in and verify the work eligibility status of all newlyhired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Exhibit B, affirming that Contractor does not knowingly employ an unauthorized alien. Contractor shall require any subcontractors performing work under this contract to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

Article 22. <u>Notices</u> Any notice required by this Agreement shall be made in writing to the individuals/addresses specified below:

City: City of Bloomington RDC, Attn: Larry Allen, PO Box 100, Bloomington, Indiana 47402.

Contractor: Belcher Fencing LLC, Attn: Wes Abram, PO Box 173, Bloomington, Indiana 47402.

Nothing contained in this Article shall be construed to restrict the transmission of routine communications between representatives of the City and MPI Solar/Mann Plumbing.

Article 23. <u>Integration and Modification</u> This Agreement, including all Exhibits incorporated by reference, represents the entire and integrated agreement between the City and the Contractor. It supersedes all prior and contemporaneous communications, representations and agreements, whether oral or written, relating to the subject matter of this Agreement. This Agreement may be modified only by a written amendment signed by both parties hereto.

Article 24. <u>Non-Collusion</u> Contractor is required to certify that it has not, nor has any other member, representative, or agent of Contractor, entered into any combination, collusion, or agreement with any person relative to the price to be offered by any person nor prevented any person from making an offer nor induced anyone to refrain from making an offer and that this offer is made without reference to any other offer. Contractor shall sign an affidavit, attached hereto as Exhibit C, affirming that Contractor has not engaged in any collusive conduct. Exhibit C is attached hereto and incorporated by reference as though fully set forth.

APPROVAL OF CONTRACT WITH WOODS ELECTRICAL CONTRACTORS INC. FOR ELECTRICAL MAINTENANCE AND CONNECTION SERVICES IN HOPEWELL

- WHEREAS, pursuant to Indiana Code 36-7-14 *et seq.*, the Redevelopment Commission of the City of Bloomington ("RDC") and the Common Council of the City of Bloomington created an economic development area known as the Consolidated Economic Development Area ("Consolidated TIF"); and
- WHEREAS, in Resolution 18-10, the RDC approved a Project Review and Approval Form ("Form") which sought the support of the RDC for the purchase and redevelopment the Old Bloomington Hospital Site ("Hopewell") using funds from the Consolidated TIF; and
- WHEREAS, the RDC has need of electrical work to be performed at the Hopewell site, including reconnecting 714 S Rogers Street with electricity ("Services"); and
- WHEREAS, after obtaining quotes from different providers, Staff identified Woods Electrical Contractors Inc. ("Woods Electrical") as the best provider of the Services; and
- WHEREAS, Staff has negotiated an Agreement with Woods Electrical, which is attached to this Resolution as <u>Exhibit A</u> ("Agreement"). Pursuant to the terms of the Agreement, Belcher Fencing is willing to perform the Services for an amount not to exceed Fifteen Thousand Dollars (\$15,000.00); and
- WHEREAS, the RDC has available funds in its non-TIF, maintenance account ("444 Account") (Expanded Adams Crossing) to pay for the Services;

NOW, THEREFORE, BE IT RESOLVED BY THE REDEVELOPMENT COMMISSION OF THE CITY OF BLOOMINGTON, INDIANA, THAT:

- 1. The RDC hereby approves the Agreement attached to this Resolution as <u>Exhibit A</u> with Woods Electrical for the Services.
- 2. The RDC hereby approves payment not to exceed Fifteen Thousand Dollars (\$15,000.00) to be paid from the 444 Account for the Services. The payment shall be payable in accordance with the terms of <u>Exhibit A</u>.

AGREEMENT BETWEEN THE CITY OF BLOOMINGTON REDEVELOPMENT COMMISSION AND BELCHER FENCING LLC

This Agreement, entered into on this ______ day of September, 2024, by and between the City of Bloomington Redevelopment Commission (the "City"), and Woods Electrical Contractors Inc. ("Contractor").

Article 1. <u>Scope of Services</u> Contractor shall reconnect electricity to 714 S. Rogers Street and provide any other electrical services for properties owned by the Redevelopment Commission as directed with the City's project coordinator, JD Boruff. All Services provided under this agreement must be approved by the City's project coordinator in writing.

Contractor shall diligently provide the Services under this Agreement and shall complete the Services described in this Agreement in a timely manner consistent with the Standard of Care identified in Article 2. Contractor shall complete the Services required under this Agreement on or before December 31, 2025, unless the parties mutually agree to a later completion date. Completion shall mean completion of all work related to the Services. In the performance of Contractor's work, Contractor agrees to maintain such coordination with the City as may be requested and desirable, including primary coordination with JD Boruff, Operations and Facilities Director for the City. Contractor agrees that any information or documents supplied by the City pursuant to Article 3, below, shall be used by Contractor for this project only, and shall not be reused or reassigned for any other purpose without the written permission of the City.

Article 2. <u>Standard of Care</u> Contractor shall be responsible for completion of the Services in a manner consistent with that degree of care and skill ordinarily exercised by members of the same profession currently practicing under similar circumstances ("Standard of Care"). The City shall be the sole judge of the adequacy of Contractor's work in meeting the Standard of Care; however, the City shall not unreasonably withhold its approval as to the adequacy of Contractor's performance. Upon notice to Contractor and by mutual agreement between the parties, Contractor will, without additional compensation, correct or replace any and all Services not meeting the Standard of Care.

Article 3. <u>Responsibilities of the City</u> The City shall provide all necessary information regarding requirements for the Services. The City shall furnish such information as necessary for the orderly progress of the work, and Contractor shall be entitled to rely upon the accuracy and completeness of such information. The City's Project Manager shall act on its behalf with respect to this Agreement.

Article 4. <u>Compensation</u> The City shall pay Contractor for all fees and expenses in an amount not to exceed Fifteen Thousand Dollars (\$15,000.00). Contractor shall submit invoices to the City monthly throughout completion of the Services described in Article 1. Invoices shall be sent via email to boruffj@bloomington.in.gov or via first class mail postage prepaid to Bloomington Redevelopment Commission, ATTN: Christina Finley, 401 N. Morton Street, Suite 130, Bloomington, IN 47404. Payment will be remitted to the Contractor within forty-five (45) days of receipt of invoice. Additional services not set forth in Article 1, or changes in the Services must be authorized in writing by the City or its designated project coordinator prior to such work being performed, or expenses incurred. The City shall not make payment for any unauthorized work or expenses.

Article 5. <u>Appropriation of Funds</u> Notwithstanding any other provision of this Agreement, if funds for the continued fulfillment of this Agreement by the City are at any time not forthcoming or are insufficient, through failure of any entity, including the City itself, to appropriate funds or otherwise, then the City shall have the right to terminate this Agreement without penalty.

Article 6. <u>Schedule</u> Contractor shall perform the Services according to the following schedule:

Services will be on as needed basis upon request of the City. The time limits established by this schedule shall not be exceeded, except for reasonable cause as mutually agreed to by all parties.

Article 7. <u>Termination</u> In the event of a party's substantial failure to perform in accordance with the terms of this Agreement, the other party shall have the right to terminate the Agreement upon written notice. The nonperforming party shall have fourteen (14) calendar days from the receipt of the termination notice to cure or to submit a plan for cure acceptable to the other party. Additionally, the City may terminate or suspend performance of this Agreement at the City's prerogative at any time upon written notice to Contractor. Contractor shall terminate or suspend performance of the Services on a schedule acceptable to the City and the City shall pay the Contractor for all the Services performed up to the date that written notice is received, plus reasonable termination or suspension expenses. Upon restart, an equitable adjustment shall be made to Contractor's compensation and the schedule of services. Upon termination or suspension of this Agreement, all finished or unfinished reports, drawings, collections of data and other documents generated by Contractor in connection with this Agreement shall become the property of the City, as set forth in Article 9 herein.

Article 8. <u>Identity of the Contractor</u> Contractor acknowledges that one of the primary reasons for its selection by the City to perform the Services is the qualifications and experience of Contractor. Contractor thus agrees that the Services to be performed pursuant to this Agreement shall be performed by Contractor. Contractor shall not subcontract any part of the Services without the prior written permission of the City. The City reserves the right to reject any of the Contractor's personnel or proposed outside professional sub-Contractors, and the City reserves the right to request that acceptable replacement personnel be assigned to the project.

Article 9. <u>Ownership of Documents and Intellectual Property</u> All documents, drawings and specifications, including digital format files, prepared by Contractor and furnished to the City as part of the Services shall become the property of the City. Contractor shall retain its ownership rights in its design, drawing details, specifications, databases, computer software and other proprietary property. Intellectual property developed, utilized or modified in the performance of the Services shall remain the property of Contractor.

Article 10. <u>Independent Contractor Status</u> During the entire term of this Agreement, Contractor shall be an independent contractor, and in no event shall any of its personnel, agents or sub-contractors be construed to be, or represent themselves to be, employees of the City. Contractor shall be solely responsible for the payment and reporting of all employee and employer taxes, including social security, unemployment, and any other federal, state, or local taxes required to be withheld from employees or payable on behalf of employees.

Article 11. <u>Indemnification</u> Contractor shall defend, indemnify, and hold harmless the City of Bloomington, the City, and the officers, agents and employees of the City and the City from any and all claims, demands, damages, costs, expenses or other liability arising out of the Agreement or occasioned by the reckless or negligent performance of any provision thereof, including, but not limited to, any reckless or negligent act or failure to act or any misconduct on the part of the Contractor or its agents or employees, or any independent contractors directly responsible to it (collectively "Claims").

Article 12. <u>Insurance</u> During the performance of any and all Services under this Agreement, Contractor shall maintain the following insurance in full force and effect: a) General Liability Insurance, with a minimum combined single limit of \$1,000,000 for each occurrence and \$2,000,000 in the aggregate; b) Automobile Liability Insurance, with a minimum combined single limit of \$1,000,000 for each person and \$1,000,000 for each accident; c) Workers' Compensation Insurance in accordance with the statutory requirements of Title 22 of the Indiana Code; and d) Professional Liability Insurance ("Errors and Omissions Insurance") with a minimum limit of \$1,000,000 annual aggregate. All insurance policies shall be issued by an insurance company authorized to issue such insurance in the State of Indiana. The City of

Bloomington, the City, and the officers, employees and agents of each shall be named as insureds under the General Liability, Automobile, and Worker's Compensation policies, and such policies shall stipulate that the insurance will operate as primary insurance and that no other insurance of the City's will be called upon to contribute to a loss hereunder. Contractor shall provide evidence of each insurance policy to the City prior to the commencement of work under this Agreement.

Article 13. <u>Conflict of Interest</u> Contractor declares that it has no present interest, nor shall it acquire any interest, direct or indirect, which would conflict with the performance of Services under this Agreement. Contractor agrees that no person having any such interest shall be employed in the performance of this Agreement.

Article 14. <u>Waiver</u> No failure of either party to enforce a term of this Agreement against the other shall be construed as a waiver of that term, nor shall it in any way affect the party's right to enforce that term. No waiver by any party of any term of this Agreement shall be considered to be a waiver of any other term or breach thereof.

Article 15. <u>Severability</u> The invalidity, illegality or unenforceability of any provision of this Agreement or the occurrence of any event rendering any portion or provision of this Agreement void shall in no way affect the validity or enforceability of any other portion or provision of this Agreement. Any void provision shall be deemed severed from this Agreement, and the balance of the Agreement shall be construed and enforced as if it did not contain the particular provision to be held void. The parties further agree to amend this Agreement to replace any stricken provision with a valid provision that comes as close as possible to the intent of the stricken provision. The provisions of this Agreement be determined void.

Article 16. <u>Assignment</u> Neither the City nor the Contractor shall assign any rights or duties under this Agreement without the prior written consent of the other party. Unless otherwise stated in the written consent to an assignment, no assignment will release or discharge the assignor from any obligation under this Agreement.

Article 17. <u>Third Party Rights</u> Nothing in this Agreement shall be construed to give any rights or benefits to anyone other than the parties.

Article 18. <u>Governing Law and Venue</u> This Agreement shall be governed by the laws of the State of Indiana. Venue of any disputes arising under this Agreement shall be in the Monroe Circuit Court, Monroe County, Indiana.

Article 19. <u>Non-Discrimination</u> Contractor shall comply with City of Bloomington Ordinance 2.23.110 and all other federal, state and local laws and regulations governing non-discrimination in all regards, including, but not limited to, employment. Contractor understands that the City of Bloomington prohibits its employees from engaging in harassment or discrimination of any kind, including harassing or discriminating against independent contractors doing work for the City. If the Contractor believes that a City employee engaged in such conduct towards Contractor and/or any of its employees, Contractor or its employees may file a complaint with the City department head in charge of the Contractor's work and/or with the City human resources department or the Bloomington Human Rights Commission. The City takes all complaints of harassment and discrimination seriously and will take appropriate disciplinary action if it finds that any City employee engaged in such prohibited conduct.

Article 20. <u>Compliance with Laws</u> In performing the Services under this Agreement, Contractor shall comply with any and all applicable federal, state and local statutes, ordinances, plans and regulations, including any and all regulations for protection of the environment. Where such statutes, ordinances, plans or regulations of any public authority having any jurisdiction over the project are in conflict, Contractor shall proceed using its best judgment only after attempting to resolve any such conflict between such

governmental agencies, and shall notify the City in a timely manner of the conflict, attempts of resolution, and planned course of action.

Article 21. <u>E-Verify</u> Contractor is required to enroll in and verify the work eligibility status of all newlyhired employees through the E-Verify program. (This is not required if the E-Verify program no longer exists). Contractor shall sign an affidavit, attached as Exhibit A, affirming that Contractor does not knowingly employ an unauthorized alien. Contractor shall require any subcontractors performing work under this contract to certify to the Contractor that, at the time of certification, the subcontractor does not knowingly employ or contract with an unauthorized alien and the subcontractor has enrolled in and is participating in the E-Verify program. Contractor shall maintain on file all subcontractors' certifications throughout the term of the contract with the City.

Article 22. <u>Notices</u> Any notice required by this Agreement shall be made in writing to the individuals/addresses specified below:

Nothing contained in this Article shall be construed to restrict the transmission of routine communications between representatives of the City and MPI Solar/Mann Plumbing.

Article 23. <u>Integration and Modification</u> This Agreement, including all Exhibits incorporated by reference, represents the entire and integrated agreement between the City and the Contractor. It supersedes all prior and contemporaneous communications, representations and agreements, whether oral or written, relating to the subject matter of this Agreement. This Agreement may be modified only by a written amendment signed by both parties hereto.

Article 24. <u>Non-Collusion</u> Contractor is required to certify that it has not, nor has any other member, representative, or agent of Contractor, entered into any combination, collusion, or agreement with any person relative to the price to be offered by any person nor prevented any person from making an offer nor induced anyone to refrain from making an offer and that this offer is made without reference to any other offer. Contractor shall sign an affidavit, attached hereto as Exhibit B, affirming that Contractor has not engaged in any collusive conduct.
