Re: Bloomington Arts Commission recommendations for BUEA 2024 Art Operations Grants

The BUEA has allocated \$50,000 for 2024 Zone Arts Grants, which the Bloomington Arts Commission has been entrusted to allot as part of its annual Arts Projects and Operations grant cycles. The BUEA previously supported awarding \$21,950 in 2024 Arts Project grants. The BAC recommends that the BUEA award \$27,000 of the remaining 2024 Zone Art Grant funds to the arts organizations listed below as part of its 2024 Operations grant cycle.

BUEA Zone Arts Operations Grants are meant to support arts-focused 501(c)3s whose activities take place within the boundaries of the Bloomington Urban Enterprise Zone or significantly impact Zone residents and visitors. Organization's annual operating budget cannot exceed \$500,000. Award amount cannot exceed five percent of an organization's operating budget or \$5000.

As part of its annual Arts Operations Grant Cycle, members of the Bloomington Arts Commission, along with community readers working locally in the arts, evaluate applications according to the following criteria:

- Organizational Capacity- organizations must demonstrate a clear mission and the planning to achieve it, must be fiscally sound, and have staff or volunteers committed to doing the work to achieve your mission.
- Community Impact- organizations must address a community need, engage in larger community dialogues and reach out to or connect with the various communities that exist in Bloomington.
- Equity and Inclusion- organizations must take actionable steps to increase equity and inclusion.

Funded organizations must do one or more of the following for residents and businesses within the Urban Enterprise Zone:

Facilitate involvement in arts and cultural activities

- Provide an opportunity to participate in the creative process
- Advance the quality and availability of the arts in the Zone
- Celebrate or enhance the identity of the Zone

The BAC received a total of 19 Arts Operations grant applications during 2024. Based on our evaluation, we recommend that the BUEA fund the following 11 grant applicants a total of \$27,000:

We can see the growth in our students in academic proficiency, self-confidence, and expression.

We are requesting your help in the following areas of need:

Grant Need (1) VMath Amount: \$4,103

VMath has been an effective intervention tool at Fairview. The BUEA grant last year supported subscriptions for grades 2-6. Classroom teachers and special education teachers are able to use the materials with their students. We are also able to utilize the program with volunteers, service learners, and tutors who come in to work with our students because the program is so user-friendly. ILEARN Math Assessment data, showed that 61% are below proficiency in math. This is a decrease from the previous year where 69% of our students were below proficiency in

math. Our math team believes VMath has been a great resource in helping our students achieve this growth. This funding will enable us to renew the license fee at the beginning of the 2025-2026 and provide consistency in access to the software. It will also provide print-based materials for the grade level modules.

Grant Need (2) My Heggerty

Amount: \$1,441

My Heggerty is an online subscription for classroom teachers to have access to a wide variety of resources targeting phonemic awareness. Each classroom teacher will be able to access curricula in English and in Spanish. They will also have access to "Bridge the Gap", which is another great tool for teaching phonemic awareness. In addition, the subscription provides daily lessons, tutorials, assessments, and on-demand professional development opportunities.

Grant Need (3) Generation Genius Subscription – grade 4

Amount: \$970

Generation Genius was used by our 4th grade team last year. The program provides content with lessons and videos for both science and math. The 4th grade team would like to ass this into their curriculum to engage students in these subject areas. The video series are mapped to state standards and offer creative lessons to engage students in academic growth.

Grant Need (4) Positive Behavioral Interventions Supports

Amount: \$5,400

A priority for our teachers is to close learning gaps for all students in math. Our teachers and staff recognize there is a need for students to strength their fluency in the areas of addition, subtraction, multiplication, division, as well as foundational knowledge of fractions and decimals. Math kits will be used as supplemental material during our core math block. The kits will also expand our intervention materials to include more hands-on methods and materials that give students the opportunity to practice fluency. The intervention kids would be integrated into Tier II and Tier III instructional times to increase math skills and provide growth in math standards.

Grant Need (5) Library Materials

Amount: \$3,240

We would I like to continue updating the Fairview Library collection with both fiction and nonfiction books. With these funds we will add titles in the following areas:

• Fiction and Nonfiction bilingual and Spanish books. This will support our Spanish speaking students with books in their native language.

- Fiction and Nonfiction Social Emotional Learning books. This will support the SEL section of the library to help students of all ages with their emotions and behaviors with their peers.
- Sport, Biographies, Countries and Cultures.

School Name: Summit

Students who live in the Enterprise Zone: 128

% of Total School Enrollment: 22%
Total Requested: \$14,705

Summit Elementary is a Title 1 school with 44% of its students receiving free and reduced lunch. It is located at 1450 W Countryside Lane. The school total enrollment is 614 students and 22% of its students live in the BUEA residential area. Summit is as a Dual Language Immersion school in the Spanish language. Students are taught in Spanish for part of the day and in English for part of the day. The goal with the program is to have students who are not just bilingual, but biliterate as well.

The areas of need at Summit include the following:

Grant Need (1): Learning A-Z Raz-Kids

Amount: \$2,916

Raz-Kids is an online interactive e-reading program complete with comprehension checks and engaging levels reading materials for students in K-6th. The program gives students access to 400+ eBooks and eQuizzes, in English and Spanish, with new books added each month. Corresponding eQuizzes check comprehension, providing teachers with skill reports. Raz-Kids also has an online running record option for teachers to digitally assess reading fluency. Student can access Raz-Kids from home. The ability to provide additional ebooks is important to help keep students engaged both inside and outside of the classroom. This funding will provide an annual license for the school.

Grant Need (2): Generation Genius

Amount: \$1,368

Generation Genius provides content with lessons and videos for both science and math. We would like to add this resource into our current curriculums to engage students in these subject areas. The video series are mapped to state standards and offer create lessons to engage students in academic growth. Generation Genius also provides teachers with an expanded resource for DIY activities, reading material, Exit Tickets and quizzes to asses understanding, as well as vocabulary practice and discussion questions.

Grant Need (3): VMAth Amount: \$5,427

VMath is a targeted intervention program for learners in grades 2-8 that provides additional opportunities to practice and strengthen core mathematical skills. Thanks to your generous support, Summit is currently using the VMath program with multiple classrooms this school year. Feedback from teachers and students has been positive overall, with teachers noting increased student engagement during math work time and competence in targeted skills. Student feedback has been positive regarding the online component that they use during independent and small group work time. Due to this positive overall experience, we are requesting funding to expand our use of VMath to cover all of 3rd through 6th grade classrooms. To do this most effectively, and after gathering feedback from teachers currently using the program, we are requesting funding for the online component. We believe that continuing and expanding this program will benefit our students and positively impact our growth on NWEA and ILEARN.

Grant Need (4): Decodable Books, Just Right Reader

Amount: \$4,424

As Summit teachers continue to expand their knowledge of the Science of Reading and adjusting their instructional practices to better meet students needs, we have encountered an increased need to provide decodable books to our students to practice what they are learning in class. In an effort to continue to provide students with these materials, we want to purchase decodable reading selections from Just Right Reader. This purchase would include a K-2 selection of decodable books in both English and Spanish to serve our diverse student population. Books will be distributed and shared amongst teachers to supplement their classroom selection of books available to students.

School Name: Templeton

Students who live in the Enterprise Zone: 60

% of Total School Enrollment: 15% Amount Requested: \$17,021

Templeton Elementary School, located in the heart of Bloomington, has a total student population of 403 students from preschool through sixth grade. Over 50% of our students receive free or reduced lunch. In spite of some of the difficult life circumstances that many of our students face, they are bright and hardworking individuals who work hard in the classroom. Templeton is an International Baccalaureate School.

Grant Need (1): Decodable Readers Grades (K-6)

Amount: \$9,461

Our building is in dire need of decodable readers for all grade levels in the classrooms. These books are research-based and supported by the Science of Reading initiative. Our students come to us disadvantaged simply because of the socioeconomic status of their families; often our students have never even left Bloomington. The lack of experience students have often translates into how they read- without knowledge through experiences (scaffolding) it is hard to understand what they read. Decodable readers help students gain the confidence in their reading abilities by allowing them a structure and pattern to the words in the stories that they read. This closes the gaps in their phonics development. Where the topic may be about something they aren't familiar with, the words are created to allow them to figure out the word by decoding them with learned skills, thus helping students to create a knowledge base on those experiences they are reading about in the decodable readers.

We are requesting sets of decodable readers from Supercharged Decodable Readers for all K through 6 grade classrooms. Teachers will be able to immediately implement these books into small groups of high need students. They will be able to follow a simple lesson plan that is provided with these books. They can be systematically used in conjunction with UFLI, a phonics intervention that we are using in both whole and small groups throughout the building, as well.

Grant Need (2): IXL Language Arts Grades 2-6

Amount: \$3,240

To further support our students in language arts we would like to utilize the IXL Language Arts subscription. IXL provides a research based systematic approach to teach reading skills. Reading skills are crucial to a student's long-term success in the classroom and beyond. While IXL aligns with a variety of curriculums, standards, and pedagogies, its alignment with best practices in reading science ensure that early learners can build a strong foundation in literacy. This will support about 300 students who need additional supports and interventions to gain reading proficiency.

Grant Need (3): IXL Math Grades 2-6

Amount: \$4,320

We also want to continue with our IXL Math subscription for grades 2-6, which reaches about 300 students throughout the year. This gives teachers a chance to remediate and enrich at the touch of a button, knowing the quality of learning is solid. IXL also has reports that can target areas of weaknesses so that all student achievement gaps are filled. Teachers can either assign their learning path, targeted to that specific student, or assign sections, which can be used to gain information as to what skills students have or need to sharpen.

School Name: Tri North Middle School # Students who live in the Enterprise Zone: 48

% of total enrollment: 9% Amount Requested: \$3,120 Tri-North Middle School is located at 1000 W. 15th St., just off West 17th St. The school serves families and communities on the north side of Bloomington and Monroe County. It students have attended Fairview, Highland Park, Arlington, and Marlin elementary schools. The school's enrollment is 545 with 42% of students eligible for free and reduced lunch. Students from Tri-North attend Bloomington High School North or The Academy for Science and Entrepreneurship.

Grant Need (1) PBIS Continued Amount: \$3,120

Tri-North has excelled in implementing its PBIS rewards. Expanding the program to hold our staff accountable is an important next step. Last year we started the process of building a program that rewards both teachers and students. Students receive weekly rewards for their ARMOR code and teachers and staff throughout the building would be recognized monthly for their positive contributions. This project has positively impacted student learning because it is fostering a positive learning environment that benefits students. Research shows that the classroom teacher has a significant effect on student learning and outcomes. By celebrating both students and staff, we anticipate improvements in attendance, grades, and the overall school environment. Funding this year will allow us to continue and refine the program.
