Matt motioned to move the BDWG update before WQ and Shannon seconded. All present voted yes. Mitchel abstained. The motion passed.

Special projects had not met.

### BDWG

- The BDWG met in December to talk about the group's goals. The BDWG needed input from the city and external stakeholders to continue pursuing Bee City USA certification. The BDWG had drafted the resolution needed for Bee City, and had been in touch with IU Sustainability and Parks and Rec.
- The BDWG anticipates that filling out the application and paying the fee, and receiving certification could happen in the spring.
- Rachael said Rebecca Swift mentioned it might be nice to have this figured out by Earth Day.
- Matt mentioned that Linda in the past had helped get things in front of council. Rachael agreed to do this for the Bee City USA project.
- Rachael met with Megan Blair, the GIS person with the city, and reported that Megan is available to meet with Matt over how to help update and improve the Habitat Connectivity map.

Abby Garcia mentioned that the formation of the committee would be the most difficult, which is the first step toward Bee City USA certification. Abby mentioned that Joanna and an additional person from Parks and Rec would be interested in being on that committee.

### WQWG

- The WQWG was unable to get an undergrad capstone course organized to work on water quality projects, including a stream buffer analysis project.

a. 2024 Annual Report - Nadia mentioned adding participation with the sustainability team's heat mapping project as an important mention. Mitchell mentioned that it could center around the theme of collaboration including the heat mapping project, the water quality group working with the city, and the bee city opportunity. Carrie mentioned that she will be presenting this to council, potentially including the Bee City resolution. Matt pointed out that the Annual Report presentation might end up being after Earth Day or Bee City certification.

b. Rachael mentioned that she had met with the Earth Day Celebration event organizers. The celebration will be April 19<sup>th</sup>, at Switchyard Park. Rachael confirmed with the EC that the EC still wanted EcoHeroes to happen at this celebration. She also mentioned that she filled out the application for the EC to have its own table at the event. The organizer also asked if the EC wanted to have a slideshow again this year during the EcoHeroes event, which Carrie said yes to because it acknowledges donors/ sponsors. Rachael asked how important it would be for the mayor to have a photo op with the winners, and Matt and Carrie agreed that it was preferable. The organizers also wanted to know the EC's theme for EcoHeroes. Rachael asked if additional materials and organizing would be possible for the commission members to do, as the Fellow will be gone after April, and has another project that is a priority. Shannon shared that a simple theme would be the best way for things to get done including choosing a theme, materials, outreach with educators, timing, and budget.

The EC members then discussed a possible theme. Fiona mentioned a pun on "in Bloom" to emphasize flowers. Matt mentioned "Decomposers, Predators and Pollinators, Oh My!" to emphasize the variety of ecological roles insects play. Karenna mentioned "Bugs in Bloom" to fuse these ideas, and allowing for broad interpretation. Fiona mentioned adding a secondary title to explain the relationship between native insects and plants. Nadia agreed that there should be a secondary part to expand on the role of bugs in Bloomington.

Karenna mentioned doing Bloomington's Big Bad Bugs in a future year, if the EC choses a theme less focused on pollination.

Fiona asked if there were any exclusively native plant nurseries in Bloomington. The other EC members mentioned a number of important native plant resources, including MCIRIS, Sycamore Land Trust, and Indiana Native Plant Society, however EC members collectively confirmed there are no native-only nurseries in Bloomington.

The Plan Commission was not environmentally friendly at the time, nor was a property rights group, or the Planning Director. He reflected that the city has improved immensely over recent years.

Shannon: Shannon will be giving a talk on her new book about ecology, which weaves together narratives of ecology in Southern Indiana. The talk will be at the Bishop at 6:30 pm on January 29<sup>th</sup>.

Karenna: Also shared she was leaving.

Rachael: Mentioned that an updated Native Landscaping brochure was created by Matt and printed copies were available.

### **RESOLUTION NO.**

A RESOLUTION of the Common Council of Bloomington, Indiana designating Bloomington as a BEE CITY USA® affiliate.

WHEREAS, the mission of BEE CITY USA is to galvanize communities to sustain pollinators, responsible for the reproduction of almost 90% of the world's flowering plant species, by providing them with healthy habitat, rich in a variety of native plants and free to nearly free of pesticides; and

WHEREAS, thanks to the more than 3,600 species of native bees in the United States, along with introduced honey bees, we have very diverse dietary choices rich in fruits, nuts, and vegetables; and

WHEREAS, bees and other pollinators have experienced population declines due to a combination of habitat loss, poor nutrition, pesticides (including insecticides, fungicides, and herbicides), parasites, diseases, and climate change; and

WHEREAS, pollinator-friendly communities can benefit local and regional economies through healthier ecosystems, increased vegetable and fruit crop yields, and increased demand for pollinatorfriendly plant materials from local growers; and

WHEREAS, ideal pollinator-friendly habitat (A) is comprised of mostly native wildflowers, grasses, vines, shrubs, and trees blooming in succession throughout the growing season to provide diverse and abundant nectar and pollen, since many wild pollinators prefer or depend on the native plants with which they co-adapted; (B) is free to nearly free of pesticides, as many pesticides can harm pollinators and/or their habitat; (C) comprises undisturbed spaces (leaf and brush piles, unmown fields or field margins, fallen trees and other dead wood) for nesting and overwintering; and (D) provides connectivity between habitat areas to support pollinator movement and resilience; and

WHEREAS, Integrated Pest Management (IPM) is a long-term approach to maintaining healthy landscapes and facilities that minimizes risks to people and the environment by: identifying and removing the causes of pest problems rather than only attacking the symptoms (the pests); employing pests' natural enemies along with cultural, mechanical, and physical controls when prevention is not enough; and using pesticides only when no other method is feasible or effective; and

WHEREAS, supporting pollinators fosters broad-based community engagement in environmental awareness and sustainability; and

WHEREAS, Bloomington should be certified as a BEE CITY USA community because the city has long been committed to planting pollinator friendly and native plants in its parks and public greenspaces. The city conducts regular weed wrangles (targeting invasives) and native plantings with volunteers, encourages and supports neighborhood pollinator gardens, and partners with a range of local organizations to run annual native plant sales (MC-IRIS), collect and distribute native seeds (Project Wingspan), improve the urban tree cover (Canopy Bloomington). In 2018, our city Mayor signed the monarch pledge. The Environmental Commission contributes to city-wide education focused on pollinators and

native plantings at our annual Bugfest, Earth Day events, our Ecoheroes contest for student<mark>s,</mark> and our habitat connectivity plan.

- NOW, THEREFORE, in order to enhance understanding among local government staff and the public about the vital role that pollinators play and what each of us can do to sustain them, Bloomington chooses to support and encourage healthy pollinator habitat creation and enhancement, resolving as follows:
  - 1. The Bloomington Environmental Commission is hereby designated as the BEE CITY USA sponsor.
  - 2. The Chair of the Environmental Commission is designated as the BEE CITY USA Liaison.
  - 3. Facilitation of Bloomington's BEE CITY USA program is assigned to the Environmental Commission.
  - 4. The Environmental Comission is authorized to and shall:
    - a. **Celebration**: Host at least one educational event or pollinator habitat planting or restoration each year to showcase Bloomington's commitment to raising awareness of pollinator conservation and expanding pollinator health and habitat.
    - b. **Publicity & Information**: Install and maintain at least one authorized BEE CITY USA street sign in a prominent location, and create and maintain a webpage on the Bloomington Environmental Commission's website which includes, at minimum a copy of this resolution and links to the national BEE CITY USA website; contact information for your BEE CITY USA Liaison and Committee; reports of the pollinator-friendly activities the community has accomplished the previous year(s); and your recommended native plant species list and integrated pest management plan (explained below).
    - c. **Habitat**: Develop and implement a program to create or expand pollinator-friendly habitat on public and private land, which includes, but is not limited to, Identifying and inventorying **Bloomington**'s real property that can be enhanced with pollinator-friendly plantings; creating a recommended locally native plant list to include wildflowers, grasses, vines, shrubs, and trees and a list of local suppliers for those species; and, tracking (by square footage and/or acreage) annual area of pollinator habitat created or enhanced.
    - d. **Pollinator-Friendly Pest Management:** Create and adopt an integrated pest management (IPM) plan designed to prevent pest problems, reduce pesticide use, and expand the use of non-chemical pest management methods.
    - e. **Policy & Plans**: Establish, through the Bloomington Common Council, a policy in the Bloominton Comprehensive Plan to acknowledge and commit to the BEE CITY USA designation and review the Comprehensive Plan and other relevant documents to consider improvements to pest management policies and practices as they relate to pollinator conservation, identify appropriate locations for pollinator-friendly plantings, and consider other appropriate measures.
    - f. **Renewal:** After completing the first calendar year as a BEE CITY USA affiliate, each February, if funding is available, apply for renewal of Bloomington's BEE CITY USA designation following the format provided by BEE CITY USA, including a report of the previous year's BEE CITY USA activities, and paying the renewal fee based on Bloomington's population.
