a. Updates for BMCMPO Projects (projects receiving federal funding allocated through the MPO)

(1) Neil Kopper shared for the City of Bloomington –

- **B-Line Trail extension (west of Adams) - work is mostly complete but a block of it adjacent to the railroad was delayed for environmental remediation - should wrap up in spring**

- 1st street project - road is open but final work
 - Crosswalks phase 2 just went to a successful bid letting
 - W 2nd Street Reconstruction project has been delayed - the environmental review by INDOT was delayed (original May letting but letting has been pushed past the INDOT fiscal year and now anticipate August letting) - funding is being shifted into a mixture of other city, county, INDOT and transit projects.
 - High St project is in right of way acquisition right now
 - N Dunn Street MultiUse Path Project is starting with design consultant selection; there will be a public meeting scheduled for March 27 (in-person only) at Lower Cascades Park – [meeting information here](#)
 - Crosswalks Phase 3 got approval from INDOT to move forward with using federal funds for preliminary engineering.

- Sunrise greetings overpass - setting beams in middle of march; project should be complete in July/August
