The meeting began with a welcome to Brad Whistler, representing the Plan Commission.

The February minutes were unanimously approved by roll call.

Director's Report

De reported on two upcoming outreach efforts: an info session for CFC tenants about tax benefits and available grants and an "8-1-2 Podcast" appearance to promote BUEA programs. She's initiating an RFP process to secure marketing support.

The service contract for EZID consulting is under internal review and will be finalized soon. Tax filings are due May 15, and early submission is encouraged to allow time for corrections. De also gave a brief overview of the EZID program for new members.

A draft proposal for the Rapid Response Fund loan forgiveness program is under review. The plan prioritizes relief for borrowers still facing hardship and is expected to come before the board in April.

Financial Updates

Board members expressed concerns regarding the absence of recent financial reports. At the next meeting, Cheryl will present the year-end 2024 financials and the 2025 year-to-date data. In the meantime, a new interdepartmental payment tracking system has been implemented to resolve processing delays.

To date, approximately \$110,000 has been committed to 2025 grant funding. In 2024, the board disbursed \$140,500 in arts and culture grants and \$40,000 in zone improvement funds.

There was some discussion about unspent funds from 2024—around \$9,500 left in arts and culture and just under \$35,000 in zone improvement. The group generally agreed these funds could potentially be carried over

or reallocated to 2025 grant lines, especially given the strong early demand for things like business building improvements. Several members emphasized looking at actual financials and tracking committed and disbursed amounts before making decisions. The board will continue to explore this topic next month when they have the full financial report.

Grant Requests

Warehouse Community Center requested \$25,000 for kitchen upgrades. The project was seen as valuable, but the request would exceed the current budget line. The board tabled the request pending a more detailed estimate and a presentation from the applicant.

Gold Dust Records requested \$3,000 for interior improvements. The board approved the grant, contingent on clarification about the signage's compliance with city code.

The Mill requested funding for ADA-accessible entry doors. Board members expressed general support but raised questions about city responsibility and the frequency of prior requests. The application was tabled pending clarification on funding sources, cost breakdowns, and ADA obligations in city-owned properties.

Next Steps

- Cheryl will prepare updated financials for the next meeting.
- De will follow up with grant applicants, distribute original grant guidelines, and provide information on The Mill's financial relationship with the city.
- The board will review current budget allocations and consider whether to reallocate unspent 2024 funds.

BUEA Director's Report - April 2025

RRF Loan Conversion Program

As part of the City's continued commitment to post-pandemic economic recovery, staff proposes converting outstanding Rapid Response Fund (RRF) loan balances into grants for eligible small businesses. This approach prioritizes those experiencing ongoing financial hardship and aligns with BUEA's mission to support business stability and enterprise zone revitalization.

The following is a very high-level listing of the areas addressed in the draft proposal

- Eligibility Framework:
 - Prioritized for borrowers demonstrating sustained financial hardship.
 - Non-profits are automatically eligible; active, financially stable borrowers are excluded.
- Application Process: Requires business info, financial documentation, and hardship verification.
- Approval Structure:
 - Staff-led compliance review followed by BUEA committee evaluation.
 - Formal notification and agreement for approved borrowers.
- Accounting Impact:
 - Loans reclassified as grant disbursements, reflected in 2025 budget adjustments.
 - \circ $\;$ Treated as economic recovery grants rather than defaults.
- Compliance Measures:
 - Documentation, borrower certification, and optional post-conversion impact reporting.
- Implementation Timeline: 6-month rollout from program buildout to final approvals.

We continue to work on details with the mayor's office, the office of the controller, and legal.

Grant Application and Submitted Applications Update

Four grants and one scholarship application were submitted within days of The 812 podcast interview. This has revealed some challenges with our current grant applications. Recently submitted applications have not included some items as they are defined in the guidelines for submission but not explicitly stated in the application. Staff has either added or request the following:

- Section to upload written consent from landlord/property owner
- Section to include a simplified budget for funding requests reflecting the match funds of the applicant.
- Request to change the language of "If you are applying for the Business Building Improvement Grant, can you match up to 50% of your total <u>funding request</u>?" to "If you are applying for the Business Building Improvement Grant, can you match up to 50% of the <u>total project cost</u>?

The Mill -

- The board requested clarification regarding the following:
 - Funding received by the Mill from the City.

- The Mill received 175k from the city this year to support its various programs. However, the City does not provide operating funds.
- Terms of the Mill's lease agreement, as it is a City-owned building under the RDC's purview
 - The lease states that the Mill must have written consent before altering the building.
 - The RDC is only responsible for the doors if they need <u>necessary</u> replacement.
- Corrections/clarifications on the total funding request
 - The staff has requested that the Mill provide a budget including their matching funds.
- ADA requirements in city buildings
 - All city buildings are required to abide by the minimum ADA requirements. However, the Mill is making efforts to enhance accessibility for both its members and its membership at large.

The Warehouse

• Staff has requested a formal quote for the flooring improvements. We will discuss and clarify the details of the application and formal request.
