- I. Call to Order and Introductions Meeting convened at 1:32pm with Lisa Ridge, Chair presiding.
- II. Approval of Meeting Agenda\* \*\*Cibor moved for approval of the meeting agenda. Stosberg seconded. Motion carried by a voice vote (11-0).\* APPROVED

  - a. Kennedy, CAC representative, shared that the CAC recommended approval of the TIP amendment and UPWP (on today's PC agenda) at their March 26<sup>th</sup> meeting.

- VI. Reports from the MPO Staff
  - a. <u>BMCMPO FY 2026-2030 Transportation Improvement Program (TIP)</u> update Gandhi shared that the FY 2026-2030 TIP has been submitted to INDOT and Federal Highway and Federal Transit for review and approval.
  - b. <u>BMCMPO 2050 MTP</u> update Gandhi shared that the BMCMPO 2050 MTP has been submitted to INDOT for review and approval. Faris requested that the committee consider voting to amend the MTP so that any SR45/10<sup>th</sup> St projects, which are

currently listed as a near-term/programmed projects in the MTP, also be listed as longterm project. Faris summarized the existing safety concerns for SR45/10<sup>th</sup>. Ridge shared there have been discussions about INDOT's recent installation of the all-way stop and whether or not there may be other solutions, at the local or INDOT level, for upgrading that intersection to a stop light (or something else besides an all-way stop) while the road updates are under design. Discussion ensued.

Gandhi shared information about the most recent INDOT TIP amendments as detailed in the attached memo. Stosberg inquired about the reason for the shift; Wahlman

shared that the funding was moved up because they have another group of thin deck overlays on I-69 so they wanted to bundle them.

Ridge asked if all funds are allocated and used each year. Stosberg and Faris asked about and commented on public participation and visibility for this document. Discussion ensued.
