

This figure represents a 20.1% increase in 2025.






CRIME INVOLVING WEAPONS

- A firearm has been reported in 58 incidents in 2025 and were fired at a person in 13 of those incidents.




2024-2025 Adult Arrests






2024-2025 Juvenile Referrals

I am so glad that we have a Mayor that has supported law enforcement with changes that enhance their quality of life and ours.

I'm writing today to sincerely thank you and the Bloomington Police Department for doing what you can to help protect vulnerable residents of Bloomington.










BFD Incident Types



Incident Types on the IU Campus








Response Times/Goals (1st arriving) FIRE calls for July 2025


Travel Time for 1st fire suppression apparatus on fire suppression incidents 90th Percentile: 00:08:19



All Responses for July 2025




Inspection Division's Activity July 2025


