# Two Items for Discussion at the Committee of the Whole on Wednesday, February 28<sup>th</sup>

There are two items ready for discussion at the Committee of the Whole next Wednesday. The first item, <u>**Res 07-01**</u>, allocates CDBG funds for 2007 and can be found in this packet. The second item, <u>**Ord 07-03**</u>, amends Title 8 (Historic Preservation) and Title 17 (Construction Regulations) to account for changes to the demolition delay procedures enacted in the Unified Development Ordinance and can be found in the <u>21 February 2007 Legislative Packet</u>

# Res 07-01 - CDBG Allocations for 2007

# Amount of Funds and HUD Regulations

**<u>Res 07-01</u>** approves the Mayor's recommendations for allocating the Community Development Block Grant (CDBG) funds for 2007. We receive CDBG funds from the Housing and Urban Development (HUD) Department and our portion, as an "entitlement" city, is largely determined by several objective measures of community need, including: level of poverty, age of housing stock, over-crowded housing, and population growth. This year we expect to receive \$743,750, which is about \$113,688 *less* than we received last year. Please note that the City will not be able to augment these funds from program income or unspent funds as it has been able to do occasionally in the past.

## In the Event of a Shortfall

Since it's possible that HUD may send us more or less than the expected amount of funds, the resolution directs that the amount received be equally and proportionately distributed among the recipients. *(See Section II of the Resolution)* 

# **Eligible Activities and Projects**

HUD administers these monies and regulates their use. Their regulations require that we use the bulk of these funds (at least 70%) for the benefit of low and moderate income persons. The remaining funds may be used to prevent or eliminate blighted areas or to address community development needs arising from serious and immediate threats to the health or welfare of the community. Please note that currently all our funds are leveraged to address low Moderate income populations. Please also note that these funds may not be used to purchase equipment or maintain property.

The HUD regulations allocate the funds to three categories of activities according to the following formula:

- no more than 15% of the funds may be spent for social service programs. As the City has done in the past, the full 15% (or \$111,000) will go for that purpose;
- no more than 20% may be used for administrative costs and, as has been the case for the past term, the legal maximum (amounting to \$148,750) will be used for that purpose; and
- the remaining 65% (or \$484,000) must be used for physical improvements.

# CACs, Agencies, and their Schedules

The CDBG regulations require us to develop a "Citizen Participation Plan." For decades, the City has used two Citizen Advisory Committees (CACs) to make recommendations regarding the allocation of these funds. These CACs are composed of members from the Common Council (2), Redevelopment Commission (2), Community and Family Resource Commission (4), as well as Mayoral appointees (12). One CAC reviews applications for social services funds (with Andy Ruff as the Council representative) and the other reviews applications for physical improvement funds (with Timothy Mayer as the Council representative).

The two CACs typically work from November through January to make these recommendations. In the fall they hold an organizational meeting, may make site visits to the agencies, and review the ranking system and funding formulae. In January, they hold public hearings to consider and make recommendations regarding the applications that were submitted to the Housing and Neighborhood Development (HAND) Department in early December. In February, the Redevelopment Commission reviews the recommendations and forwards its decision to the Mayor, who then forwards them to the Council. The recommendations this year, as in past years, have come forward without change.

The agencies are on a schedule that begins in August, when the applications are available for them to pick up. In September, they have an opportunity to attend a general information meeting, and must submit their letter of intent. They must attend a training session later that month and must submit their finished application by early December.

# **<u>\$111,000 Funding for Social Services</u>**

The disparity between the amount of funds available and the amount funds requested is always most evident with social services programs. Nine programs sought approximately \$225,000 (which amounts to about twice the available funds) and six were recommended for funding. This year, as in the past, the committee ranked the applications on a 50-point rating system and made its initial decision based upon their score and without knowing the names of the agencies. As a result of this process about two-thirds of the funds went to emergency services. The ranking was tied to how well the applicant:

- documented the need for the program in this community (15);
- demonstrated that it primarily serves low-income individuals and residents of the City (10);
- demonstrated its ability to evaluate and document the effectiveness of the program (15);
- detailed the use of the funds and demonstrated that at least 50% of the funding comes from other sources (5); and
- were valued by the evaluator of the program (5).

## **<u>\$484,000 in Funding for Physical Improvements</u>**

This year the CAC for Physical Improvements changed the method of ranking proposals in order to tie the ranking to the *Consolidated Plan* rather than a general set of criteria. The citations to the *Consolidated Plan* are listed in the packet and the *Consolidated Plan* itself can be found at:

Of the \$484,000 set aside for physical improvements, the CAC recommended allotting \$384,000 for housing, \$65,000 for improving an agency facility, and \$35,000 for community-wide infrastructure programs. Broken down in a different way, approximately \$232,000 will go to City departments, \$50,000 will go to the Bloomington Housing Authority, \$202,000 will go to non-profit agencies. The major role of the City and City agencies is largely explained by the broad effect of those programs compared to programs run by agencies. The particular projects are set forth below:

### **RESOLUTION 07-01**

### TO APPROVE RECOMMENDATIONS OF THE MAYOR FOR DISTRIBUTION OF COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS FOR 2007

- WHEREAS, the City of Bloomington, Indiana, is eligible for Community Development Block Grant (CDBG) funds in the amount of \$743,750.00 for Fiscal Year 2007 pursuant to the Housing and Community Development Act of 1974 as amended; and
- WHEREAS, the national objectives of the Community Development Program are:

1. first and foremost, the development of viable urban communities, including decent housing and a suitable living environment and expanding economic opportunities principally for person of low and moderate income; and

2. the elimination of slums and blight, and the prevention of blighting influences and the deterioration of property and neighborhood and community facilities of importance to the welfare of the community, principally for persons of low and moderate income; and

3. the elimination of conditions which are detrimental to health, safety, and public welfare, through code enforcement, demolition, interim rehabilitation assistance, and related activities; and

4. the conversion and expansion of the nation's housing stock in order to provide a decent home and suitable living environment for all persons, but principally those of low and moderate income; and

5. the expansion and improvement of the quantity and quality of community services, principally for persons of low and moderate income, which are essential for sound community development and for development of viable urban communities; and

6. the integration of income groups throughout the community by spreading persons of lower income into more prosperous neighborhoods and drawing persons of higher income to declining or deteriorated neighborhoods; and

7. the alleviation of physical and economic distress through the stimulation of private investment and community revitalization; and

- WHEREAS, a proposed statement of community development objectives and projected use of the funds has been advertised; and
- WHEREAS, said statement and projected use of funds reflects programs recommended by the Mayor with input from the Citizen's Advisory Committees and the Redevelopment Commission and are consistent with local and national objectives of the Housing and Community Development Act of 1974, as amended;

### SYNOPIS

The City of Bloomington is eligible for a Community Development Block Grant of \$743,750 from the Department of Housing and Urban Development for fiscal year 2007. This resolution allocates that funding. It outlines program recommendations by the Mayor with input from the Citizen's Advisory Committee and the Redevelopment Commission. General program areas include: Social Service Programs, Physical Improvements, Housing Programs, Neighborhood Improvements, and Administrative Services.

### 07-04 RESOLUTION OF THE REDEVELOPMENT COMMISSION OF THE CITY OF BLOOMINGTON, INDIANA

**WHEREAS**, the City of Bloomington, Indiana, is eligible for Community Development Block Grant (CDBG) funds in the amount of \$743,750 for Fiscal Year 2007, the following allocations are recommended:

65% = \$484,000 for Physical Improvements
15% = \$111,000 for Social Services
20% = \$148,750 for the Administration of the program; and

Re: 2007Community Development Block Grant Allocations

The Department of Housing and Urban Development (HUD) defines an entitlement community as one that is a metropolitan city with a population of at least 50,000. Bloomington meets that threshold and is therefore eligible for Community Development Block Grant (CDBG) funding. The annual funding is formula based and is based on several objective measures of community need; 1) poverty in the community, 2) housing overcrowding, 3) age of housing stock, and 4) population growth. For Fiscal Year 2007-2008, we estimate receiving \$743,750 in CDBG funds. As of today, we do not have a firm amount for our 2007-2008 allocation.

The activities that will receive funding are divided into 3 distinct categories: physical improvements, social services and administration. By law, no more than 15% of the total grant may be used for social services and no more than 20% may be used for administration. The other 65% is used for physical improvements.

CDBG funds must be used to benefit low and moderate income persons, prevent or eliminate slum and blight and/or to alleviate conditions that pose immediate and serious threat to the health or welfare of the community. I have included in this packet excerpts from the CDBG regulations on eligible and ineligible activities.

HUD requires each entitlement community to develop a citizen participation plan. This plan sets out procedures for public input into the allocation process. The City of Bloomington has an extremely open process for public input. The allocation recommendations are made by the Citizen Advisory Council (CAC) which is made up of citizens from various councils and commissions, as well as interested parties who apply for appointments. See attached membership list. The CAC is divided into two sub-committees, one to review physical improvement applications and one to review social service applications. Attached please find copies of the schedules. In addition to each sub-committee's public hearing, the Redevelopment Commission meeting is also open to public comment.

I have included in this packet, a brief description of each program and recommended allocation amount. Also attached is Redevelopment Commission Resolution 07-04 in which they unanimously forwarded on the CAC recommendations to Mayor Kruzan. Common Council Resolution 07-01 will confirm the recommendations of the CAC, the Redevelopment Commission and the Mayor.

### **CDBG ELIGIBLE AND INELIGIBLE PROJECTS**

(Excerpts from the CDBG regulations)

#### 570.201 - Basic Eligible Activities

- (a) Acquisition of real property.
- (b) Disposition of real property.
- (c) Public facilities and improvements. Acquisition, construction, reconstruction,

rehabilitation or installation of public facilities and improvements.

- (d) Clearance activities.
- (e) Public services: Provision of public services (including labor, supplies, and materials) which are directed toward improving the community's public services and facilities; including, but not limited to those concerned with employment, crime prevention, child care, health, drug abuse, education, fair housing counseling, energy conservation, welfare, or recreational needs.
- (f) Interim assistance. Activities undertaken on an interim basis in areas exhibiting objectively determinable signs of physical deterioration. And activities to alleviate emergency conditions threatening the public health and safety.
- (n) Homeownership assistance. Acquisition, down payment and closing cost assistance to low- or moderate-income homebuyers.
- (o) Microenterprise Assistance.

### 570.202 – Eligible Rehabilitation and Preservation Activities

- (a) CDBG funds may be used to finance the rehabilitation of :
  - (1) Privately owned buildings and improvements for residential purposes;
  - (2) Low-income public housing and other publicly owned residential buildings and improvements; and
  - (3) Publicly or privately owned commercial or industrial buildings, except that the rehabilitation of such buildings owned by a private for-profit business is limited to improvements to the exterior of the building and the correction of code violations.
  - (4) Nonprofit-owned nonresidential building and improvements not eligible under 570.201 (c).
- (b) Types of assistance. To assist various types of rehabilitation activities, and related cost for buildings and improvements described in paragraph (a) of this section.

- (c) Code enforcement.
- (d) Historic Preservation: CDBG funds my be used for the rehabilitation, preservation or restoration of historic properties, whether publicly or privately owned.
- (f) Lead-based paint hazard evaluation and reduction.

### 570.203 – Eligible Special Economic Development Activities

(a) The acquisition, construction, reconstruction, rehabilitation or installation of commercial or industrial buildings, structures, and other real property equipment and improvements.

### 570.204 – Special Activities by Community-Based Development Organizations (CDBOs)

(a) Eligible activities.
(1) Neighborhood revitalization projects.
(2) Community economic development projects.
(3) Energy conservation projects.

### <u>570.205 – Eligible Planning, Urban Environmental Design and Policy-Planning-</u> <u>Management-Capacity Building Activities</u>

- (a) Costs of data-gathering, studies, analysis, and preparation of plans and identification of actions that will implement such plans.
- (b) Policy-planning-management-capacity building activities.

### 570.206 – Program Administration Costs

### 570.207 – Ineligible Activities

(a) The following activities may not be assisted with CDBG funds:
(1) Buildings or portions thereof, used for the general conduct of government;
(2) General government expenses; and
(3) Political activities.

### (b) The following activities are generally ineligible for CDBG funds:

- (1) Purchase of equipment;
- (2) Operating and maintenance expenses; and
- (3) Construction of new permanent residential structures.
