The commission went over the responses to questions posed at the previous meeting.

The city does not plan to undertake this project due to state-level changes to local government funding alongside the fact that the city is currently undergoing its own budgeting process.

Joanna Sparks mentioned that lack of resources for maintenance is a concern. Native plants usually require less maintenance, but the difficult downtown environment may negate that benefit

Shannon suggesting planting a tree may be a better solution, but Joanna mentioned issues with utilities.

How to Make Your Grass "Greener"

With an Easy Change of Routine

Bloomington, Indiana, is known as pretty place for a bunch of reasons that residents recite with pleasure. And one favorite is our lawns, those charming green carpets surrounding our houses that we tend with pleasure ("Honey—don't forget to cut the grass!").

But we're also responsible for the good, green, planet Earth. And that's the point at which cranking up the mower has begun to raise some questions. Your gasoline-powered lawn mower (and your leaf blower) spew lots of Earth-warming, greenhouse gases.

According to scientists at Princeton University, running a lawn mower for an hour produces as much air pollution as driving a car 500 miles.

How do you change your lawn-mowing routine? A good first step may be to share your concerns by chatting with your neighbors, especially if you're planning to mow less often (and risk neighbors' complaints!). You may hear that they're thinking the same way, and you can compare strategies.

Here's what Princeton suggests:

- 1. First and best: cut how often you mow—go from once a week to once every two weeks, for example. This should improve the health of the lawn because taller grass improves moisture retention in the soil. (And you may be surprised to see your lawn looking just as nice on a two-week routine.)
- 2. Mow in the evening. "During the day, ozone forms more easily," Princeton notes. "Mowing at evening gives these chemicals time to disappear overnight because they lack sunlight."
- 3. Reduce your use of other landscaping tools that are gasoline-powered: hedge trimmers, weed whackers, chippers, shredders.

What about avoiding the greenhouse-gas problem by switching to electric-powered mowers and trimmers? Sure, shop around. You may find discounts as the growing season winds down in the fall.

But suppose you've hired a lawn-maintenance company to do all the cutting and trimming. And you've contracted for weekly service over a stated number of months at a fixed rate.

Our advice: talk it over with your contractor. See if you can find common ground by explaining that your objective is to reduce greenhouse gases. See if you can adjust your lawn-cutting routine, maybe keeping the service fee the same but covering a longer period. That'll help keep your contractor going and give him or her room for new customers and new services.

Our research finds that landscapers are responding to the reduced frequency of lawn-cutting by expanding services to include sustainable, low-maintenance, and high-value offerings, like...
