CALL TO ORDER

Board President Debro called the regular meeting of the Utilities Service Board to order at 5:01 p.m. The meeting took place in the Utilities Service Boardroom at the City of Bloomington Utilities Service Center, 600 East Miller Drive, Bloomington, Indiana.

MINUTES

White moved, and Sherman seconded the motion to approve the Regular Meeting minutes of the 9/22/2025 meeting. Motion carried, six ayes.

CLAIMS

Standard Invoice Questions

Burnham referenced page eight of the claims list, seeking clarification on an item labeled "Type R Class 2 short sleeve t-shirts." Burnham asked whether the \$800 charge reflected the purchase of two shirts or if "Type R Class 2" referred to a classification. Assistant Director of Finance – Havey confirmed that the description indicates a safety standard, not the quantity, and that the purchase was for safety apparel rather than two individual shirts. Ehman inquired about entries on page six, noting that two John Deere financial charges appeared to be the same claim but were listed on separate lines—one charged to water and one to another division at a 60/40 split. Ehman observed that this format was atypical and asked for clarification. Havey confirmed that the entries appeared accurate but stated they would continue reviewing the invoice to verify the reason for the split. Later in the meeting, Havey clarified that the charge was likely for two separate toolboxes.

White moved, and Board member Sherman seconded the motion to approve the Standard Invoices:

Invoices included \$333,898.93 from the Water Fund, \$13,203.89 from the Water Construction Fund, \$247,595.25 from the Wastewater Fund, \$61,465.73 from Wastewater Construction Fund, and \$42,081.79 from the Stormwater Fund.

Motion carried - six ayes. Total claims approved: \$698,245.59

White moved, and Sherman seconded the motion to approve the Utility Bills:

Invoices included \$621.54 from the Water Fund, \$16,871.54 from the Wastewater Fund, and \$56.73 from the Stormwater Fund.

Motion carried - six ayes. Total claims approved: \$17,549.81

White moved, and Sherman seconded the motion to approve the Wire Transfers, Fees, and Payroll for \$633,392.71. Motion carried - six ayes.

White moved, and Sherman seconded the motion to approve the Customer Refunds for \$545.76. Motion carried - six ayes.

CONSENT AGENDA

CBU Director – Zaiger presented the following items recommended by staff for approval

a. Water Solutions Unlimited, Inc., \$9.50 per gallon, 2025 Supply of Copper Sulfate at Monroe Water Plant

Consent Agenda was approved as presented. Total approved: \$0.00 (Non-chemical contracts)

REQUEST APPROVAL OF FIRST AMENDMENT TO SERVICE AGREEMENT WITH MACALLISTER MACHINERY CO., INC.

Assistant Director of Environmental Division – Thetonia presented a request for approval of the first amendment to the service agreement with MacAllister Machinery Company, Inc. Thetonia explained that the amendment corrects a minor scrivener's error in the original contract language. The intent of the agreement was for the contract to renew for two additional years following the initial term. The amendment also clarifies that the amounts for years two and three differ from year one, reflecting variations in the scope of work related to generator inspection and maintenance, which changes annually. Thetonia noted that all other terms remain consistent and invited questions from the board.

White moved, Sherman seconded to approve Amendment No.1 with MacAllister Machinery Co., Inc. - six ayes.

REQUEST APPROVAL OF FIRST AMENDMENT TO SERVICE AGREEMENT WITH POTOMAC ELECTRICAL SERVICES, LLC

Assistant Director of Operations – Ortiz presented a request to amend an existing contract, explaining that the purpose of the amendment is to extend the contract term by three years rather than the three months originally specified. Ortiz invited questions from the board.

White moved, Sherman seconded to approve Amendment No.1 with Potomac Electrical Services, LLC - six ayes.

REQUEST APPROVAL OF RESOLUTION 2025-20 FOR THE SALARIES OF APPOINTED OFFICERS, NON-UNION, AND A.F.S.C.M.E. EMPLOYEES FOR THE CITY OF BLOOMINGTON UTILITIES DEPARTMENT FOR 2026

CBU Director – Zaiger requested the board's review and approval of the 2025–20 resolution establishing salaries for appointed officers, non-union, and A.F.S.C.M.E employees of City of Bloomington Utilities for 2026. Zaiger noted that the resolution recommends changes to the salary ordinance, detailed in the accompanying memo and summarized in the presentation slides. Zaiger explained that while no new positions are being proposed, several existing roles are being reclassified or adjusted following the implementation of the Crow salary study and updates made by the new administration and HR department. These revisions, accumulated over the past few years, include a total of ten positions and nine formal requests to council for consideration. White asked whether the proposed adjustments were the result of recommendations made by Crow or subsequent internal reviews. Zaiger responded that some reviews were completed during the Crow study, while others were done later using the same classification rubric. Zaiger provided examples, including reclassifying the Administrative Assistant to the Director as an Office Manager to better reflect the actual scope of duties and restructuring a Communications Operator position into a Lead Communications Operator to handle new responsibilities such as 811 requests and walk-in reception duties. Zaiger also noted that an Administrative Assistant position was being reclassified to serve all of Operations rather than a single plant. White followed up expressing concern that classification changes should not be used as a means to provide raises without corresponding changes in job responsibilities. White emphasized the importance of external review to maintain the integrity of the classification system. Zaiger confirmed that all changes were reviewed by the city's HR department and their consultant, who specializes in classification and benefits. Zaiger added that all proposed reclassifications reflect actual changes in duties or organizational structure. Zaiger cited an example from the Engineering Division, where one of three Utilities Technician positions is being converted to a Plan Central Coordinator due to the employee's expanded responsibilities in plan review. Zaiger also noted that two positions—including the K9 unit—were eliminated earlier in the year to balance the proposed changes, resulting in a minimal net fiscal impact. Flaherty asked whether the City of Bloomington Utilities follows the same workforce evaluation and realignment process used by other city departments. Zaiger confirmed that the process is identical, though Utilities operate under separate budget constraints from the City's general fund. Flaherty summarized the sequence of prior salary adjustments, including reclassifications under the Crow study and the implementation of a step system, and asked if the current proposal represented the next phase in updating job descriptions and classifications. Zaiger confirmed, calling his summary "an excellent assessment." Parmenter asked whether any other positions had been reviewed but not proposed for reclassification. Zaiger began her answer by saying that this process is not meant to be a "We're not satisfied with the results of Crow, so we're going to try to use this [process] to change it." This process is truly meant to reflect job changes, and update inaccurate job descriptions. Zaiger then explained that each division submits recommendations through internal memos, which are then consolidated and prioritized based on budget availability. Zaiger clarified that the current proposal does not represent the full list of requests but those deemed most pressing and feasible within the current budget. Ehman asked what the sum total of the fiscal impact of these changes was. While she didn't have an exact number handy, Zaiger reported that, including the elimination of two positions midyear, the total budget impact of the proposed changes would be less than \$9,000. Parmenter confirmed that, if approved by the board and subsequently by City Council, the changes would take effect January 1. Zaiger affirmed and added that several positions included in the proposal are also transitioning from part-time to full-time status as part of the reclassification process.

White moved, Sherman seconded to approve Resolution 2025-20 - six ayes.

REQUEST APPROVAL OF EMERGENCY CONTRACT WITH SET ENVIRONMENTAL, INC.

Hazmat Coordinator – Isabelle Quiroz presented an emergency contract with SET Environmental in the amount of \$5,402.07 for emergency response services related to a chemical spill at the Monroe Water Treatment Plant. Ehman asked what had occurred. Quiroz explained that the incident involved an uncontained two-gallon spill of copper sulfate near the plant's intake tower. While the spill posed no risk to personnel or public health, the close proximity to the lake warranted an emergency response and reporting to regulatory agencies. Quiroz provided details of the incident, clarifying that the spill originated from a small chemical storage building near the intake tower, not within the tower itself. Parmenter then inquired about potential staff exposure and related safety protocols. Quiroz confirmed that no employees were exposed or placed at risk, but that emergency response was initiated due to environmental precautions and reporting requirements. Parmenter asked whether preventive measures were being considered to avoid future incidents. Quiroz explained that every time there is an incidental spill, an analysis of what happened is completed as well as an identification of opportunities to prevent the spill from happening again. Quiroz went on to say a root cause analysis had already been completed, identifying the issue as a valve leak caused during nearby repair work. The valve has since been fully sealed, and corrective actions implemented. Parementer noted that incidents like this underscore the need for continued infrastructure investment through the water rate case to reduce recurring maintenance-related hazards. White asked about containment and safety procedures at the chemical storage site. Quiroz confirmed that all chemical tanks are stored within a building designed with 110% capacity for containment, and that if the spill is big or risks the safety of the workers, then emergency response is called. Quiroz added that for this particular response, SET Environmental came to site within two hours for cleanup. Ehman asked about the hazards of copper sulfate. Quiroz explained that the substance is acidic and corrosive but not highly toxic in the small quantity released. Quiroz added that there are thresholds that need to be taken care of depending on each chemical, which includes reporting the issue to the appropriate channel. This particular spill was a very small one, approximately two gallons, Quiroz added. City Legal – Wheeler noted that the contract with SET Environmental was still being routed for approval and requested that the board's motion specify approval pending review by the Controller's Office. The board acknowledged the request, and agreed to proceed accordingly.

White moved, Sherman seconded to approve the agreement with SET Environmental, Inc. - six ayes.

OLD BUSINESS: Burnham revisited a prior discussion regarding charges to the City's Fleet Department, noting that earlier in the year, staff had identified approximately \$120,000 in outside repair work conducted independently of Fleet services. Burnham recalled that at the March 25 meeting, the board had requested a detailed breakdown of those costs to better assess the value of Fleet's services, including a comparison of expenses incurred through Fleet versus external vendors. Burnham emphasized the importance of having this information available before upcoming negotiations with Fleet, citing concerns about both cost-effectiveness and response time for vehicle repairs, particularly for vehicles essential to public safety. She expressed a desire for the utilities department to have a clear understanding of the financial and operational trade-offs before finalizing any new agreement. Havey responded that staff are close to finalizing the requested summary and have been working with external vendors to collect the necessary data. Burnham expressed appreciation that the issue had not been forgotten and reiterated the importance of completing the review before the next round of negotiations. Havey added that the delay was primarily due to the complexity of gathering and verifying the data. Burnham acknowledged the challenge but stressed the need to have the analysis ready within the year to ensure informed decision-making.

DATE: October 15, 2025

The CBU Pretreatment Group recommends updates to the Bloomington Municipal Code Title 10 - Wastewater for the following reasons:

- 1. The current rates and charges of the sewage works of the City for hauled wastewaters were established by Common Council under Ordinance 00-34 on September 13, 2000, with said rate adjustment taking effect on September 15, 2000.
- 2. Inflation has substantially increased the Consumer Price Index and Construction Cost Index since September 2000, rendering the cost of such service substantially more expensive.
- 3. Rates currently charged by CBU for hauled wastewater are insufficient to cover the cost of treatment, administration, and billing for the acceptance and treatment of hauled wastewaters.

The City of Bloomington Utilities (CBU) has historically accepted hauled wastewater for treatment at its Dillman Road wastewater treatment plant as a service to local residents and businesses located beyond the reach of its sewage collection system. This practice has continued as a means of enhancing community quality of life by providing safe, sustainable, cost-effective wastewater services while promoting public health, economic vitality, and environmental stewardship.

Billing rates for this service have remained unchanged since September 2000 (Ordinance 00-34). Since that time, the Consumer Price Index for All Urban Consumers has increased by 86 percent (https://fred.stlouisfed.org/series/CPIAUCSL) and the construction cost index has increased by nearly 218 percent (Engineering News Record).

In 2024, CBU commissioned Crowe LLP to study and analyze operating and financial reports and other data pertaining to calculate an appropriate rate that can be charged to domestic septage haulers who deposit waste at CBU's treatment facilities. An appropriate rate was determined by Crowe LLP considering the following direct expenses for rendering such service:

- (1) Strength Charge: charge to recover bulk waste haulers' share of annual revenue requirements incurred by CBU based on the strength of waste deposited, relative to average waste treated by the facility.
- (2) Bulk Waste Specific Expense Charge: charge to recover the labor and testing activities undertaken by CBU staff in order to accept bulk waste.

(3) Billing Charge: charge to recover a share of billing expenses incurred by the CBU allocable to domestic bulk waste haulers.

Based on the typical strength of septage reported by EPA (1994) and factors specific to CBU's operations, Crowe LLP determined that a billing rate of \$0.175 per gallon for domestic septage would provide the revenue corresponding to the cost of treatment, CBU staff activities, and billing charges.

CBU's current rates are structured such that septage haulers are charged an equivalent of \$0.0206 per gallon. Grease wastes are accepted at a billing rate equivalent to \$0.0589 per gallon. Wastewater treatment plant waste (occasionally received from neighboring facilities) and commercial/industrial waste are billed at a rate of \$0.0442 per gallon. CBU's Pretreatment Group finds that the different rates charged for the differing hauled wastewaters has little basis in cost of treatment or providing such services as each of the four wastewater categories typically exhibit strength of the same magnitude. As such, a single, uniform rate is appropriate for the four (4) different categories of hauled wastewater listed in the sewer use ordinance.

While a billing rate of \$0.175 per gallon is indicated in Crowe LLP's study, immediate implementation of this rate is likely to be disruptive to the current waste hauler's market and counterproductive for CBU's mission of promoting environmental stewardship. Such a rate would represent an increase ranging from 297 percent for grease waste to nearly 850 percent for domestic septage. A step-wise or phased implementation is therefore recommended.

Based on the available information and CBU's evaluation of current hauled wastewater rates in the central and southern Indiana market, a uniform rate of \$0.08/gallon is recommended at this time for implementation beginning January 1, 2026.

Regarding financial impact to customers hauling wastewater to CBU for treatment, the rates and charges recommended herein are nondiscriminatory, reasonable, and just. The recommended rate is based upon the cost of providing service to the customers of the Sewage Works and will enable the City to meet its legal revenue requirements for the Sewage Works. Finally, the CBU Pretreatment Group notes that the recommended rate of \$0.08 per gallon is approximately one half of the state average for septage of \$0.179 per gallon reported by the IDEM in 2024, and therefore comprises a logical phased increase towards CBU's actual costs of about \$0.175 per gallon.
