#### BLOOMINGTON BOARD OF PUBLIC SAFETY

The Bloomington Board of Public Safety held a Special Session on Wednesday, September 24, 2025 at 3:10pm, in the McCloskey Room, Room 135, City of Bloomington located at 401 N. Morton Street, Bloomington, Indiana.

#### **CALL TO ORDER**

Board President Timothy Brinson called the meeting to order at 3:13 p.m. Board Members Philip Amerson, Russell Kitchner and Stephen Walker were also present.

Board Member Barbara McKinney was not present.

#### BLOOMINGTON BOARD OF PUBLIC SAFETY

The Bloomington Board of Public Safety held a Regular Session on **Thursday, October 16, 2025 at 10:30am,** in the McCloskey Room, Room 135, City of Bloomington located at 401 N. Morton Street, Bloomington, Indiana.

#### **CALL TO ORDER**

Board President Timothy Brinson called the meeting to order at 10:30 a.m. Board Members Russell Kitchner and Barbara McKinney were also present.

Board Member Philip Amerson was not present.

Also in attendance were:

- Police: Police Chief Michael Diekhoff, Police Captain Ryan Pedigo;
- Fire: Deputy Fire Chief Max Litwin, Assistant Fire Chief Tania Daffron; and
- Staff: Assistant City Attorney Enedina Kassamanian, City Risk Administrator Jazmyn Forte Plunkett, and Police Department Office Assistant and Outreach Specialist Sarah Shahnavaz.

#### APPROVAL OF CONSENT AGENDA

Board President Timothy Brinson asked if any members of the board wanted to discuss or object to any items on the consent agenda. These items included the 10/10/2025 claims register and the 10/3/2025 payroll register. None of the board members had questions or objections. All items were approved.

#### POLICE DEPARTMENT BUSINESS

Report on Monthly Statistics and Training:

Monthly Statistics and Training were presented by Police Captain Ryan Pedigo

Police Captain Ryan Pedigo stated that there has been a decrease in the number of calls for service compared to the trend in previous months. 2025 calls had been trending at a 15% higher rate compared to 2024, and last month and the first half of October have shown a 12.3% increase in calls compared to this time last year. Ryan Pedigo clarified that calls are still higher compared to what they were in 2024, but the rate at which call volume increases has slowed as we progress through 2025.

Police Captain Ryan Pedigo stated the recent murder that took place in Bloomington will produce an increase in crime totals in that category during next month's statistics report. Ryan Pedigo stated that OWI arrests continue to go up, which can be attributed to the work of one night shift patrol officer who has been working more OWI cases. Board Member Barbara McKinney asked a clarifying question that this increase in OWI arrests is not due to more people drinking and driving, but rather this officer is catching more of them. Ryan Pedigo affirmed this, stating that this officer likes to focus on traffic enforcement and trying to find intoxicated drivers.

Police Captain Ryan Pedigo stated that traffic stops are down compared to this time last year. Ryan Pedigo speculated that this could be due to the increase in call volume; the more calls officers are on, the less time they have for traffic enforcement. Ryan Pedigo clarified that traffic stop frequencies are still quite a bit higher than they were a couple of years ago.

Police Captain Ryan Pedigo stated that weapons incidents continue to trend down. Ryan Pedigo speculated that this could be attributed to the investigative work of the detective division because firearms are routinely seized

and often connected to other incidents involving weapons, reducing the overall number of firearms possessed by violent individuals.

Police Captain Ryan Pedigo stated that adult arrests are down slightly by previous months, but up compared to this time last year. Ryan Pedigo attributes this to continued officer presence in the downtown area. Ryan Pedigo stated that juvenile referrals are the same as they were this time last year. Ryan Pedigo stated that there were no hate crimes in the most recent reporting period, meaning that we have made it three-quarters of the way through the year with no hate crimes reported in Bloomington.

Police Captain Ryan Pedigo reported on September 2025 nuisance calls for service, training hours, community engagement, and police social work.

#### Letters of Appreciation:

Police Captain Ryan Pedigo shared a commendation for Officer Hoppe, confirming with Office Assistant and Outreach Specialist Sarah Shahnavaz that this was a commendation that came in through the phone and was intended for Chief Diekhoff.

Board Member Russell Kitchner asked whether Kirkwood Avenue is a hot spot for police activity, citing that he is relatively new to the community. Police Chief Michael Diekhoff shared that with street closures, the area tends to attract a transient crowd and that they have been causing quite a few problems with other people in that area. Michael Diekhoff elaborated that Bloomington Police have increased their foot patrols and have been writing citations for drinking in public, et cetera. Michael Diekhoff further stated that Kirkwood is not normally a problem area, but recent changes to the community have impacted the transient community such as the closing of encampments.

Board Member Barbara McKinney asked whether this extends further west than College Avenue and Walnut Street. Police Chief Michael Diekhoff stated that it is basically between Indiana Avenue and Walnut Street.

#### General Business

Police Chief Michael Diekhoff reported that the department has continued to stay really busy with major arrests and slow progress being made with a new building for Police Headquarters. Board Member Barbara McKinney asked whether the building on South Rogers Street still looks like it might work, and Michael Diekhoff affirmed.

#### Personnel Issues:

Police Captain Ryan Pedigo shared that staffing for sworn officers is currently at 94 out of the approved 105. Ryan Pedigo referenced the three conditional offers of employment that were approved by the Board of Public Safety at the September 24, 2025 Special Session, and stated that one of the three conditional hires called Ryan Pedigo to inform him that she sustained a knee injury while on duty at her current place of employment and that she has withdrawn from the process at the Bloomington Police Department (BPD) to seek worker's compensation for the injury from her current employer. Ryan Pedigo further stated that this conditional hire might continue in the process for employment at BPD at a later time.

Police Captain Ryan Pedigo stated that several certified officers have reached out to indicate interest in employment at BPD, so another hiring process for certified officers might be held within the next three to four weeks.

#### Purchases: Expenditures/Procurements:

Police Captain Ryan Pedigo and Police Chief Michael Diekhoff agreed that there were no major purchases or expenditures to report to the Board.

#### CIRT/ARV REPORT

Police Captain Ryan Pedigo and Police Chief Michael Diekhoff agreed that there were no CIRT/ARV deployments to report to the Board.

#### FIRE DEPARTMENT BUSINESS

#### Fire Report on Monthly Statistics and Training:

Assistant Fire Chief Tania Daffron reported that fire calls went from 28 in August to 18 in September and that false alarm calls are still the biggest percentage of calls, next to rescue and EMS. Tania Daffron reported that September had 113 false alarm calls and 258 rescue calls. Tania Daffron compared the total number of emergency responses in September of 2020, 358 calls, to the total number of emergency responses in September of 2025, 597 calls, stating that the total number of calls has gone up 41% in a period of 5 years. Tania Daffron stated that if the Bloomington Fire Department (BFD) responds to a call outside of the city, it is on Indiana University's (IU) campus; 17% of September's runs were to IU's campus.

Assistant Fire Chief Tania Daffron shared that Fire Inspection outreach is at 35% of their goal of 2250. Tania Daffron shared that 66 smoke detectors have been installed as part of BFD public outreach, and referenced a yearly goal of 100 installations.

Assistant Fire Chief Tania Daffron stated that October is fire prevention month, so the department will be busy this month with plenty of public engagement. Tania Daffron then stated that BFD would be at Lowe's on Saturday October 18th to work with crews on a building project to build a fire house with a working fire pole. Board Member Barbara McKinney asked what time this event will take place, and Tania Daffron replied that the event is from 10-1 and that attendees can register online.

Assistant Fire Chief Tania Daffron reported on department training, Mobile Integrated Healthcare outreach, and showed pictures from the Child Car Seat Event earlier in the month of September.

#### Letters of Appreciation:

There were no Letters of Appreciation presented.

#### General Business:

Deputy Fire Chief Max Litwin stated that the department is currently interviewing applicants for the administrative assistant position and hope to have the position filled by next month.

#### Personnel Issues

Deputy Fire Chief Max Litwin reported that four staff members are out intermittently on baby bonding, referencing that BFD's workforce is much younger than average and that the department is seeing the impact of that program. Max Litwin further reported that one staff member is off on FMLA and three are currently on light duty, with two expected to return to full duty soon.

#### <u>Purchases: Expenditures/Procurements:</u>

Deputy Fire Chief Max Litwin reported that Station 3 renovations are done and personnel are now operating out of it. Max Litwin further reported that the training tower has received maintenance work fixing corrosion and damage, along with a fresh coat of paint.



This figure represents a 10.1% increase in 2025.








## **CRIME INVOLVING WEAPONS**


- So far in 2025, there have been 253 incidents where weapons were reportedly involved.

## 2024-2025 Adult Arrests




## 2024-2025 Juvenile Referrals




- Mental Health Providers (MHP) assisted a client with getting into a 30-day substance use program.

- OARS attended coordinated entry meetings to advocate for their clients and their housing needs.











Heat map for all BFD emergency responses in October of 2025
